TITLE: Motion Approving Agreements for the Purchase of Fence, Chain Link and Picket - Tropic Fence, Inc., Gomez & Son Fence Corp., and Supreme Roofing & Construction, Inc. - \$4,863,905 - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve agreements, in substantially the form attached, for the purchase of fencing, chain link and picket materials with Tropic Fence, Inc., Gomez & Son Fence Corp., and Supreme Roofing & Construction, Inc. in the initial one year fixed and firm contract term amount of \$4,863,905, which includes an allowance, and authorize the City Manager to approve three (3), one-year renewal options, in the estimated annual amount of \$4,863,905, for a potential total contract amount of \$19,455,620, contingent upon appropriation of funds.

Background

The Parks and Recreation Department maintains various types of fences for numerous City parks and facilities. Repairs and installation of new fencing materials are frequently needed. Specific line items, based upon line-item pricing, will be used as they relate to the required repairs throughout the contract term. Several other departments also have installation and repair needs and their estimated quantities are included in the bid tabulation.

On June 3, 2022, the Procurement Services Division issued Invitation to Bid No. 12690-022 Fence, Chain Link and Picket, Annual Contract. On June 20, 2022, the solicitation ended with a total of three (3) bids submitted. Disadvantaged Business Enterprise (DBE) status is not applicable as the bid prices submitted exceeds \$1,000,000.

The bid submitted by Tropic Fence, Inc., Gomez & Son Fence Corp., and Supreme Roofing & Construction, Inc. met all the bid requirements and all three are responsive and responsible bidders. At time of need, a purchase order will be issued to the low bidder based on such combination that best serve the City's best interest.
