

RESOLUTION NO. 26- (CRA)

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY AMENDING THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF FORT LAUDERDALE AND THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY TO AUTHORIZE FUNDING FOR REDEVELOPMENT PROJECTS AND ACTIVITIES THAT IMPLEMENT THE CENTRAL CITY REDEVELOPMENT PLAN WITHIN THE BOUNDARIES OF THE CENTRAL CITY COMMUNITY REDEVELOPMENT AREA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on August 20, 2024, the Fort Lauderdale Community Redevelopment Agency Board of Commissioners adopted Resolution No. 24-14 (CRA) approving an interlocal agreement between the Fort Lauderdale Community Redevelopment Agency ("CRA") and the City of Fort Lauderdale ("CITY"); and

WHEREAS, on August 20, 2024, the City Commissioners of the City of Fort Lauderdale adopted Resolution No. 24-146 approving an interlocal agreement between the Fort Lauderdale Community Redevelopment Agency ("CRA") and the City of Fort Lauderdale ("CITY"); and

WHEREAS, the effective date of the Interlocal Agreement was August 29, 2024 between the City and CRA; and

WHEREAS, the Interlocal Agreement was amended on July 2, 2026 by Resolution No. 26 -140 and on May 19, 2026 by Resolution No. 26-08 (CRA).

WHEREAS, the CITY and the CRA are interested in maintaining and revitalizing the Central City Community Redevelopment Area (CC-CRA") as visibly attractive, economically viable, and socially desirable areas of the CITY; and

WHEREAS, Florida Statute, Section 163.387(6) permits expenditures of money from the Community Redevelopment Agency trust fund to achieve infrastructure development and community redevelopment plan undertakings; and

WHEREAS, this amendment adds two (2) redevelopment projects to the Interlocal Agreement for CRA funding - the NE 13th Street Roundabout Public Art Sculpture Project and the Land Use Plan Amendment and Implementation Project.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY:

SECTION 1. That the Recitals set forth above are true and correct and incorporated herein by this reference.

SECTION 2. That the Board of Commissioners of the Fort Lauderdale Community Redevelopment Agency hereby approves the Amendment to the Interlocal Agreement between the City and CRA, in substantially the form attached to the Commission Agenda Memorandum No. 26-0692.

SECTION 3. Resolution No. 24-14 (CRA) and any subsequent amendments shall remain in full force and effect, subject to the amendment provided herein.

SECTION 4. That the office of the General Counsel shall review and approve as to form all documents prior to their execution by authorized officials.

SECTION 5. That this Resolution shall be in full force and effect upon final passage.
