THIS SINGLE STORY HOME BUILT IN 1939 HAS BEEN LIFTED FROM ITS FOUNDATION, RAISED ON 4-5' TALL SUPPORT STRUCTURES AND HAS BEEN PREPARED TO BE MOVED. ALL UTILITIES HAVE BEEN DISCONNECTED AND THERE ARE NO TIE DOWNS TO KEEP THE STRUCTURE SAFELY SECURED TO THE GROUND. THE BUILDING HAS BECOME UNSAFE AND PRESENTS A FIRE AND WINDSTORM HAZARD.



It is the ORDER of the Unsafe Structures Board that based upon the foregoing; Respondent(s) shall comply as follows:


WE ORDER THE PROPERTY OWNER TO DEMOLISH THE STRUCTURE WITHIN 30 DAYS AND THAT WE ORDER THE CITY TO DEMOLISH THE STRUCTURE SHOULD THE PROPERTY OWNER FAIL TO. TIMELY DEMOLISH. SUCH DEMOLITION IS TO BE ACCOMPLISHED BY A LICENSED DEMOLITION CONTRACTOR PURSUANT TO A CITY-ISSUED DEMOLITION PERMIT.

If the respondent(s) does (do) not comply by August 16, 2008, the City of Fort Lauderdale will proceed with the demolition of the structure.

If the Respondent(s) does (do) not comply, the Notice of Violation and the Notice of Non-Compliance shall be recorded in the public records of the Office of the Clerk of the Circuit Court in and for Broward County.

RIGHT TO APPEAL: If any person desires to appeal any decision with respect to the matter considered at this Hearing, such person will need a record of the proceedings, and for such purpose, such person may need to ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which the appeal is based.
