

**THIRD RENEWAL OF AGREEMENT

THIS IS A THIRD RENEWAL OF AGREEMENT, made and entered into this 20th day of May, 2014 by and between CITY OF FORT LAUDERDALE, a Florida municipality, ("CITY"), and MILLER, LEGG & ASSOCIATES, INC., a Florida corporation, ("CONSULTANT").

WHEREAS, the CITY and the CONSULTANT entered into an Agreement for Consultant Services, a Continuing Contract for General Environmental Engineering Services, RFQ 616-10632, dated August 23, 2011, which agreement was extended and amended *via* First Extension and Amendment to Agreement dated May 15, 2012, and extended *via* Second Extension to Agreement dated February 19, 2013, (collectively, the "Agreement"); and
