Resolution Approving Final Community Redevelopment Agency Operating Budget and Community Investment Plan Allocations for Fiscal Year 2024 - (Commission Districts 2 and 3)

In response to Commissioner Glassman's questions, regarding the \$1,416,431 in Fiscal Year (FY) 2023 funding for the Central City CRA (CCCRA), Clarence Woods, Northwest-Progresso-Flagler Heights Community Redevelopment Agency (NWPFH CRA) Area Manager, explained ongoing CCCRA rezoning efforts and advertising of Residential Facade and Landscaping Programs, which requires the community to pursue.

Commissioner Glassman noted five (5) weeks remain in FY 2023. Mr. Woods said that unused CRA funding would be returned to the City and is usually reappropriated to the CRA in the next fiscal year.

Commissioner Glassman commented on the need for improved accuracy. Further comment and discussion ensued.
