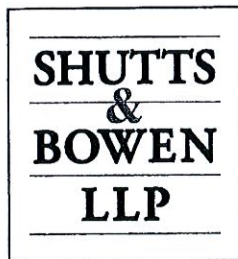

Our firm represents Multimo, LLC ("Applicant") on the above referenced matter which is on the agenda for the April 16, 2013 City Commission meeting. The Applicant is seeking a resolution authorizing approval of two triple-pile mooring clusters at the Property. As you know, certain issues and questions were raised at the City Commission meeting held on March 19, 2013. We are working with the Applicant and the Applicant's consultants to prepare a marine survey and site plan to ensure that the pilings do not create a navigational hazard or infringe upon the riparian rights of the adjacent property owners.

Because the marine survey and site plan are not complete, we request a continuance of the item to the May 21, 2013 meeting of the City Commission.
