

**AMENDMENT AND RESTATEMENT TO THE
SUBRECIPIENT AGREEMENT FOR 2019 EDWARD BYRNE
MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM**

This Amendment and Restatement to the Subrecipient Agreement (“Amendment”), is made and entered into by and between City of Pompano Beach, a municipal corporation organized and existing under the laws of the State of Florida (“City”) and City of Fort Lauderdale, (“Subrecipient”), (collectively referred to as the “Parties”).

RECITAL

A. The Parties entered into a Memorandum of Understanding (MOU) pertaining to the subject grant funding, which had an original term of October 1, 2018 to September 30, 2022 (Grant Period); and

B. In furtherance of the MOU, under the direction of the Federal Department of Justice (DOJ), the funding agency, the parties also entered into a Subrecipient Agreement to implement the objectives and goals of the Federal Edward Byrne Memorial Justice Assistance Grant (JAG), with an expiration date of September 30, 2022, later extended by the DOJ to September 30, 2023; and

C. Prior to the Subrecipient Agreement’s expiration, the Department of Justice (DOJ) extended the Grant Period to terminate on September 30, 2024, however, the MOU and, in some cases, the Subrecipient Agreement were not amended to reflect the extension and have since expired; neither the MOU nor the Subrecipient Agreement were amended to reflect the latest extension and each has since expired; and

D. The Parties have continued to comply with the terms and conditions of the MOU and Subrecipient Agreement, even though expired, and the DOJ, because of its extension to the

Grant Period, continues to review, instruct and direct the Parties in accordance with the terms and conditions of the 2019 Edward Byrne Justice Assistance Grant.

NOW THEREFORE, in consideration of the mutual terms, conditions, promises, and covenants set forth, the Parties agree as follows:

1. Each paragraph in the Recital set forth above is true and correct and incorporated by this reference.

2. Section IV entitled, "Term," is amended to read as follows:

The term of this Agreement and the sub-award period of performance shall begin retroactive to October 1, 2018 and shall end on September 30, ~~2022~~ 2024. The continuation of this Agreement beyond the end of any City fiscal year is subject to the appropriation and availability of necessary funding from the JAG Program.

3. Except as expressly modified by this Amendment, all terms of the Subrecipient Agreement shall remain in full force and effect.

4. This Amendment and Restatement shall bind the parties and their respective successors and assign and shall be fully effective as though the Amendment and Restatement had been originally included in the Subrecipient Agreement.




