TITLE: Motion approving the acceptance of a grant from State Citizen Corps

Grant through State of Florida Division of Emergency Management, FY2012 State Citizen Corps Grant in the amount of \$7,500.00, no match

required.

Recommendation

It is recommended that the City Commission approve a motion authorizing the proper City officials to accept a grant from the State of Florida Division of Emergency Management and to execute any documents required to accept funds between the State of Florida Division of Emergency Management and the City of Fort Lauderdale.

Background

In August 2012, the Fire-Rescue Department applied through the State of Florida Division of Emergency Management, for funding under the FY 12 Citizen Corps Grant Program. This grant program promotes partnership between local emergency service providers and the citizens that they serve, by training citizens in basic emergency preparedness, response and recovery skills and other preparation necessary to function as auxiliary personnel to first responders.

On October 17, 2012, the State of Florida Division of Emergency Management awarded funds to the City in the amount of \$7,500.00. These funds will be used to pay for instructor and training expenses, and to purchase equipment for City of Fort Lauderdale Citizen Corps Citizen on Patrol, Fire and Police Explorer Program participants. The program period for this grant is October 1, 2012- January 31, 2014. There is no matching requirement for this grant program.

Resource Impact

There is a positive fiscal impact to the City in the amount of \$7,500.00.
