A RESOLUTION OF THE CITY COMMISSION OF THE CITY FORT LAUDERDALE, FLORIDA, DENYING THE APPLICATION BY NICHOLAS JOSEPH DILORIO AND SHARON LYNN DILORIO, HUSBAND AND WIFE FOR A WAIVER OF LIMITATIONS FOR AN EXISTING FLOATING VESSEL PLATFORM EXTENDING A MAXIMUM DISTAMCE OF 34.4' +/-, MEASURED FROM THE PROPERTY LINE, INTO THE ADJACENT WATERS OF THE CERRO GORDO RIVER, PURSUANT TO SECTIONS 47-19(e) OF THE CITY OF FORT LAUDERDALE UNIFIED LAND DEVELOPMENT REGULATIONS ("ULDR"), FOR PROPERTIES LOCATED 12TH STREET, HEMINGWAY LANDINGS CONDOMINIUM, UNIT #2C, SLIP #11, FORT LAUDERDALE, **FLORIDA 33316.**

WHEREAS, Section 47-19.3(e) of the City of Fort Lauderdale, Florida Unified Land Development Regulations (hereinafter "ULDR") provides that the City Commission may waive the limitations of Sections 47-19.3(c), or 47-19.3(d) or both, under a demonstration of extraordinary circumstances; and

WHEREAS, Joseph Dilorio and Sharon Lynn Dilorio (hereinafter "Applicant") owns the property located at 1414 SE 12th Street, Hemingway Landings Condominium, Unit #2C, Slip #11, Fort Lauderdale, Florida 33316, (hereinafter "Upland Property"); and

WHEREAS, Applicant submitted an application for a Waiver of Limitations to allow the existing floating vessel platform (FVP) extending a maximum of 36.4' +/-, revised to 34.4' as a result of the City Surveyor establishing the length of the FVP to be 34.4' +/-, measured from the property line into the adjacent waters of the Cerro Gordo River (hereinafter "Application");

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That each WHEREAS clause set forth above is true and correct and incorporated herein by this reference.

<u>SECTION 2</u>. That the City Commission of the City of Fort Lauderdale, Florida, after reviewing the evidence finds that the Application for a Waiver of Limitations for the existing 31.5' x 12' floating vessel platform extending a maximum of 34.4 +/- into the adjacent waters of the Cerro Gordo River fails to meet the criteria set forth in ULDR Section 47-19.3 (e) and is therefore hereby denied.
