## RESOLUTION NO. 20-177

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A MEMORANDUM OF AGREEMENT WITH THE UNITED STATES CUSTOMS AND BORDER PROTECTION FOR EQUIPMENT REQUIRED FOR THE PERFORMANCE OF FEDERAL INSPECTIONS SERVICES AT THE FORT LAUDERDALE EXECUTIVE AIRPORT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the United States Customs and Border Protection ("CBP") was opened at the Fort Lauderdale Executive Airport ("FXE") in 2015; and

WHEREAS, the facility operates daily from 8:00 a.m. to Midnight and is ranked as the second busiest General Aviation CBP clearing facility in the country; and

WHEREAS, FXE wishes to enter into a Memorandum of Agreement with CBP to reimburse CBP for the purchase of equipment required for Federal Inspections Services, and recurring service and maintenance costs associated with the equipment at the Fort Lauderdale Executive Airport; and

WHEREAS, the equipment includes workstations, monitors, network switches, scanners, fingerprint scanners, cameras, printers, and additional equipment for a complete working system; and

WHEREAS, the equipment may require upgrades every three to five years; and

WHEREAS, the equipment is estimated to cost \$127,910.30, plus an annual recurring cost estimated at \$20,315.00; and

WHEREAS, the City Commission finds that approving the Memorandum of Agreement is in the best interest of the City of Fort Lauderdale.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. The Memorandum of Agreement with the United States Customs and Border Protection for equipment required for the performance of Federal Inspections Services at the Fort Lauderdale Executive Airport, is hereby approved and the City Manager is authorized to execute the Memorandum of Agreement on behalf of the City of Fort Lauderdale, Florida.
