

RESOLUTION NO. 14-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR THE LEASE OF VEHICLES FOR COMMUNITY BUS SERVICE, WITH AN EFFECTIVE DATE OF OCTOBER 1, 2014.

WHEREAS, it is recommended that the City Commission of the City of Fort Lauderdale, Florida, authorize the City Manager to execute an Interlocal Agreement (ILA) with Broward County for the lease of a vehicle for Community Bus services, with an effective date retroactive to October 1, 2014; and

WHEREAS, the proposed ILA between the City of Fort Lauderdale and Broward County is for the lease of a vehicle from the Count for use in Community Bus services; and

WHEREAS, a bus will be added to the Neighborhood Link community bus route due to high ridership levels; and

WHEREAS, the additional bus will also help to reduce the headways (the time interval between two buses traveling in the same direction) within the existing timeframe, increasing the convenience for riders; and

WHEREAS, the proposed ILA provides a base term of three years ending on September 30, 2017, with two additional one-year extension options; and

WHEREAS, the vehicle lease will be in the amount of ten dollars (\$10) annually, with operating costs at approximately \$72,000 annually; and

WHEREAS, funding for operating costs is proved by city gas tax, the parking fund, and the NW Community Redevelopment Agency (CRA), Broward County and will appear before the Commission on the Consolidated Budget Amendment at a future meeting; and

WHEREAS, at its August 12, 2014 meeting, the Broward County Board of County Commissioners approved the Community Bus Standard Form Interlocal Agreement for Community Bus Transportation Services; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Manager is hereby authorized to execute, on behalf of the City of Fort Lauderdale, an Interlocal Agreement with Broward County for the Lease of vehicles for Community Bus Services, with an effective date retroactive to October 1, 2014 and all amendments thereto.

SECTION 2. That the office of the City Attorney shall review and approve as to form all documents prior to their execution by the City Manager.
