- TITLE: Motion Approving Agreement for Annual Bridge Repair Services -Engineering Control Systems, Corporation - \$1,204,200 - (Commission District 1, 2, 3 and 4)

# **Recommendation**

Staff recommends the City Commission approve a two-year Agreement, in substantially the form attached, for Annual Bridge Repair Services with Engineer Control System, Corporation (ECS) in the initial fixed and firm two-year term amount of \$1,204,200; and authorize the City Manager to approve two (2), one-year renewal options in the estimated renewal annual amount of \$602,100, for a potential total Agreement amount of \$2,408,400 contingent upon appropriation of funds.

### **Background**

The City of Fort Lauderdale currently owns and maintains 53 bridges as part of its public transportation infrastructure. The annual bridge program facilitates improvements and rehabilitation of the City's bridges to maintain safe conditions in compliance with regulation of the Florida Department of Transportation (FDOT). The annual bridge program addresses all deficiencies identified by the FDOT via bridge inspection reports submitted to all local agencies including the City of Fort Lauderdale.

Over a five (5) year period, the FDOT has submitted individual reports for all 53 bridges owned by the City of Fort Lauderdale indicating the deficiencies of the bridges. Based on these reports, City staff schedule bridge repair works under the annual bridge program. These repair works include pile jacketing, pile cathodic protection, expansion joints removal and replacement, spall concrete repair, corroded rebar reinforcement treatment, replacement of rebar, concrete surface sealing, approach slab repair, repair of the bridge toe-wall for under exposed bridge bulkheads and void filling.

On May 18, 2022, the Procurement Services Division issued Invitation to Bid (ITB) No. 12653-1023 - Annual Bridge Repair Services. The City received one (1) bid in response to the solicitation, which was opened on June 16, 2022, from Engineer Control Systems, Corp. A bid analysis comparison from the prior Agreement in effect since August 21, 2018, reveals that out of the 36 bid line items, 25 bid line items or 69% experienced no

price increases or a price decrease. Therefore, the bid has been determined to be fair and reasonable. Additionally, the bid was reviewed for compliance with the solicitation requirements. Engineer Control Systems, Corp. is a responsive and responsible bidder and recommended for award.

This firm did not list its status as a Disadvantaged Business Enterprise.

#### Resource Impact

There will be a fiscal year impact to the City in the amount of \$1,204,200 for the Agreement award. Funds for this Agreement, in the amount of \$1,204,200, are available in the FY 2023 Community Investment Plan in the account(s) listed below. Future years' expenditures are contingent upon the approval and appropriation of the annual budgets.
