**TITLE:** REVISED M-9 - Motion accepting ~~appropriating~~ the 2012 - 2013 State  
Housing Initiative Partnership (SHIP) Funds - \$64,947

**Recommendation**

It is recommended that the City Commission adopt a motion accepting ~~appropriating~~ the State Housing Initiative Partnership (SHIP) Program funds for the 2012-2013 grant year in the amount of \$64,947.00. These funds were received by the City in January 2013 from Florida Housing Finance Corporation and disbursed from SHIP funds that were previously set-aside for disaster recovery that have been de-obligated or returned as unexpended funds. Upon approval of the items listed above the City Commission also authorizes the City Manager to execute all documents associated with this appropriation.

**Background**

These SHIP funds are to be considered as Fiscal Year 2012-2013 funding and should be expended through strategies approved under the Local Housing Assistance Plan (LHAP) covering that year in accordance to the 2010-2013 LHAP approved by City Commission per Resolution No. 10-96. The City's proposes to use these funds as follows:

- Administration (10% of allocation) - \$ 6,494.70
- Up two (2) Single Family Housing Rehabilitation or Purchase Assistance- \$58,452.30 ( for the 2012-2013 Grant Year)

We anticipate this funding to result in assisting up to two (2) single-family homes with rehabilitation or purchase assistance.

These SHIP funds are now being presented to the City Commission for appropriation.

**Resource Impact**

There is a positive fiscal impact to the City in the amount of \$64,947. Funds are being appropriated through companion item # 13-0384.
