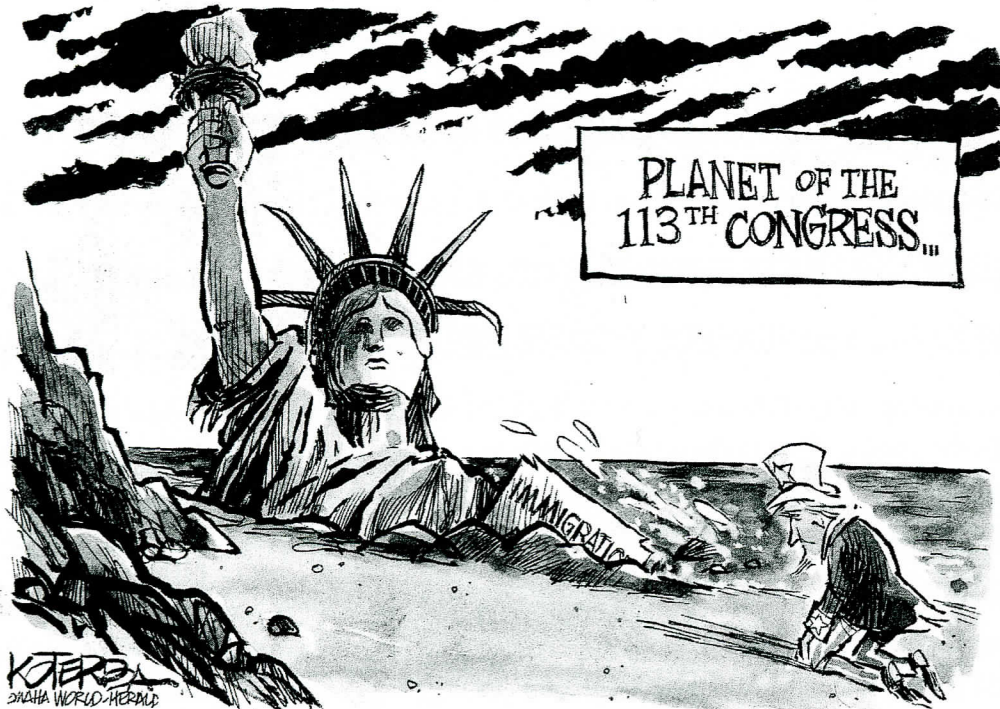

Whites may stay majority longer if immigration slows

WASHINGTON Without increased immigration, whites would lose their U.S. majority in 2046, three years beyond official projections, according to alternative census estimates released Wednesday.

The new numbers show how

projections could vary from last year's government prediction that white children will become a minority in 2018 and the overall white population will follow in 2043, based on what happens to the economy and immigration policy.

Those dates remain the official census projections, and they are based on the assumption that immigration con-

tinues to climb.

The 2046 estimate of a white minority is one of three new alternative projections based on birth rates, death rates and immigration following its recent slower pace of adding more than 700,000 foreigners each year.

The actual shift in demographics will be influenced by factors that can't accurately be

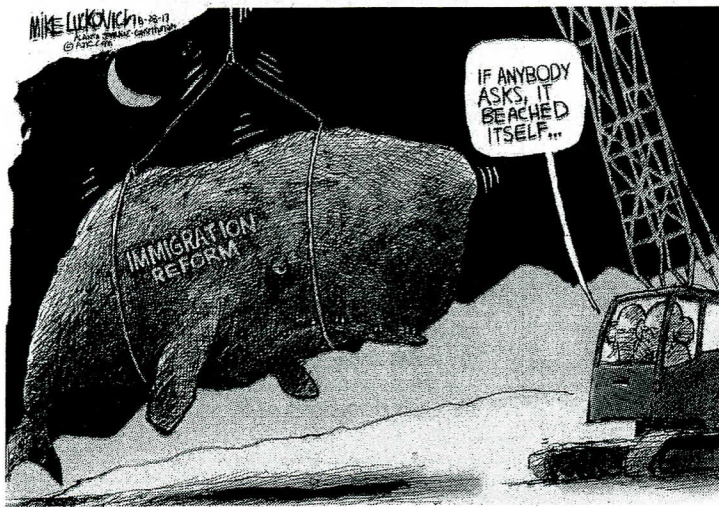
forecast.

Those include the pace of the economic recovery, cultural changes, natural or manmade disasters, as well as any overhaul of immigration laws based on legislation now being debated in Congress.

The United States has 315 million people today; less than 64 percent are non-Hispanic whites.

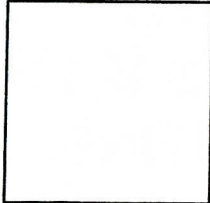

Dominican court turns Haitians into non-citizens

Last month, the Dominican Republic's constitutional court stripped away the citizenship of several generations of Dominican citizens in violation of the country's constitution. This ruling, retroactive to 1929, revoked the citizenship of about 250,000 Dominican-born citizens, under the specious argument that their parents were only "in transit" in the Dominican Republic when they were born.

It bears mentioning that the people now considered transients left neighboring Haiti decades ago to work in the Dominican sugar cane plantations. They contributed to the economic development of the Dominican Republic while living in inhu-

mane conditions in the infamous bateys.

Today, these hard working Haitian migrants' children, grandchildren and great-grandchildren who were born in the Dominican Republic — thus irrevocably acquiring Dominican citizenship — are the ones affected by the court's decision. If we follow the Dominican court's reasoning, all the proud American citizens born to the Cubans who fled the Castro dictatorship from the early 1960s on, once a regime change occurs in Cuba, should be stripped of their U.S. citizenship because their ancestors were only in transit in the U.S. waiting for the Castro brothers' demise.

It is important to understand that the constitutional court is only serving as a pawn of a particular sector of the Dominican elite. Now that the country has largely transitioned from farming to a service economy, particularly tourism, this sector sees no more use for the cheap, industrious workforce whose labor it used to diligently exploit.

It is also important to realize this massive and targeted denationalization is part of a bigger, even more macabre scheme that will lead to a human tragedy. Most of the people affected by this decision only speak Spanish and have never been to any country other than their native Dominican Republic. They have few, if any, known family ties in Haiti.

Now, on top of being indescribably poor due to decades of exploitation, these peo-

mer country, waiting powerless for the next step of the aforementioned elite.

How many of them will be deported to Haiti, where they will compound the challenges of a country that still has not recovered from a devastating earthquake and a tenacious cholera outbreak? How many will be taken under the "benevolent" protection of the same individuals who have masterminded their disenfranchisement to have them work under worse conditions than before with the threat of deportation constantly hanging over their head? How many will be forced to risk their lives — children included — aboard makeshift vessels, trying to reach the Bahamas, Cuba or the United States?

The answer to these questions is the same: so many that the rest of the world should act swiftly to prevent the humanitarian crisis that this ruling will bring about. But what can be done?

First, there must be a political response from the world. The United States and other countries need to make it clear to the Dominican Republic and all other countries that may be tempted to resort to similar ethnic cleansing measures that projects like this are not acceptable. On Nov. 26, the Caribbean Community, after condemning the Dominican court's ruling, deferred a Dominican request to become a member and will be reassessing its relationship with this country in other forums.

Second, Haitian Americans for Progress, a civil society organization in South Florida, is giving everybody the opportunity to make their voices heard on the issue by spearheading a petition on moveon.org. The petition calls on the rest of the world to boycott tourism in the Dominican Republic until this country changes its practices.

On the Dominican Republic board of tourism's website, the country is referred to as "paradise." Once people make it clear that they won't go to paradise until the country gets rid of the hell it is subjecting a quarter million of its citizens to, the problem will be solved swiftly. This is an opportunity to test the power of private citizens around the world who, with the advance of social media, can become more powerful than the mightiest of governments in promoting a better world. Let's not squander it.
