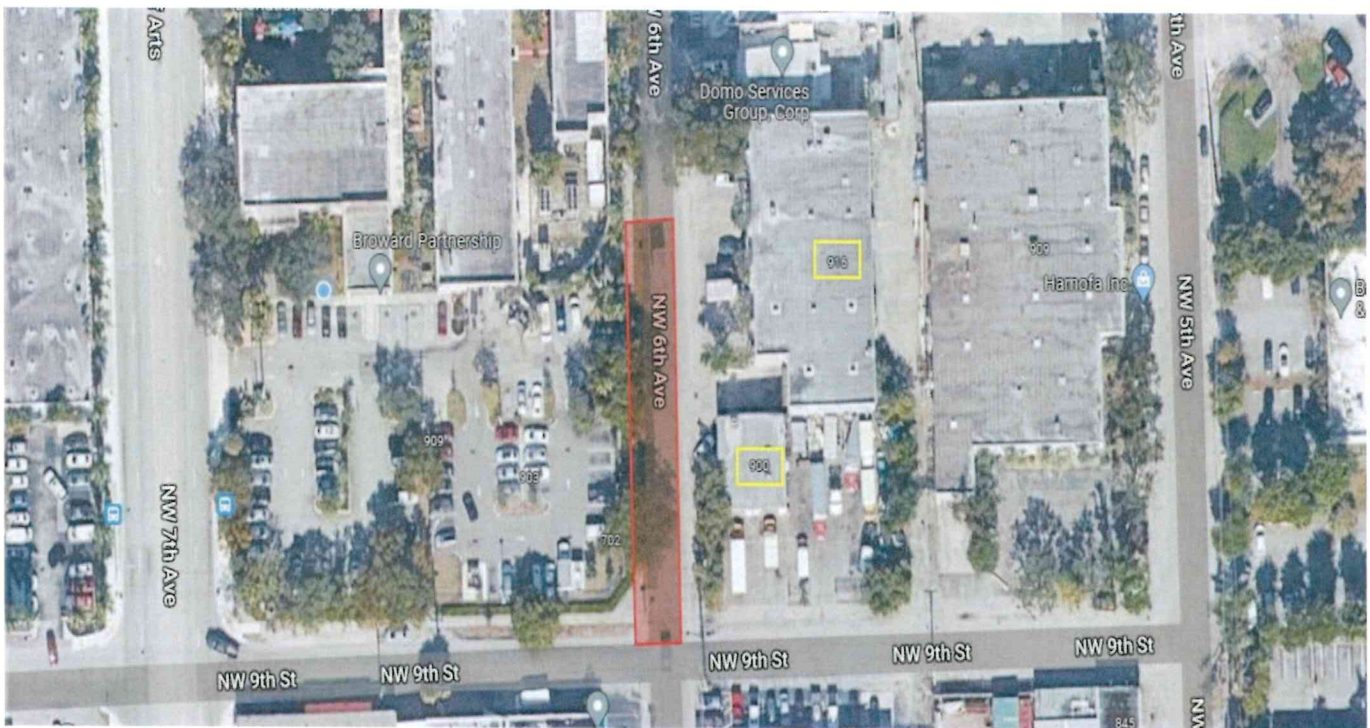

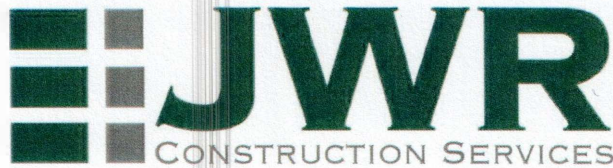
Map of Closure Area
