TITLE: Resolution Approving NE 35th Street to also be known as "Chabad Drive"

between State Road A1A and Galt Ocean Drive - (Commission District 1)

Recommendation

Staff recommends that the City Commission adopt a resolution approving NE 35th Street to also be known as "Chabad Drive" between State Road A1A and Galt Ocean Drive.

Background

During the September 5, 2023 City Commission Conference meeting, the City Commission discussed designating NE 35th Street between State Road A1A and Galt Ocean Drive to also be known as "Chabad Drive" and directed staff to advance this initiative as a City project.

Chabad Lubavitch is a multidimensional organization with a global network of centers, schools, and social services that cater to people of all backgrounds and affiliations, promoting Jewish observance, education, and outreach, as well as humanitarian causes and interfaith dialogue.

Chabad Lubavitch of Fort Lauderdale began operating in 1990, renting a small store front on Galt Ocean Drive. With steady growth in programs and attendance, the Chabad expanded its premises and built a permanent community center. The Chabad offers community programs and services, at no cost to the public, ranging from a Jewish public library, religious services, Hebrew school, adult education, a pre-school, youth programs and family programs, all at no charge to the community.

Broward County Traffic Engineering Division requires that the City Commission adopt a Resolution for street name change. After adoption, the estimated timeline for installation is 8 – 10 weeks.
