TITLE: Motion to Accept FY2014 Justice Assistance Grant – Countywide Program
– Overtime for Fort Lauderdale Airport Response – \$59,982.20

Recommendation

It is recommended that the City Commission approve the acceptance of grant funds in the amount of \$59,982.20 from the FY2014 Justice Assistance Grant (JAG) – Countywide Program on behalf of the City of Fort Lauderdale.

Background

On January 6, 2017, an active shooter incident was reported at the Fort Lauderdale/Hollywood International Airport. This shooting resulted in the death and injury of many and the transfer of thousands of civilians and witnesses from the airport. The large local, regional and state law enforcement response resulted in an unanticipated cost and expense to responding agencies. The Florida Department of Law Enforcement has approved this grant award under the Florida's state FY2014 JAG award from the Department of Justice. The grant award will reimburse the Fort Lauderdale Police Department for overtime costs associated with the response of its personnel to this incident.

Resource Impact

There is a positive fiscal impact to the City in the amount of \$59,982.20. The grant does not require matching funds. Funds are being appropriated through Commission Agenda Memo 17-0703.
