### PROFESSIONAL SERVICES

Describing a specific agreement between the City of Fort Lauderdale (CITY) and DeRose Design Consultants, Inc. (CONSULTANT) in accordance with the terms of the Master Agreement for Structural Engineering Services Continuing Contract dated January 19, 2011, as amended on June 5, 2012 and extended on October 16, 2012.

### GENERAL PROJECT DESCRIPTION

CONSULTANT shall provide engineering services and documentation services associated with the structural inspections of the City Park Garage located at 100 SE 1st Street, Fort Lauderdale, Florida (Exhibit 1).

### GENERAL CATEGORY OF SERVICES

The project will require professional structural engineering services.

### SPECIFIC SCOPE OF BASIC SERVICES

Basic services will be provided under the following one task:

#### Task 1 Structural Inspections and Reporting

This phase shall include review of the existing building drawings and perform onsite visual, non-destructive condition assessment of the building structure. Our office will prepare a report determining (i) Immediate critical structural repair requirements (ii) recommend maintenance checklist for the next 5 years, (iii) recommended capital improvements over the next 20 years.

Deliverable: a structural report as described above shall be signed and sealed by a Professional Engineer licensed in the State of Florida.

*This proposal does not include the design, permitting, or inspection of repairs that may or may not be necessary resulting from these building inspections.*

### ADDITIONAL SERVICES

If authorized in writing by the City as an amendment to this Task Order, the Consultant shall furnish, or obtain from others, Additional Services as indicated in Article 8 of the Master Agreement.

### **PROJECT ASSUMPTIONS**

- a. The CITY will identify the individuals who will be the points of contact for the project.
- b. The CITY will provide "as-built" set of existing architectural and structural drawings.

### **PERFORMANCE SCHEDULE**

Upon receipt of written Notice to Proceed, the CONSULTANT will perform the services described above within six weeks following authorization and contingent on CONSULTANT being provided with any essential information in a timely manner.

All documents prepared by CONSULTANT in the performance of this agreement shall become property of the CITY in accordance with Article 11.1 of the Master Agreement. CONSULTANT retains the intellectual property rights of the documents. The CITY can use the documents at any time in the future for information. The CITY cannot alter, revise and reuse the information contained in these documents for other projects without written permission from CONSULTANT.

### **PROJECT FUNDING**

Performance of this project is at the CITY'S discretion and may be contingent upon receipt by the CITY of funding from Transportation and Mobility, and work shall not begin until funding sources for this project are in place.

### **METHOD OF COMPENSATION**

The services performed will be accomplished using the Not-to-Exceed method of compensation. Reimbursable expenses associated with these services are not included in the fees and will be itemized separately, subject to an established Not-to-Exceed limit. The total hourly rates payable by the CITY for each of CONSULTANT's employee categories, reimbursable expenses and sub-consultant fees are shown on Exhibit "A" attached hereto and made a part hereof.

### **TERMS OF COMPENSATION**

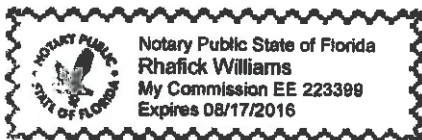
