ORDINANCE NO. C-17-23

AN ORDINANCE AMENDING SECTION 47-1.6.B OF THE CITY OF LAUDERDALE, **FORT** FLORIDA UNIFIED DEVELOPMENT REGULATIONS THROUGH THE REVISION OF THE OFFICIAL ZONING MAP OF CITY OF FORT LAUDERDALE AND SCHEDULE "A" REVISED COMPILATION ATTACHED THERETO AND BY REFERENCE MADE A PART THEREOF, SO AS TO REZONE FROM "RO - RESIDENTIAL OFFICE DISTRICT" TO "B-1 - BOULEVARD BUSINESS DISTRICT", LOTS 4 THROUGH 12, LOTS 15 THROUGH 21 AND A PORTION OF LOTS 13 AND 14, ALL IN BLOCK 64-L, "EAST AVENUE SECTION OF CROISSANT PARK", ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 4, PAGE 28, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, AND THE WEST HALF OF THAT CERTAIN ALLEY IN BLOCK 64-L. "EAST **AVENUE** SECTION OF CROISSANT ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 7, PAGE 57, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, LOCATED WEST OF SOUTH FEDERAL HIGHWAY, NORTH OF SOUTHEAST 17th STREET, EAST OF SOUTHEAST 4th AVENUE AND SOUTH OF SOUTHEAST 16th COURT, ALL LOCATED IN THE CITY OF FORT LAUDERDALE. BROWARD COUNTY, FLORIDA.

WHEREAS, the applicant, HS 17th Street, LLC, applied for the rezoning of certain property as described in Section 1 and Section 2 herein; and

WHEREAS, the Planning and Zoning Board at its meeting of May 17, 2017 (PZ Case No. Z17006) did recommend to the City Commission of the City of Fort Lauderdale ("City Commission") that certain lands herein described should be rezoned in the respects mentioned and that the Official Zoning Map and Schedule "A" attached thereto should be amended to include such lands; and

WHEREAS, the City Clerk notified the public of a public hearing to be held on Tuesday, August 22, 2017 and Wednesday, September 6, 2017 at 6:00 P.M., in the City Commission Room, City Hall, Fort Lauderdale, Florida, for the purpose of hearing any public comment to such rezoning; and

WHEREAS, such public hearing was duly held at the time and place designated

after notice of same was given by publication as required by law, and the City Commission determined that the requested rezoning met the criteria for amending the zoning regulations;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City of Fort Lauderdale Unified Land Development Regulations ("ULDR") together with the Official Zoning Map of the City of Fort Lauderdale and revised Schedule "A", describing the lands lying within each zoning district, as approved on June 18, 1997, and described in Section 47-1.6 of the ULDR, be amended by rezoning in the respects mentioned, the following lands, situate in the City of Fort Lauderdale, Broward County, Florida, to wit:

REZONE FROM "B-1 - BOULEVARD BUSINESS DISTRICT" TO "R-O - RESIDENTIAL OFFICE DISTRICT":

LOTS 4 THROUGH 12, LOTS 15 THROUGH 21 AND A PORTION OF LOTS 13 AND 14, ALL IN BLOCK 64-L, "EAST AVENUE SECTION OF CROISSANT PARK", ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 4, PAGE 28, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, AND THE WEST HALF OF THAT CERTAIN ALLEY IN BLOCK 64-L, "EAST AVENUE SECTION OF CROISSANT PARK", ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 7, PAGE 57, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS AREA 1 AND AREA 2 ON THE SKETCH AND LEGAL DESCRIPTION ATTACHED AS EXHIBIT A.

<u>SECTION 2</u>. That the appropriate City officials of the City of Fort Lauderdale shall indicate such zoning upon a copy of the Official Zoning Map, and shall indicate an amendment of Schedule "A" accordingly, upon the records with proper reference to this ordinance and date of passage.

<u>SECTION 3</u>. That if any clause, section or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

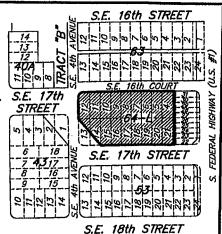
