Commissioner Sturman remarked on several proposals, expounded on related details, and noted that the proposal selected includes the largest amount of tree preservation. Mr. Rogers confirmed and explained this Agenda item allows Staff to move forward with the next phase. Mr. Rogers said there would be additional public outreach and expounded on related details.

Mayor Trantalis recognized Ted Inserra, 912 SW 19th Street, River Oaks Civic Association President. Mr. Inserra discussed his viewpoint regarding this Agenda item and concerns about removal of existing trees along an area of SE 17th Street.

Commissioner Sturman remarked on feedback from Pat Rathburn, Croissant Park Civic Association President. Further comment and discussion ensued. In response to Commissioner Sturman's questions, Mr. Rogers discussed his understanding of concerns discussed by Mr. Inserra and would confirm. Commissioner Sturman requested Staff maintain dialogue with Ms. Rathburn with the goal of preserving as many existing trees as possible.

Mayor Trantalis recommended not approving this Agenda item until resident concerns are addressed and discussed his perspective. Commissioner Sturman noted the overwhelming support from area residents for this plan. Further comment and discussion ensued.

Vice Mayor Glassman noted that this Agenda item is located in District 2 and discussed the goal to revitalize the Himmarshee Entertainment District, which was formerly promoted by an area business association that is no longer in existence.

Mayor Trantalis recognized Yaser Dashouch, Downtown Himmarshee Village Association (DHVA). Mr. Dashouch discussed the purpose of the DHVA, which is to promote the area and expounded on related information.

In response to Vice Mayor Glassman's questions, Mr. Dashouch said Eugenia Ellis, President & Chief Executive Officer at Riverwalk Fort

Lauderdale Inc., assisted in reinstating the DHVA. Mr. Dashouch clarified information he provided in the Special Event application and said that the DHVA is comprised of eight (8) restaurants and bars located in the Himmarshee Street area.

In response to Vice Mayor Glassman's question regarding a current business association in the Himmarshee Street area, Linda Short, Finance Department Director, confirmed that the DHVA is an active business entity registered with the State of Florida and explained related information.

In response to Vice Mayor Glassman's question, Chris Cooper, Development Services Department Director, discussed Staff efforts to revitalize Himmarshee Street and confirmed Staff will work with the DHVA to register them with the City and include them in conversations to revitalize Himmarshee Street. Vice Mayor Glassman discussed the importance of all stakeholders working together and expounded on his perspective.

Vice Mayor Glassman noted a key component of improvements to Warfield Park is a splash pad. He said that the splash pad at Oceanside Park has not operated consistently and inquired about the possibility of a similar experience with the Warfield Park splash pad. In response to Vice Mayor Glassman's questions, Carl Williams, Parks and Recreation Department Director, provided an update on the Oceanside Park splash pad, noting it is currently operational but is not operating at its full potential. It is not under warranty and Staff is working to remedy existing

issues. Vice Mayor Glassman expounded on his concerns. Further comment and discussion ensued.

Vice Mayor Glassman remarked on budget reductions associated with this planned splash pad. In response to Vice Mayor Glassman's questions, Mr. Williams said that the splash pad had been reduced in size, is basic, and is anticipated to work properly.

In response to Commissioner Beasley-Pittman's questions, Mr. Williams confirmed the vendor for the Oceanside Park splash pad indicated salt water intrusion had negatively impacted the splash pad software and expounded on related information. Commissioner Beasley-Pittman remarked on the need to revisit the ability of barrier island amenities to withstand environmental factors.

Vice Mayor Glassman concurred with Commissioner Beasley-Pittman's comments and the need to consider the impact of environmental factors. Mayor Trantalis agreed that environmental factors should be paramount and remarked on the beach wave wall that has experienced damage from salt and sand. Commissioner Beasley-Pittman noted the Warfield Park splash pad will not be exposed to the same type of environment. Further comment and discussion ensued.

Mayor Trantalis remarked on concerns related to this Agenda item. Mr. Williams explained information associated with Warfield Park planned improvements. Vice Mayor Glassman reviewed related costs for Warfield Park improvements and confirmed neighbor support for having a splash pad. Commissioner Beasley-Pittman remarked on her viewpoint in support of providing park amenities benefiting neighbors.

Commissioner Herbst commented on concerns related to receiving only one (1) response to the Request for Proposals (RFP) for this project. In response to Commissioner Herbst's question, Glenn Marcos, Finance Department Assistant Director - Procurement, said that the response period was extended twice. Mr. Marcos explained Staff has pursued outreach efforts to inform vendors about the bid process and opportunities towards increasing vendor interest. Further comment and discussion ensued. Commissioner Herbst noted the impact of high interest rates on developer projects and commented on the reduced risk opportunity provided by a government project such as this.

In response to Mayor Trantalis' question, Mr. Marcos said this contract is not proprietary and noted any special aspects of this project could be subcontracted out.

Mayor Trantalis requested that sound absorbing material be installed in the Warfield Park Gymnasium to address acoustic concerns.

Vice Mayor Glassman made a motion to approve this Agenda item and was seconded by Commissioner Sturman.


