		Commissioner Glassman noted a discrepancy in backup information from Live Nation, indicating the ending time for music would be 11:30 p.m. throughout the three-day Tortuga Music Festival (TMF). Phil Thornburg, Parks and Recreation Director, said the music would end at 10:00 p.m. and confirmed event equipment breakdown would extend until 11:30 p.m.

Commissioner Glassman commented on neighbor inquiries regarding stationing additional personnel at the critical points, i.e., directing traffic out of the Las Olas Garage and other areas in and around the Event.

City Manager Lagerbloom explained reliance on the Police Department and Fire-Rescue Department Staff review to determine traffic recommendations, i.e., personnel or other traffic control devices to move vehicle traffic efficiently.

Commissioner Glassman commented on the *TMF* overlapping with *The Boat Show.* He noted concerns regarding access to the *South Beach Parking Lot* and efforts to mitigate the impact on parking. Mr. Thornburg confirmed parking in the *South Beach Lot* would be limited due to overlapping events. *The Boat Show* and *TMF* are working together and coordinating efforts to ensure a smooth transition. Commissioner Glassman recommended providing related information to the *Central Beach Alliance* and ensuring all stakeholders are communicating.

Commissioner Glassman commented on input received regarding the setup and breakdown of the TMF.

Mayor Trantalis recognized Chris Stacey, on behalf of *TMF*, who confirmed 10:00 p.m. as the end time for music and explained equipment setup and breakdown is done as soon and safely possible, expounding on details. He confirmed *TMF* coordination with INFORMA to coordinate resources and minimize the impact on event transition.

Anyone wishing to speak must be sworn in. Commission will announce any site visits, communications or expert opinions received and make them part of the record.

Each Commission Member disclosed verbal communications, written communications, site visits, and expert opinions received.

Mayor Trantalis opened the public hearing.

Mayor Trantalis recognized Antonio Curatolo, 825 NE 2nd Avenue. Mr. Curatolo, longtime owner of multiple area properties, spoke in opposition to this item, commenting on area rezoning and the negative impact closing NE 8th Street would have on future development of his properties.

Mayor Trantalis recognized John Phillips, Esq., on behalf of Mr. Curatolo. Mr. Phillips confirmed his submission of numerous documents related to

this item and commented on concerns discussed at the Planning and Zoning Board (P&Z Board) Meeting.

Mr. Phillips explained the negative impact vacating NE 8th Street would have on his client's plans for mixed-use development in the Northwest-Progresso Flagler Heights Regional Activity Center (NWPFH RAC).

Mayor Trantalis recognized Dennis Mele, Esq., Greenspoon Marder, on behalf of Holman Automotive (Applicant). Mr. Mele reviewed several slides illustrating distance separations at NE 8th Street when making make left turns. He explained Staff input on related safety concerns at a P&Z Board Meeting and confirmed the Applicant addressed required criteria and would preserve utility, emergency vehicle access and pedestrian easements (Easements).

A copy has been made part of the backup to this Agenda item.

In response to Mayor Trantalis' questions, Mr. Mele explained NE 8th Street had been fenced off since 1987 and not used as a thoroughfare. Current fencing would be removed to allow Easements.

Vice Mayor Moraitis discussed area rezoning allowing different uses. She commented on the ability to remove trees to allow a safe intersection at NE 8th Street should it be reopened. Further comment and discussion ensued.

In response to Mayor Trantalis' question, Mr. Mele confirmed the purpose of this item is to allow the Applicant future development, i.e., building above NE 8th Street, and recognition of NE 8th Street as an easement versus a right-of-way for development purposes, i.e., measuring setbacks.

In response to Commissioner Sorensen's question, Mr. Mele confirmed Staff comments at the P&Z Board Meeting regarding safety concerns related to opening NE 8th Street as a thoroughfare.

Mayor Trantalis recognized Terry McKay, 809 Progresso Drive. Mr. McKay, a longtime local area business property owner, spoke in opposition to this item. He questioned limiting ingress and egress impacting area development and noted the lack of traffic safety incidents on other area streets with forty-five (45) degree angles.

Mayor Trantalis recognized Hernan Gonzalez, 110 North Federal Highway. Mr. Gonzalez spoke in opposition to this item. He discussed efforts to develop a nearby property, previous encroachment benefits received by the Applicant and the financial ability of Applicant to purchase the property. Mr. Gonzalez suggested modifying the direction of NE 8th Street direction to allow its use as a thoroughfare.

Mayor Trantalis recognized Robert Bamonte, Esq., on behalf of the Applicant. Mr. Bamonte submitted letters of support for this item from area neighbors. He explained the vacation of this Street would assist the Applicant with development efforts.

A copy has been made part of the backup to this Agenda item.

Vice Mayor Moraitis commented on her perspective and neighbor concerns previously unknown. She explained unease with assisting one business to the detriment of others and implications of this item on future development. Vice Mayor Moraitis said this is not the best use of a City street. Vice Mayor Moraitis confirmed her review and concurrence with aspects of P&Z Board comments.

Mayor Trantalis noted NE 8th Street had not been used since 1987 and could not be developed on its own. This item would assist the Applicant with plans for development. Further comment and discussion ensued.

There being no one else wishing to speak on this item, Commissioner McKinzie made a motion to close the public hearing, which was seconded by Commissioner Sorensen. Roll call showed: AYES: Vice Mayor Moraitis, Commissioner Glassman, Commissioner McKinzie, Commissioner Sorensen, and Mayor Trantalis.

Commissioner Glassman concurred with Mayor Trantalis' comments. He confirmed support of this item and discussions with area neighborhood associations that had no objection. Commissioner Glassman pointed out details regarding the Applicant's reapplication, including Easements, meeting the five (5) Unified Land Development Requirements (ULDR) criteria for vacationing rights-of-way and conditions included in the backup to this item.

Commissioner Sorensen introduced this Ordinance for the Second Reading which was read by title only.

Vice Mayor Moraitis confirmed support of making it easier for neighbors to receive water leakage credits coinciding with the installation of digital water meters. City Manager Lagerbloom confirmed.

Mayor Trantalis recognized Katherine Fianni. Ms. Fianni commented on efforts to work with Staff regarding a \$14,000 water bill due to an underground water leak. Staff had agreed to a \$7,000 credit. She expounded on extensive efforts to locate the leak and requested forgiveness of the remaining \$7,000 balance. Further comment and discussion ensued.

Vice Mayor Moraitis said she would be following up with Staff on Ms. Fianni's concerns. Comment and discussion ensued on grandfathering in similar situations before the adoption of this Ordinance. City Attorney Boileau said Staff would review, noting related State Statute limitations.

Commissioner Sorensen withdrew his introduction of this Ordinance.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, URGING THE FLORIDA LEGISLATURE TO OPPOSE HOUSE BILL 1475 AND SENATE BILL 2012 OF THE 2021 LEGISLATIVE SESSION BANNING CERTAIN TRANSGENDER STUDENTS FROM PARTICIPATING IN ATHLETICS; AND DIRECTING THE CITY CLERK TO TRANSMIT THIS RESOLUTION TO THE GOVERNOR, THE SENATE PRESIDENT, THE SPEAKER OF THE HOUSE, AND THE MEMBERS OF THE BROWARD STATE LEGISLATIVE DELEGATION.

WHEREAS, the City of Fort Lauderdale prides itself on being welcoming, affirming, and inclusive for all residents, including all members of the LGBTQ+ community; and

WHEREAS, on September 17, 2019, the City Commission of the City of Fort Lauderdale, reflecting our values as an entire community, enacted one of the most, if not the most, comprehensive human rights/anti-discrimination ordinances in the nation; and

WHEREAS, the transgender community is recognized as a valued, important segment of our city entitled to equal treatment in all facets of life; and

WHEREAS, transgender youth are among the most misunderstood and marginalized within our community; and

WHEREAS, House Bill 1475 and Senate Bill 2012 have been introduced during the 2021 Legislative Session would effectively ban certain transgender student athletes from participating in sports; and

WHEREAS, similar legislation excluding or curtailing the rights of the transgender community has been filed in at least 25 states as part of a coordinated campaign that puts the health and wellbeing of transgender youth at risk; and

WHEREAS, participating in sports provides critical life lessons like teamwork, dedication, and leadership that should be available to all youth, including transgender youth; and

WHEREAS, the Florida High School Athletic Association and the National Collegiate Athletic Association (NCAA) have had existing policies in place regarding gender

identity and participation in sports for nearly a decade, and no formal complaints have been identified under those existing policies; and

WHEREAS, a federal judge has already halted implementation of transgender sports ban legislation due to its likely unconstitutionality; and

WHEREAS, adopting state legislation curtailing the rights of the transgender community has previously led to millions of dollars of economic losses, including from NCAA tournament relocations and boycotts; and

WHEREAS, businesses with strong diversity and inclusion commitments, particularly in the sports and hospitality industry, may be forced to locate events outside the state to align with their values; and

WHEREAS, South Florida's NBA team, the Miami Heat, released a statement through Equality Florida on April 5th, 2021, stating, "The Miami Heat champions diversity and inclusion both on and off the court. We believe sports are at their best when they bring people together to work, to play and to create a sense of belonging for all. Every young person deserves the opportunity to participate in athletics and experience the critical life lessons that sports offer such as wellness, dedication, problem-solving, and leadership. Sports should be welcoming for all."; and

WHEREAS, South Florida's NHL team, the Florida Panthers, released a statement on April 17, 2021, stating, "The Florida Panthers are committed to diversity and equality through the NHL's hockey is for everyone initiatives, living these values through education programs and Pride community outreach. We are proud to support Equality Florida's mission.";

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are incorporated herein by this reference.

<u>SECTION 2</u>. The City Commission urges the Florida Legislature to strongly oppose House Bill 1475 and Senate Bill 2012 or similar legislation that would bar certain transgender students from playing sports.

<u>SECTION 3</u>. The City Commission directs the City Clerk to transmit certified copies of this resolution to Governor Ron DeSantis, Senate President Wilton Simpson, Speaker of the House Chris Sprowls, and the members of the Broward State Legislative Delegation.

<u>SECTION 4</u>. The City Commission directs the City's state lobbyists to advocate against House Bill 1475 and Senate Bill 2012.
