Mayor Seiler recognized Charles King, 105 N. Victoria Park Road. Mr. King commented on this item's loan to a low income housing developer and its impact on the future Commission.

Mayor Seiler recognized Jeff Meehan, a long-time Parks and Recreation Division employee, who will be retiring. The Commission thanked Mr. Meehan for his service and dedicated years of work.

Commissioner Trantalis questioned the financing of this item. He noted this requires the 2020 Commission to pledge these funds when the developer requests a state matching grant. In response to Commissioner Trantalis' concerns, City Manager Feldman explained details of repayment to the City. Further Commission discussions

ensued on this topic. Commissioner Trantalis confirmed his position as a proponent of affordable housing. He also commented on the need for clearer details and explanation in the Commission Agenda Memo (CAM). City Manager Feldman discussed possible future sources of funding.

In response to Commissioner Trantalis' request, Robert Lochrie, Esq., on behalf of the Housing Authority, confirmed the Housing Authority's commitment to repaying the loan. City Auditor John Herbst clarified, explaining the scoring process in place by the Florida Housing Authority. This item provides evidence of local government support that must be included in the scoring process to be considered for a matching grant. He confirmed this is one way to support setting aside future funding and is subject to the future Commission's appropriation decision. Further discussions ensued on the acceptability of this language. City Auditor Herbst confirmed it is acceptable language, commenting on the state grant approval process.

In response to Commissioner Trantalis's question regarding the requirement for Fund Balance dollars being used to pay for funding

Collective Bargaining Agreements (CBA) with the Police Unions, City Manager Feldman confirmed. Commissioner Trantalis asked why Operating Funds are not used. City Manager Feldman explained the manner in which collective bargaining is handled. Appropriating funds in advance would inhibit the City's negotiating position. Commissioner Trantalis commented on additional concerns. The City Manager discussed police vacancies and details about managing salary dollars within the budget. Further discussions ensued on this topic.

Mayor Seiler recognized Paul Chettle, 200 S. Birch Road. Mr. Chettle confirmed his support of the Police Department. He also commented on numerous past police budget requests which were not granted.

Mayor Seiler recognized Charles King, 105 N. Victoria Park Road. Mr. King commented on this item's nomenclature. He recommended allowing the City Attorney to review the Police Unions CBAs before funding. Mr. King suggested deferring this to allow the next Commission to address approval of the CBA.

Mayor Seiler recognized Count Rosenthal, 1237 NW 4th Avenue. Mr. Rosenthal commented on funding law enforcement services throughout history. He commented on the process of transferring funds to pay for items and associated budget amendments.

Commissioner Rogers commented on City Auditor Herbst's memo stating that there were no funds available for raises and ways to shift funds to pay for increases. He also commented on the need to decide the reasonableness of CBA negotiations.

Vice Mayor Roberts said this is the traditional way of managing the budget. There is a healthy Fund Balance, more than Ordinance requirements, confirming its annual replenishment.

Vice Mayor Roberts introduced this item which was read by title only.

Mayor Seiler recognized Robert Walsh, 401 E. Las Olas Boulevard. Mr. Walsh commented on the late Sergeant Jack Lokeinsky's work on behalf of members of the Fraternal Order of Police. He recommended increasing the base pay of the Police Department to \$75,000. Mr. Walsh encouraged the Commission to confirm Acting Police Chief Maglione as Police Chief.

Mayor Seiler recognized former Commissioner Charlotte Rodstrom. Commissioner Rodstrom commented on the diversion of Water and Sewer Funds and its impact on infrastructure. She reviewed past actions on pension funding and the issuance of bonds. Commissioner Rodstrom commented on specific aspects of the Collective Bargaining Agreement (CBA) for the City's Police Unions as compared to the Broward Sheriff's Office. She gave a brief analysis of the financial impact.

Mayor Seiler recognized Tim Smith, 1720 NE 9th Avenue. Mr. Smith commented on his support of this item, noting the need to maintain competitive salaries to retain the best talent.

Mayor Seiler recognized Charles King, 105 N. Victoria Park Road. Mr. King commented on the large cost of funding this item and the increase from 2017 to 2018. He recommended allowing the next Commission address this issue.

Mayor Seiler recognized Count Rosenthal, 1237 NW 4th Avenue. Mr. Rosenthal expounded of the first modern U.S. Police Department in Philadelphia in 1751 and the first municipal Police Department in Tallahassee in 1826. He commented on his support of this item, the Police Department and the need for more affordable housing to allow Police Officers to reside in the City. Mr. Rosenthal also commented on the quick response of Police Officers in his Middle River Neighborhood.

Commissioner Trantalis commented on previous Commission Workshops held to analyze first responders' contracts and the need to have more Commission involvement. Commissioner Trantalis asked for clarification about incorporating hiring practice recommendations into the CBA relating to transgender individuals. City Manager Feldman explained this was not included in the CBA due to it being included as a management right. Mayor Seiler confirmed Michael Tucker, President of the Fraternal Order of Police, stated "correct" to this statement by City Manager Feldman. Further discussions ensued on this topic.

In response to Commissioner Trantalis' question about the CBA reimbursement for police take-home cars, City Manager Feldman said these reimbursements are based on where police officers reside. City

Manager Feldman deferred to Mr. Tucker who confirmed these reimbursements.

Commissioner Trantalis discussed former CBA pay increases which were previously tied to the Consumer Price Index (CPI) and the new CBA having a minimum. City Manager Feldman confirmed. Discussions ensued on former minimums.

Commissioner Trantalis discussed implications of the CBA's mandate that salaries be in the 75th percentile of law enforcement agencies in the surrounding County and municipalities. City Manager Feldman explained the analysis that will be used to ensure a competitively paid police agency in order to maintain the desired level of police officers. He confirmed that the 75th percentile only includes pay compensation, not benefits.

Commissioner Trantalis raised the issue of post-retirement pay steps. In response to Commissioner Trantalis' question regarding Cost of Living Adjustments (COLA), City Manager Feldman confirmed it is not a COLA, rather an additional compensation paid to a retiree. He said this was not available under the previous contract.

Discussions continued on the monthly health care contribution paid to the police union. City Manager Feldman said that under this agreement, vacant positions would also be paid, confirming this number is fixed based upon the number of available positions.

In response to Commissioner Trantalis' question about the Police Body-Camera Program (Program), City Manager Feldman confirmed training and deployment of the first vendor had been completed. The second vendor is currently in the training phase. City Manager Feldman clarified his position that the Program is not part of the CBA due to it being a policy issue. He discussed implications of officers refusing to wear a Police Body-Camera.

Mayor Seiler stated that no officers are disciplined or fired for violating the CBA. However, officers can be disciplined or fired for violating management requirements, Florida Statutes, Code and local laws. Further discussions ensued on this topic.

Vice Mayor Roberts stated that there are currently 34 sworn vacancies in the Police Department, commenting on required, additional personnel hired over the last year. He noted that the former CBA expired in 2017. Vice Mayor Roberts discussed the public notice procedures for the CBA negotiations, confirming his agreement on the need for competitive

compensation and retention.

Commissioner Rogers thanked the women and men of the Police and Fire Departments. He acknowledged work done currently and in the past to address compensation issues, commenting on the reasonable aspects of the CBA and the balance of the Fund Balance. He requested City Attorney Cynthia Everett opine on the CBAs.

City Attorney Everett discussed outside counsel's participation in CBA negotiations. She confirmed meetings held with outside counsel to review the CBAs.

Commissioner McKinzie introduced this Resolution which was read by title only.

City Manager Feldman announced the graduation of Major Alvarez from the FBI National Academy (NA), a professional development course for U.S. and international law enforcement leaders held in Quantico, VA.







