Welcome and Introduction of Consul General Rodolfo Rodriguez-Cambronero, Consul General of Costa Rica in Miami

Mayor Seiler welcomed Rodolfo Rodriguez-Cambronero, Consul General of Costa Rica in Miami. Mayor Seiler gave a brief historical overview of the similarities and growth of South Florida and Costa Rica due to the construction of railroads in the late 19th Century. He spoke of the similarities in tourism potential and attributes of both Costa Rica and South Florida as well as Costa Rica's high United Nations ranking in environmental sustainability and its economic attributes.

Consul General Rodolfo Rodriguez-Cambronero thanked Mayor Seiler and the Commission. Mr. Rodriguez-Cambronero discussed Costa Rica's eco-tourism industry, its highly trained innovative workforce and is home to 5% of the world's biodiversity. He expounded on

Costa Rica's economics and business potential, acknowledging Fort Lauderdale as a world-class business center and looking forward to moving forward as a partnership. Mr. Rodriguez-Cambronero also recognized the consolidation of the Sister Cities partnership with Quepos, Costa Rica, a world-class sports fishing destination. He expounded on the additional attributes of Costa Rica and the future of both cities working together to achieve trade and investment opportunities and goals.

The vendor, Shark Entertainment's representative Damian Lleweln, addressed the Commission stating he was not at the Snyder Park event and the noise issues were due to the speakers facing the wrong direction.

Commissioner Trantalis suggested these issues should be addressed by private duty police officers on site, asking City Manager Feldman for an explanation. City Manager Feldman stated it was due to the speakers being placed in the wrong direction. Regular road patrol officers interacted and the music was not turned down to the satisfaction of neighbors. Mayor Seiler raised concerns about the event's content. Mr. Lleweln stated he would address the Commission's concerns with the DJ's. Commissioner McKinzie concurred with the concerns stated and did not want the event at Snyder Park duplicated at Mills Pond Park.

Mr. Lleweln confirmed the music volume and content would be appropriate. Commissioner McKinzie emphasized any deviation from what the Commission has requested would result in the event being over. Mayor Seiler asked Mr. Lleweln to give his cell number to the City Clerk.

Mr. Rajner acknowledged Commissioner Trantalis's efforts as a member of an elected body to address the civil rights of the LGBT community. He discussed requests to the City Manager for changes in City policy to address the protection of those in the LGBT community.

Mr. Rajner passed out two handouts to the Commission related to the County's Human Rights Act, urging the Commission to adopt an Ordinance including protections for gender identity and sexual orientation.

Rena Adams - Outdoor Street Lighting - Environmental Efficiency

Mayor Seiler recognized Rena Adams representing RCC Lighting and Chips and Wafers Energy Solutions, who gave a presentation on outdoor street lighting as it relates to the need for environmental efficiency. Ms. Adams discussed the street lighting problem along A1A affecting Sea Turtle hatchlings and nesting. Dr. Robert Adams, a material scientist, developed an led light with an integrated filter, which will serve to address sea turtle street lighting and the saving of fossil fuels. They have been working with FSWC and Ryan Henderson of the City Manager's Office to have demonstration lighting on the beach and requesting the assistance of the City to work with FDOT to move it forward. In response to Commissioner Trantalis's question, Ms. Adams stated they can replace or retrofit the existing lights along A1A. Ms. Adams expounded on their efforts to date, stating they are in the process of being certified by the State of Florida. City Manager

Feldman explained the progress to date working with the FDOT, District IV, and the City is assisting. FDOT and the Florida Department of Fish and Wildlife have not yet signed off. FSWC and FDOT need to approve the proposed lighting before a demonstration. Further discussion ensued.

Mayor Seiler opened the public hearing.

There being no one wishing to speak on this item, Commissioner Trantalis made a motion to close the public hearing, which was seconded by Vice Mayor Roberts. Roll call showed: AYES: Commissioner Trantalis, Commissioner McKinzie, Commissioner Rogers, Vice Mayor Roberts, and Mayor Seiler. NAYS: None.

Commissioner Trantalis introduced the Resolution that was read by title only.

Anyone wishing to speak must be sworn in. Commission will announce any site visits, communications or expert opinions received and make them part of the record.

Each City Commission member disclosed their verbal and written communications, site visits, and expert opinions received.

Mayor Seiler requested an update from Staff and recognized Anthony Fajardo, Director of Department of Sustainable Development. Mr. Fajardo gave the Commission an update on this issue stating Trisha Logan, Planner III, Department of Sustainable Development, visited the site known as First Evangelical Lutheran Church of Fort Lauderdale (Church) to confirm no changes had been made to the site.

Mayor Seiler recognized Trisha Logan, Planner III, Department of Sustainable Development, confirmed she visited the site this morning and confirmed the only change to the existing condition illustrated in the February 22, 2017 video was the removal on one of the older stained glass window. She could not confirm when or who removed the window. The interior was somewhat ruffled, with the removal of copper wiring and mechanical equipment and some lights were removed from the exterior, most likely due to vandalism though the property was secured.

In response to Mayor Seiler's inquiry, Ms. Logan confirmed prior to the February 22, 2017 video, the stained glass windows had been removed and sold (in November 2016) and remain off site. The frames are in place and the windows have been boarded up.

Commissioner Trantalis discussed the removal of the stained glass windows, stating a permit was issued for their removal. Mr. Fajardo confirmed the original permit stated removal of the windows and boarding up the windows. Due to the fact they were not removing the frames, they did not need a permit to remove the windows. They only needed a permit to board up the windows. There was a notation on the building permit stating "for repair and replacement", stating it was not clarified if they were repairing the stained glass windows or replacing them.

Commissioner Trantalis discussed representations made to the Commission about removal of the stained glass windows and the associated transaction not being an "arm's length" transaction. Mr. Fajardo stated Staff has not done research into this issue. They have only researched the history of the windows during the 1978 and 1981 timelines. Staff has no information regarding recent transactions.

Commissioner Trantalis asked Ms. Logan about designating this building as historic, requesting Ms. Logan to explain its impact. Ms. Logan gave a breakdown of the process, stating it would only cover the exterior of the structure. The interior was not explicitly requested in the application for historic designation. Preservation to the interior of the building would only apply to things attached to the building. The

application for historic designation only speaks to the exterior of the structure. Ms. Logan clarified that though the historic designation was filed prior to the removal of the stained glass windows, current Code does not allow for interim protection measures for properties under consideration for historic designation. The process does exist in other cities and Ms. Logan gave an example of how it would be addressed.

Discussions continued on the Historic Preservation Board requiring the stained glass windows be replaced with stained glass windows identical to the ones removed. Evaluation and determination of this request would have to happen at the time of application with the Historic Preservation Board, i.e., replicating and replacing the structure's original stained glass windows or the stained glass windows recently removed that were installed in the late 1970's and early 1980's. In response to Commissioner McKinzie's question, Ms. Logan further expounded on the decisions to be made by the Historic Preservation Board regarding the appropriate stained glass windows. It was noted that the purpose of the Church is changing from being used for religious purposes to a secular purpose. Comments and discussions continued on aspects of physical changes to structures with historic designations and what aspects the developer or Historic Preservation Board would purpose as appropriate.

Mr. Fajardo clarified current requirements and standards for the Certificate of Application for Historic Preservation. In addition to the structure, it also includes and applies to the lot on which the structure is built. Stipulation of historic designation of only the building must be made by the Commission. Discussions continued on this issue and how this would be achieved. Ms. Logan confirmed this could be done.

Mayor Seiler opened the public hearing, requesting speakers not repeat their testimony made previously before the Commission.

Mayor Seiler recognized Rosalyn Scherf, 1060 Tyler Street, who corrected previous statements noting no current member of the Lutheran Church spoke in favor of historic preservation. Ms. Scherf stated she and her husband have been members for over 27 years. Ms. Scherf gave an overview of their history with the Church as well as their experiences relating to its sale and the stained glass windows.

Mayor Seiler recognized Christopher Brennan, 2721 NE 14th Street, who expressed his opinion of Mr. Knott's recent actions regarding the Church. Mr. Brennan requested the Commission take action against Mr. Knott.

Mayor Seiler recognized Reverend Paul Phadenhauer, 1842 Coral

Ridge Drive, who discussed his interim service and more recent service with the Church. He discussed the recent history of a proposed sale of the Church, subsequent changes to the proposed sale by the new pastor, and the current pending sale. Reverend Phadenhauer stated his support of preserving the Church.

Mayor Seiler recognized Robert Larsen, President of Flagler Village Homeowners Association (Association), who noted the Association voted in favor of preserving of the Church and their support of the developer. Their vision is to see the sanctuary and the facade of the Church preserved. Mr. Larsen commented on the proposed developer's presentation, stating it was highly regarded by the Association and benefits the neighborhood. Discussions continued on the safety of the structure, the Association Board's recommendations regarding aspects of its historic designation and its purchase for the proposed development.

Mayor Seiler recognized Tim Davis, 3212 Colony Club Drive, who spoke in favor of preserving this Church, stating there are organizations who could ensure this building is restored and maintained. Additionally, he questioned why the sellers allowed the building to fall into disrepair, their lack of acknowledgement of its historic nature, behaving suspiciously through the sales process and walking away with a large sum of money.

Mayor Seiler recognized Abby Laughlin, 425 Bayshore Drive, who stated this is not a historic preservation issue, it is a battle between two church governments over control. Ms. Laughlin commented the Commission should not be arbitrating this matter and is spot zoning. She recommended updating language in the Preservation Ordinance to allow for true Historic Preservation, stating this item could illustrate how adaptive rehabilitation could work well. Ms. Laughlin also commented on the inability to legislate perpetuity and the need to address specific matters to improve the process.

Mayor Seiler recognized Steve Glassman, 2821 N. Ocean Boulevard and on behalf of Broward Trust for Historic Preservation. He asked that the Historic Preservation Ordinance is respected. His previous testimony on this issue reflects his position, recommending the historic designation of this Church. Mr. Glassman suggested the site plan process could move parallel to the historic designation process and there is room for compromise and balance. He recommended modifying the Code to protect historic structures once the designation process has begun.

Mayor Seiler recognized Judy Summers, 400 NE 14th Way, thanked

the Commission for hiring Historic Preservation Officer Trisha Logan and for the Commission's hard work.

Mayor Seiler recognized Robin Merrill on behalf of First Lutheran Church. She thanked the Commission, discussing the historic aspects of previous efforts to save the historic post office. Ms. Merrill focused on the criteria for this building, stating the five criterion were met and the original intention of the building, recommending consideration be taken regarding the spiritual needs of the City.

Mayor Seiler recognized Count Rosenthal 1237 NW 4th Avenue, who discussed the adaptive reuse of churches and synagogues due to declines in usage. He encouraged the adaptive reuse of the Church as proposed by the developer along with the stained glass windows.

Mayor Seiler recognized Courtney Crush on behalf of Tahoe Investments, who submitted a site plan picture for preserving this structure. Ms. Crush discussed the history of discussions with the Historic Preservation Board. She reviewed the developer's plans for adaptive reuse of the Church, keeping the structure and repurposing its use and as illustrated in her submission to the Commission. Ms. Crush requested the Commission to allow the developer to continue to move forward, positively commenting on Ms. Logan's ability and input on this matter. She stated her client is willing to commit to keeping the structure and repurposing. She discussed Mr. Avital's efforts to purchase the stained glass windows previously sold. Discussions continued on ownership of the stained glass windows that were removed.

A copy of Ms. Crush's illustration submitted to the Commission is attached to these minutes.

Mayor Seiler recognized Itay Avital, designated representative of Tahoe Investments, who discussed the recent history of the stained glass windows. They are currently stored at the company who manufactured the stained glass windows. Mr. Avital stated he has an agreement to buy back the windows should the site plan move forward.

Mayor Seiler commented on the way the stained glass window issue has been handled.

In response to Vice Mayor Roberts's question, Ms. Crush explained how the Church would repurpose the multipurpose indoor/outdoor space. She also explained the uncertainty involved due to the current Ordinance and future recommendations by the Historic Preservation

Board. Commissioner Rogers commented on aspects of a possible deed restriction versus a designation and the significance of this structure. Commissioner Trantalis commented on the enforcement of deed restrictions as they relate to historic preservation, noting its difficulty. He also discussed the perspectives of the Association and the developer, expressing his concern with maintaining the integrity of the building over time and recommending repurposing. He also encourages community use, such as a possible meeting place. Further discussions ensued from the Commission on the need for consistency, the designation being consistent to follow intent, benefitting both the developer and the City.

Assistant City Attorney D'Wayne Spence stated designation protects the property and explained what the Code requires for a new development Certificate of Appropriateness that affects a historically designated property. Ms. Crush confirmed her client's willingness to do what is necessary as a result of historic designation. Further discussions continued on the issue of input from the Historic Preservation Board and the Commission's designation as to what portion of the structure is historic and should be preserved, i.e., the front, exterior facade, and the main part of the sanctuary, noting the interior cannot be preserved.

Assistant City Attorney D'Wayne Spence further expounded on the requirement of the Certificate of Appropriateness when an action affects a designated landmark site. He stated the record needs to support the Commission's findings and requested testimony supporting the fact that alterations beyond the historically designated facade would not affect the facade, i.e., the area of impact surrounding the facade and a factual basis for the Commission's conclusions. Commissioner Rogers clarified the criteria he referenced in the Code. Further discussions continued on the facade of the annex portion of the Church as it relates to concerns about previous statements made in other situations by the Historic Preservation Board. This portion of a designation would require a condition to address this issue. Assistant City Attorney Spence recommended the developer provide a site plan showing the existing Church, identifying the area the Commission is going to designate, suggesting what distance from that area would affect and would not affect the historically designated property. Ms. Crush confirmed she would be happy to do this, expounding on the current application before the Commission.

Commissioner Trantalis recommended a deferral on this item to allow this to be clearly delineated. Ms. Crush agreed and confirmed.

Mr. Avital confirmed his plans to keep the existing Church structure intact in entirety, noting the word facade is not accurate, stating the interior is one large interior space, with one small office on the left. Secondly, he will illustrate what the plans are for the structure. He commented on his concern about adding lengthy timelines due to delays and missing the market cycle. Ms. Crush confirmed running concurrent approval with the Development Review Committee and the Historic Preservation Board.

Mayor Seiler recognized Brad Schmidt, 700 SE 8th Street, who expressed concern regarding deferring to the developer for historic designation. Commissioner Rogers explained the goals of the Commission. Mr. Schmidt also stated his dismay should it be turned into anything other than a Church.

Mayor Seiler recognized Charles King, 105 N. Victoria Park Road, who stated his viewpoint on the history of the Church and its pastor. He recommended preserving public buildings.

There being no one else wishing to speak on this item, Commissioner Trantalis made a motion to close the public hearing, which was seconded by Commissioner Rogers. Roll call showed: AYES: Commissioner Trantalis, Commissioner McKinzie, Commissioner Rogers, Vice Mayor Roberts, and Mayor Seiler. NAYS: None.

Vice Mayor Roberts and Commissioner Trantalis confirmed the importance of the applicant being involved in the ongoing process with Staff.

Commissioner Trantalis made a motion to defer this item to June 6, 2017 which was seconded by Vice Mayor Roberts.

Mayor Seiler opened the public hearing.

There being no one wishing to speak on this item, Commissioner Trantalis made a motion to close the public hearing, which was seconded by Vice Mayor Roberts. Roll call showed: AYES: Commissioner Trantalis, Commissioner McKinzie, Commissioner Rogers, Vice Mayor Roberts, and Mayor Seiler. NAYS: None.

Commissioner McKinzie introduced the Ordinance on First Reading that was read by title only.

Mayor Seiler asked for an update from Staff regarding the Strike All Amendment (the replacement of language in a Bill, except the title) being debated in Tallahassee about to this Ordinance. City Attorney Everett gave an update on the House Bill, recommending the Commission continue moving forward with this Ordinance. Further comments and opinions ensued.

Mayor Seiler opened the public hearing.

Mayor Seiler recognized Kristen Maus, 1778 SE 25th Avenue, who stated she did not feel an ordinance should be passed simply to get something "on the books", stating language should be carefully considered. Mayor Seiler explained the reasoning involved, similar to what occurred with the vacation rental issue. Ms. Maus stated she would like to defer this item.

Mayor Seiler stated he was just handed the Strike All Amendment, 82 pages in length.

In response to Commissioner Trantalis's question, Ms. Maus stated she did not want this Ordinance to pass tonight due to it allowing too many dispensaries. She gave her reasoning for her opposition, her belief that the goal is total legalization, and it is not regulated enough. Ms. Maus recommended having a very strict ordinance in place on this issue, with the ability to modify it as necessary and expounding on her other recommendations for the ordinance.

Mayor Seiler asked Corey Staniscia, Government Relations with Tripp Scott and representing one of the possible dispensaries, for an update on the pending legislation. Mr. Staniscia confirmed there are currently seven permit holders and the proposed bill will possibly allow three to four additional permit holders.

Mayor Seiler recognized Flor Santesteban on behalf of Modern Health Concepts, one of the seven licensed dispensing organizations, who gave the Commission an update stating the vote for House Bill 1397, the Strike All Bill, was passed 107-9. Ms. Santesteban expounded on aspects of the Bill.

Mayor Seiler recognized John Loges, Detective Fort Lauderdale Police Department. He stated there is an approval process for licensing dispensaries, noting House Bill 1397 was the most restrictive and contains language as to who may have the dispensed product and the length of the doctor-patient relationship of 90 days. Discussions, comments and questions continued on the details and the regulations in House Bill 1397.

Mayor Seiler expressed his concern over the number of possible dispensary storefronts. Detective John Loges recommended the Commission pass the ordinance to allow for restrictions not in House Bill 1397. In response to Commissioner Trantalis's question, Detective Loges stated the cost could be market driven. Discussions ensued on the demands of the market and pricing. Ms. Santesteban confirmed there were approximately 15,000 registered in the State's Compassionate Use Registry, of which approximately 3,000 are actively ordering today.

In response to Vice Mayor Roberts's question, Detective Loges confirmed the drug monitoring program was recommended to be checked by doctors prior to issuing a prescription.

Commissioner Trantalis recommended passing a reasonable ordinance that makes sense for the patient while not allowing for proliferation. Further discussions on this topic ensued and included the need for a balance to address patient needs and market pricing,

the distance from safe zones such as schools, and the appropriate number of dispensaries.

Mayor Seiler asked Assistant City Attorney D'Wayne Spence to review a section of House Bill 1397 entitled "Preemption". Assistant City Attorney D'Wayne Spence noted this section of House Bill 1397 prohibits municipalities from enacting ordinances permitting or determining the location of dispensaries facilities that are more restrictive than locations of pharmacies licensed under Chapter 465. He also noted a distance requirement of 500 feet from public and private elementary schools and secondary schools. City Attorney Spence further expounding on the recommended zoning restrictions and proposed actions in other states.

The grandfathering in of a local municipal ordinance was confirmed as it relates to House Bill 1397 and further comments and discussions ensued. Anthony Fajardo, Director of Sustainable Development, explained the distance of 1,000 feet from elementary and secondary schools was determined due because the distance of 1,500 feet would limit the locations where dispensaries could be placed. Further discussions continued on the location of dispensaries and language in House Bill 1397.

In response to Commissioner Trantalis's question about aspects of the Pharmacy Code's impact, i.e., distance and quantity, Ms. Santesteban commented on the parking provision for dispensaries and asked for the parking aspect to be treated as a pharmacy code with 250 square feet per space rather than 150 square feet per space. Discussions continued on the need to regulate parking. Ms. Santesteban stated there is no doctor at a dispensary, only qualified patients are allowed inside a dispensary. They are only coming to pick up their medicine.

City Manager Feldman noted the short timeline remaining in the current legislative session. Adjustments can be made at the Second Reading of this Ordinance based on what the State Legislature adopts, recommending the Commission, collectively, adopt its desired Ordinance. City Attorney Everett stated this Ordinance focuses on zoning.

There was a consensus on a 1,500 foot distance from elementary and secondary schools.

Vice Mayor Roberts commented on his concerns about security issues regarding the use and regulation of pharmacy parking lots. Detective Loges stated he has been working with the Department of Sustainable Development to look at security measures and the licensing of security

guards. Vice Mayor Roberts requested Detective Loges recommend any additional security issues for the Ordinance between First and Second Reading. Mayor Seiler confirmed the Ordinance will not allow drive-thru dispensaries and discussed issues relating to allowing dispensaries in zoning areas B-1, B-2, and B-3. Discussions continued on surrounding municipalities providing this service and the requirement of dispensaries being licensed by the State in the Staff application paperwork.

Mayor Seiler recognized Flor Santesteban on behalf of Modern Health Concepts, one of the seven licensed dispensing organizations. She discussed the high level of regulation by the State, stating the specific conditions a patient must meet to receive this medicine, and reviewing the requirements for prescribing physicians. Additionally, only qualified patients will be allowed to enter the dispensary.

Mayor Seiler commented on the need to regulate and provide safe access. In response to Vice Mayor Seiler, Ms. Santesteban reviewed the process for qualified patients receiving prescribed medication and the control mechanism that will be in place, i.e., a central registry database.

Mayor Seiler asked Corey Staniscia, Government Relations Representative with Tripp Scott and representing one of the possible dispensaries. Mr. Staniscia suggested ranking dispensaries and discussions ensued on this and the ability of municipalities to implement regulations.

Mayor Seiler recognized Rodney Sanchez, Director of Security - Modern Health Concepts, who discussed the security measures their company will put in place at their dispensaries, stating they will be exceeding State requirements. Mr. Sanchez discussed the monetary security measure that will also be put in place, using a computer application and debit cards to reduce security concerns with cash transactions. Discussions on the home delivery of medication as noted in the State Statute ensued.

Mayor Seiler recognized Dennis Ulmer, 1007 NW 11th Place, who discussed the issues of 1,500 feet from schools, home delivery of medication, and the marketing of the marijuana card. Mr. Ulmer encouraged protecting the neighborhoods.

Mayor Seiler recognized Charles King, 105 N. Victoria Park Road, who commented that on a Federal level, marijuana is illegal. He recommended following the City of Hollywood's example of only allowing two dispensaries and increasing the distances from schools.

Mr. King voiced his concern of this mirroring the previous pill-mill situation, recommending following federal law.

There being no one else wishing to speak on this item, Commissioner Trantalis made a motion to close the public hearing, which was seconded by Vice Mayor Roberts. Roll call showed: AYES: Commissioner Trantalis, Commissioner McKinzie, Commissioner Rogers, Vice Mayor Roberts, and Mayor Seiler. NAYS: None.

Mayor Seiler requested City Attorney Everett and Assistant City Attorney Spence give the Commission a detailed update and summary of the State House and Senate legislation prior to the Second Reading of this Ordinance in order to allow for any necessary amendments.

Commissioner Trantalis introduced the Ordinance on First Reading as amended that was read by title only.
