Commissioner Glassman commented on District 2 Pre-Agenda Meeting discussions of this item and his support of new *Community Shuttle Routes* and service changes. He discussed shuttle expansion and the need to delve deep into the community with outreach efforts to inform residents, citing examples.

Vice Mayor Moraitis concurred with Commissioner Glassman's comments.

In response to Vice Mayor Moraitis' questions, Ben Rogers, Transportation and Mobility (TAM) Department Director, explained the six (6) to twelve (12) month timeline and process for implementation of updates and changes to *Community Shuttle Routes* that are dependent upon *Broward County Transit* negotiations and funding. He commented on the probability of funding.

In response to Mayor Trantalis' question, Mr. Rogers said the trolley had been retired and there are new cutaway buses being leased from Broward County at a cost of \$10.00 per year. Further comment and discussion ensued on the design of the new cutaway buses.

City Manager Lagerbloom provided a brief summary of this item, noting it addresses a rent deferment request from a restaurant tenant located in a City owned property at *Riverwalk Center*.

Commissioner Glassman introduced this Resolution which was read by title only.

Resolution Adopting the Sailboat Bend Historic District Architectural Resource Survey Update Report; and Assigning a "Contributing" or "Non-Contributing" Status to all Properties within the Sailboat Bend Historic District - Historic Preservation Board Case No. UDP-HPD20001 - (Commission District 2)

Commissioner Glassman provided a brief overview of this item, stating that as a *Certified Local Government*, the City should update *Historic Architectural Resource Surveys (Historical Surveys)* identifying *Contributing* or *Non-Contributing* structures every decade. *Historical Surveys* allow the City to move forward with incentives. He acknowledged and thanked Staff for its outstanding work.

Mayor Trantalis recognized Stephanie Wedgeworth, 915 Middle Street. Ms. Wedgeworth spoke in opposition to this item due to the financial impact on homeowners. She expounded on related concerns and requested that this item be delayed.

In response to Commissioner Sorensen's question, Ms. Wedgeworth requested delaying this item to allow Sailboat Bend residents to understand details regarding Contributing or Non-Contributing structures. She commented about having a third-party consultant.

In response to Mayor Trantalis' questions, Trisha Logan, Department of Sustainable Development Historic Preservation Planner, explained details regarding the *Historical Survey* process and efforts that began in 2018. Ms. Logan expounded on additional *Historical Survey* details.

Commissioner Glassman said that a *Frequently Asked Questions Flyer* addressing questions and Staff expertise was made available to *Sailboat Bend* residents.

Mayor Trantalis recognized Sharon Wilkin, 301 Kennelworth Place. Ms. Wilkin spoke in opposition to this item, citing previous objections, her prior involvement and history of similar efforts. Ms. Wilkin said this item is too onerous.

Mayor Trantalis and Commissioner Glassman commented on concerns raised by speakers and explained pertinent details. Commissioner Glassman noted changes to the Ordinance during the current Commission terms have made it less onerous and restrictive. This item delineates *Contributing* or *Non-Contributing* historical structures and the Architectural Resource Survey Update.

Mayor Trantalis recognized John Cotter, 432 Charley Avenue. Mr. Cotter spoke in support of this item. He thanked Commissioner Glassman and Staff for preserving history and commented on his related experience.

Mayor Trantalis recognized Sum Lin, 705 Bryan Place. Mr. Lin commented on his opposition and arbitrary method towards establishing a period of historical significance, citing a 2005 City Attorney communication identifying the original designation and historic protection of structures prior to 1940 - *Pre-War Construction (Pre-War Construction)*.

Mayor Trantalis recognized Don Wikin, 2937 West Cypress Creek Road.

Mr. Wikin commented on his perspective and opposition to this item. He recommended an in-person community charrette to understand all aspects and concerns related to this subject.

Mayor Trantalis recognized JR Steele, 817 Coontie Court. Ms. Steele commented on her opposition to this item and requested residents be part of the process. She explained that it burdens homeowners and inhibits decisions regarding property improvements.

In response to Commissioner Sorensen and Commissioner Glassman's questions, Ms. Logan explained that Staff held three (3) community charrettes. The *Sailboat Bend Civic Association Board of Directors* selected members of The *Working Group* addressing this topic. She explained details related to notifications to the *Sailboat Bend* community and the *Historic Preservation Board (HPB)* vote was 6-1 in favor of this item.

Ms. Logan explained updates to the process including Staff approvals, appearances before the *HPB*, incentives and fee reductions. Staff is reviewing additional incentives, a grant opportunity and updates to the related Ordinance. Further comment and discussion ensued on Commission efforts to reduce restrictions.

In response to Commissioner Glassman's request, Ms. Logan expounded on her Historical Preservation expertise, academic qualifications and professional experience. She confirmed added incentives, potential grant availability and the elimination of fees. Further comment and discussion ensued on the position of the *Sailboat Bend Civic Association* and details related to the purchase of a *Contributing* structure-property in a Historic District.

Mayor Trantalis recognized Patrick Dirindin, 1332 SW 4th Court. Mr. Dirindin spoke in support of this item, commenting on his perspective and the efforts of Ms. Logan.

Mayor Trantalis recognized Joaquin Manchego, 419 Fort Terrace. Mr. Manchego acknowledged and thanked Ms. Logan for her work. He spoke in opposition to this item and commented on restrictions placed on updates to the front portion of his home.

Mayor Trantalis recognized Cliff Dees, 801 Bryan Place. Mr. Dees commented on concerns related to his *Contributing* property and the types of renovations allowed. He spoke in opposition to this item and commented on previous development plans for adjacent lots.

Mayor Trantalis recognized Christian Garay, 1515 Arpeika Street, and President of the *Sailboat Bend Civic Association*. Mr. Garay noted this topic addresses *Contributing* or *Non-Contributing* structures, not historic designation. He commented on area zoning for new construction in Sailboat Bend and the duration and types of meetings with the community. Mr. Garay remarked that *Contributing* structures include *Pre-War Construction* structures.

In response to Mayor Trantalis' questions, Ms. Logan explained that *Pre-War Construction* properties are the most significant. Properties built in the 1940s and 1950s with characteristics of *Pre-War Construction* properties are also considered important to the neighborhood. The *Survey* is the first for *Contributing* or *Non-Contributing* structures presented to the Commission for adoption.

Mr. Garay acknowledged the City's importance as a *Certified Local Government*. He commented that obtaining related grant funding should not be tied to identifying *Contributing* or *Non-Contributing* structures in Sailboat Bend.

Mayor Trantalis recognized Megan A. Forzano, 836 SW 4th Court. Ms. Forzano discussed her opposition to this item and its negative impact on the neighborhood. She commented on her renovated home built in 1954, which the *Survey* incorrectly listed as built in 1941 and designated as a *Contributing* structure.

Mayor Trantalis recognized Ruchel Louis Coetzee, 425 Bayshore Drive. Ms. Coetzee commented on her support of this item and the importance of maintaining historic structures. She expounded on her perspective regarding the position of *Sailboat Bend Civic Association*. In response to Commissioner Glassman's question, Ms. Coetzee explained that real estate values have increased in *Sailboat Bend* as much as in *Victoria Park*.

Mayor Trantalis recognized Richard Bray, 416 Palm Avenue. Mr. Bray requested postponement of this item until the Ordinance updates can be adequately reviewed by impacted residents. He commented on historic detail inaccuracies related to his property, noting he is awaiting related information.

Mayor Trantalis recognized Maggie Hunt, 1307 SW 4th Court. Ms. Hunt thanked Staff for their work and noted her support of this item. She requested an explanation and clarification regarding the rolling

architectural period. The 1992 Study included a caveat addressing structures built in the 1940s and 1950s with a *Pre-War Construction* appearance that would be considered significant and other items.

Mayor Trantalis recognized Bob Swindell, 432 Charley Avenue. Mr. Swindell spoke in support of this item and the importance of maintaining the character of the *Sailboat Bend* neighborhood. He commented on his positive experience regarding inquiries, explanations and follow-up related to this item.

Mayor Trantalis recognized Karen Dirindin, 1332 SW 4th Court. Ms. Dirindin spoke in support of this item and the importance of *Contributing* properties and the positive impact on home values in a Historic District.

Mayor Trantalis commented on the long duration of discussions and alternate perspectives on this subject. He noted Scott Wyman's 2011 *Sun-Sentinel* newspaper article regarding the Sailboat Bend community's eagerness to establish historical guidelines regarding *Contributing* or *Non-Contributing* properties and an Ordinance defining those standards.

Mayor Trantalis expounded on his perspective and hopefulness that Staff would be flexible in terms of design guidelines and new building materials and other opportunities to responsibly advance the community.

Commissioner Glassman spoke to concerns raised and noted efforts to make the process less onerous. He expounded on his perspective regarding moving forward with this item and improving the related Ordinance.

Commissioner Glassman said there would be future community charrettes and confirmed he would continue to work with residents on both sides of this issue. This Resolution adopts the *Sailboat Bend Historic District Architectural Resource Survey Update Report* that assigns *Contributing* or *Non-Contributing* structure status to all properties within the *Sailboat Bend Historic District*. Further comment and discussion ensued.

Vice Mayor Moraitis commented on her perspective in support of this item.

Commissioner Sorensen commented on his perspective and recommended taking time for additional stakeholder, in-person discussions due to the challenges COVID presented for in-person

meetings to communicate, inform and address questions from residents about this topic to build on Staff efforts.

City Attorney Boileau clarified several points. This item does not designate any properties as historical. There is no difference in requirements or restrictions in the *Unified Land Development Regulations (ULDR)* for *Contributing* or *Non-Contributing* structures. Mayor Trantalis commented on the narrow scope of the Ordinance and incentives available to *Contributing* properties.

There being no one else wishing to speak on this item, Commissioner Glassman made a motion to close the public hearing which was seconded by Commissioner McKinzie. Roll call showed: AYES: Commissioner Glassman, Commissioner McKinzie, Commissioner Sorensen, Vice Mayor Moraitis and Mayor Trantalis

In response to Commissioner McKinzie's questions, Ms. Logan explained that this Resolution does not add any additional restrictions to properties.

Mr. Fajardo explained additional details regarding Ms. Logan's analysis and recommendations based upon the U.S. Secretary of Interior's Standards, Code and other information. The *Historic Preservation Board* process includes an appeals process. This item identified properties that contribute to the historic nature of the *Sailboat Bend Historic District*. It offers clear guidance to property owners, those making decisions related to preserving historical character and the opportunity to seek incentives. Further comment and discussion ensued.

Commissioner Glassman introduced this Resolution which was read by title only.


CITY MANAGER ANNOUNCEMENT
