Chair Trantalis recognized Linda Logan-Short, Deputy Director of the Finance Department. Ms. Logan-Short confirmed the recently implemented passive investment strategy for the OPEB Fund, noting related details. She introduced the new investment consultant Khalid Yasin, CIMA, CHP, Director, PFM Asset Management, LLC. Mr. Yasin discussed investment options moving forward, commenting on the current diversification. At the next OPEB Board Meeting, additional recommendations will be presented regarding maintaining a balanced portfolio, expounding on details.
