City Attorney Boileau said he briefly reviewed the recently received *Nurmi Isles* proposed agreement changes to which he could not agree. The City does not typically negotiate on these types of agreements, and all three (3) agreements should be consistent. Further comment and discussion ensued.

Commissioner Glassman explained his perspective and the need to be consistent with all neighborhoods. He recommended deferring these three (3) Agenda items.

Mayor Trantalis recognized Janet Gualtieri, 106 Nurmi Drive. Ms. Gualtieri explained the position of *Nurmi Isles Homeowner's Association (Association)* related to the agreement and its goal to make the City safer. The *Association's* requested changes include maintenance and repairs of the licensed area located in a City right-of-way and warranties related to privacy for information inaccessible to the *Association*. She commented on additional agreement language.

City Attorney commented on his perspective, updates to the standard revocable license and efforts to accommodate the *Association*. Further comment and discussion ensued.

Commissioner Glassman reiterated his concern regarding not maintaining consistency. Further comment and discussion ensued on deferring this item and agreement terms.

Mayor Trantalis recognized Jerry Bailey, 105 Nurmi Drive. Mr. Bailey commented on background details related to the evolution of this agreement and the spirit of the *Association's* position. He explained *Association* expenses to date and additional *Association* costs involved with the revocable license negotiated with the City. Further comment and discussion ensued.

In response to Commissioner McKinzie's question, City Attorney Boileau explained the proposed arrangement does not exist in other neighborhoods. Commissioner McKinzie commented on his perspective opposing neighborhood license readers. Further comment and discussion ensued. Mayor Trantalis explained the option to institute this as a City program, i.e., accepting the neighborhood cameras as a gift to the City. City Attorney Boileau noted the need for criteria, i.e., related crime statistics, City responsibilities and the need for placement in every neighborhood. Further comment and discussion ensued on camera costs, the need for consistency and equal treatment of every neighborhood.

In response to Commissioner Glassman's question, City Attorney Boileau explained input from the *Association* on this matter was received at 11:30 a.m. this morning.

Commissioner Glassman made a motion to defer this item to October 5, 2021 and was seconded by Commissioner Sorensen.

In response to Commissioner McKinzie's question, City Attorney Boileau confirmed a City subsidy towards electricity for the license plate readers, expounding on details. Ms. Gualtieri explained this did not apply to *Nurmi Isles*.

Commissioner McKinzie expressed his position that the City should not pay anything towards this program unless offered to all neighborhoods. Further comment and discussion ensued.

City Manager Lagerbloom explained the City is contributing \$1,200 towards electrical power costs associated with the independent meter. Excluding this from the template is an easy fix.

City Attorney Boileau explained details of the revocable license. All

future programs in neighborhoods would need to receive this subsidy too.

Vice Mayor Moraitis expounded on her perspective and support of this item.

Commissioner McKinzie reiterated his position.

Commissioner Glassman explained he would vote against M-6 and M-7 and expounded on his perspective that all revocable license agreements need to be consistent. He recommended deferring all three (3) items and expounded on his position.

Vice Mayor Moraitis concurred and recommended deferring all M-5, M-6 and M-7.

Commissioner Sorensen explained his understanding of City Attorney Boileau's legal viewpoint in his advisory role to the Commission. Further comment and discussion ensued on deferment and related timelines.

In response to Mayor Trantalis' question, Commissioner Sorensen noted the expectations of the *Rio Vista Civic Association* and his opposition to deferring this item until October 5, 2021. Mayor Trantalis commented on the amount of time Staff needs to meet with each association.

> In response to Mayor Trantalis' questions, Anthony Fajardo, Department of Sustainable Development Director, explained Ordinance 47-20 Parking and Loading Subsection details addressing parking reductions that have several criteria for parking waiver reductions from one parking space per unit. The Code recognizes out of the norm, differing types of uses and varying contexts which allow a parking reduction. Mr. Fajardo expounded on details and cited examples.

Mayor Trantalis commented on concerns regarding developers circumventing parking requirements resulting in the lack of adequate parking.

Mr. Fajardo explained the only area Staff could administratively address parking reductions is within *Community Redevelopment Agency (CRA)* Boundaries. Planning and Zoning address parking reductions in other areas. Mayor Trantalis discussed development in *CRA* areas without adequate parking, citing examples and related consequences.

Mayor Trantalis recommended eliminating this waiver prior to the Second Reading of this Ordinance. Further comment and discussion ensued.

Recommendation

Staff recommends the City Commission consider approving a motion authorizing the execution of a Revocable License with Rio Vista Civic Association, Inc. for the installation and perpetual maintenance of two privately owned License Plate Reader (LPR) cameras in the SE 7th Street and SE 9th Street rights-of-way.

Background

The applicant, Rio Vista Civic Association, Inc. is requesting approval to install two (2) license plate reader cameras within the City's public rights-of-way. Such request requires the execution of a Revocable License. The location map is attached as Exhibit 1 and the construction details are attached as Exhibit 2. The Rio Vista Civic Association will be responsible for all costs associated with the installation, as well as ongoing maintenance. If the cameras have to be relocated, the city will pay for the relocation cost, the City also agrees to pay up to \$1,200 per year towards any cost associated with the electrical consumption.

This Revocable License does not authorize construction in the right-of-way without first obtaining engineering and any associated building permits. Such installations shall follow all applicable engineering standards, which includes criteria governing roadside safety setbacks, sight triangles, conflicts with utilities and/or topographical features, electrical service, and location of property lines. A copy of the Revocable License is attached as Exhibit 3.

Typical Revocable License Agreements cover items such as engineering standards for installation of improvements as well as insurance and associated costs. The proposed Revocable License has been reformatted to address this unique situation where the homeowner's civic association is installing cameras within the right-of-way, which amount to improvements that are a-typical from other applications. The following is a summary

of the changes meant to address these types of applications. These can be found in Exhibit 3 under each section heading listed:

Section 3 – Revocable License (Page 3)

- This section includes language that address confidentiality of the data obtained from the cameras with clarification that this agreement doesn't permit the licensee to access the City's data, information or files collected or received by its police department or other safety and security personnel.
- The City makes no promises, assurances, or representations that the use of the cameras will either prevent crime activity or solve any known crimes or effect the City's response times to criminal activity in the area.
- The use of the camera system shall not create any additional duty for the City to respond or investigate any information provided by the camera system.
- The City shall not incur any liability to the licensee or liability for any damage to person or property that may result from any intestinal acts of other, which includes but is not limited to criminal activity.

Section 4 – Term

 Upon determination by the City Commission that this License shall be terminated revoked, the Licensee shall remove all Project Improvements and restore the Licensed Area to the condition existing prior to installation of the Project Improvements.

Section 5 – Conditions

Sub-sections 5.6, 5.7, 5.8, 5.9, 5.10, 5.16, 5.19, 5.20, 5.21, 5.22, 5.23, 5.25, 5.26, 5.28, 5.29 have been intentionally omitted. These sections relate to typical engineering standards for signage, street markings, warning lights, barricades, construction access, staging, off-duty FLPD officers for traffic control, Traffic Control Through Work Zones signage, MOT plans, 24-hour access through a Knox Box, full time site clerk, on-site parking, and written notice to the neighboring condominium associations and neighborhood associations within 500-feet.

Section 6 – Cost Recover and Fees

• The Rio Vista Civic Association shall be responsible for paying permit fees charged by the City to process its permit applications. Notwithstanding, such fees shall not exceed the lower of (1) the hourly rate charged for City's staff review, including any outside consultants, inspections, and

processing of the permit application or (2) \$4,200.00.

- Annual Inspection Fees have been removed. Any costs associated with inspections by the City will not be charged to the Licensee.
- Recovery of Additional Costs of Administration (recovery of reasonable costs incurred by the City) have been removed. Any costs associated with administrative fees will not be charged to the Licensee.

Section 19 – Insurance

- General liability insurance requirements insuring the Licensee and the City against any and all liability for bodily injury or property damage have been removed. These typically include:
 - o \$1,000,000 per occurrence
 - o \$2,000,000 general aggregate
- Workers' compensation insurance to apply to all Licensee employees and employees of contractors retained by Licensee for the project has been removed. These include:
 - Compliance with "Workers' Compensation Law" of the State of Florida
 - Employer's liability with a limit of \$100,000
 - Business automobile liability for all vehicles owned by the Licensee and Licensee's contractors with limits of \$300,000 per occurrence

Additionally, the request includes electrical power to support the LPR cameras at the City's expense. There are opportunities for the City to provision electrical power for the described LPR cameras, as long as the connection doesn't conflict with the blanket agreement with Florida Power and Light, which is at a fixed rate, or that a given power supply is not funded by an enterprise fund (i.e. lift stations are funded through the Water/Sewer fund).

Should the City Commission wish support proposed effort, staff will work closely with the HOA civic association to ensure the process is streamlined. All work will require the completion of the application process and any additional permits (i.e. electrical permit to connect to power) to complete the project. If the LPR cameras need to be removed (i.e. right-of-way maintenance) for any reason by the City, the City will replace the existing equipment them at the City's cost.

It should be noted that any data captured by the cameras is not the property of the HOA <u>civic association</u>, but the property of the vendor managing and monitoring the cameras. If there is an incident that requires the use of data captured by the cameras the City <u>would</u> work directly with the vendor to gain access to the data, separate from the HOA <u>civic</u> association.

Resource Impact

There is no fiscal impact to the City associated with this action.

- TITLE: REVISED M-6 Motion Authorizing Execution of a Revocable License with Rio Vista Civic Association, Inc. to Install and Maintain Two License Plate Reader Cameras in the SE 17th 7th Street and SE 9th Street Rights-of-Way -(Commission District 4)

Recommendation

Staff recommends the City Commission consider approving a motion authorizing the execution of a Revocable License with Rio Vista Civic Association, Inc. for the installation and perpetual maintenance of two privately owned License Plate Reader (LPR) cameras in the SE 7th Street and SE 9th Street rights-of-way.

Background

The applicant, Rio Vista Civic Association, Inc. is requesting approval to install two (2) license plate reader cameras within the City's public rights-of-way. Such request requires the execution of a Revocable License. The location map is attached as Exhibit 1 and the construction details are attached as Exhibit 2. The Rio Vista Civic Association will be responsible for all costs associated with the installation, as well as ongoing maintenance. If the cameras have to be relocated, the city will pay for the relocation cost, the City also agrees to pay up to \$1,200 per year towards any cost associated with the electrical consumption.

This Revocable License does not authorize construction in the right-of-way without first obtaining engineering and any associated building permits. Such installations shall follow all applicable engineering standards, which includes criteria governing roadside safety setbacks, sight triangles, conflicts with utilities and/or topographical features, electrical service, and location of property lines. A copy of the Revocable License is attached as Exhibit 3.

Typical Revocable License Agreements cover items such as engineering standards for installation of improvements as well as insurance and associated costs. The proposed Revocable License has been reformatted to address this unique situation where the homeowner's civic association is installing cameras within the right-of-way, which amount to improvements that are a-typical from other applications. The following is a summary

of the changes meant to address these types of applications. These can be found in Exhibit 3 under each section heading listed:

Section 3 – Revocable License (Page 3)

- This section includes language that address confidentiality of the data obtained from the cameras with clarification that this agreement doesn't permit the licensee to access the City's data, information or files collected or received by its police department or other safety and security personnel.
- The City makes no promises, assurances, or representations that the use of the cameras will either prevent crime activity or solve any known crimes or effect the City's response times to criminal activity in the area.
- The use of the camera system shall not create any additional duty for the City to respond or investigate any information provided by the camera system.
- The City shall not incur any liability to the licensee or liability for any damage to person or property that may result from any intestinal acts of other, which includes but is not limited to criminal activity.

Section 4 – Term

 Upon determination by the City Commission that this License shall be terminated revoked, the Licensee shall remove all Project Improvements and restore the Licensed Area to the condition existing prior to installation of the Project Improvements.

Section 5 – Conditions

Sub-sections 5.6, 5.7, 5.8, 5.9, 5.10, 5.16, 5.19, 5.20, 5.21, 5.22, 5.23, 5.25, 5.26, 5.28, 5.29 have been intentionally omitted. These sections relate to typical engineering standards for signage, street markings, warning lights, barricades, construction access, staging, off-duty FLPD officers for traffic control, Traffic Control Through Work Zones signage, MOT plans, 24-hour access through a Knox Box, full time site clerk, on-site parking, and written notice to the neighboring condominium associations and neighborhood associations within 500-feet.

Section 6 – Cost Recover and Fees

• The Rio Vista Civic Association shall be responsible for paying permit fees charged by the City to process its permit applications. Notwithstanding, such fees shall not exceed the lower of (1) the hourly rate charged for City's staff review, including any outside consultants, inspections, and

processing of the permit application or (2) \$4,200.00.

- Annual Inspection Fees have been removed. Any costs associated with inspections by the City will not be charged to the Licensee.
- Recovery of Additional Costs of Administration (recovery of reasonable costs incurred by the City) have been removed. Any costs associated with administrative fees will not be charged to the Licensee.

Section 19 – Insurance

- General liability insurance requirements insuring the Licensee and the City against any and all liability for bodily injury or property damage have been removed. These typically include:
 - o \$1,000,000 per occurrence
 - o \$2,000,000 general aggregate
- Workers' compensation insurance to apply to all Licensee employees and employees of contractors retained by Licensee for the project has been removed. These include:
 - Compliance with "Workers' Compensation Law" of the State of Florida
 - Employer's liability with a limit of \$100,000
 - Business automobile liability for all vehicles owned by the Licensee and Licensee's contractors with limits of \$300,000 per occurrence

Additionally, the request includes electrical power to support the LPR cameras at the City's expense. There are opportunities for the City to provision electrical power for the described LPR cameras, as long as the connection doesn't conflict with the blanket agreement with Florida Power and Light, which is at a fixed rate, or that a given power supply is not funded by an enterprise fund (i.e. lift stations are funded through the Water/Sewer fund).

Should the City Commission wish support proposed effort, staff will work closely with the HOA civic association to ensure the process is streamlined. All work will require the completion of the application process and any additional permits (i.e. electrical permit to connect to power) to complete the project. If the LPR cameras need to be removed (i.e. right-of-way maintenance) for any reason by the City, the City will replace the existing equipment them at the City's cost.

It should be noted that any data captured by the cameras is not the property of the HOA <u>civic association</u>, but the property of the vendor managing and monitoring the cameras. If there is an incident that requires the use of data captured by the cameras the City would work directly with the vendor to gain access to the data, separate from the HOA <u>civic association</u>.
