Commissioner Glassman discussed his opposition to this item due to cost and the ability to utilize in-house Audit Staff and the City's real estate consultant, *Colliers International (Colliers)*. He expounded on his viewpoint and commented on the Staff's review of the *Comprehensive Economic Development and Fiscal Impact Report from The Washington Economics Group and Business Flair (Report)* regarding the Bahia Mar Project (*Project*).

City Auditor Herbst explained details of the City Auditor's Office involvement in its review of the *Report*. He noted two aspects associated with vetting the *Project*, an independent estimate of a reasonable return on the *Project* and an understanding of the viability of financial estimates included in the *Report*. Further comment and discussion ensued on efforts to estimate a fair return on the *Project* and timelines on receiving an analysis.

City Manager Lagerbloom commented on his perspective, utilizing consulting firms to do a financial analysis, *Colliers* providing a real estate analysis and the timeline to receive the real estate appraisal.

In response to Vice Mayor Moraitis' question regarding coordinating the *Report's* evaluation with the real estate appraisal, comment and discussion ensued on synchronizing anticipated timelines.

Mayor Trantalis remarked on the community's expectation of proper vetting. Further comment and discussion ensued on utilizing the City Auditor's Office and *Colliers* and the related timeline.

City Attorney Boileau commented on the need to address *Collier's* current limited scope of work under its contract with the City. Further comment and discussion ensued on the ability to validate the *Report* in-house, the expertise and timeline necessary to validate the *Report* and timelines of other audit projects.

In response to Commissioner McKinzie's questions, City Auditor Herbst explained *Ernst & Young's* knowledge base and consulting expertise necessary to validate the underlying aspects included in the *Report*. City Auditor Herbst cited examples and explained related details.

In response to Vice Mayor Moraitis' question, City Attorney Boileau explained items impacting the Commission approval timeline, including Commission input to *Project* documents followed by tenant negotiations and coordinating scheduled Commission Meeting dates. Further comment and discussion ensued on the timetable for a Commission vote on the Project.

Commissioner McKinzie commented on cost concerns related to the amount included in this Agenda item. Vice Mayor Moraitis remarked on her perspective. Further comment and discussion ensued.

Commissioner Sorensen made a motion to approve this item and was seconded by Vice Mayor Moraitis.

Mayor Trantalis opened the public hearing.

In response to Mayor Trantalis' question, Anthony Fajardo, Development Services Department Director, explained this Agenda item is part of the incentive program for Uptown Urban Village, rezoning to one of the new Uptown Zoning Districts. There is an associated mixed-use project consisting of three hundred and twelve (312) units and approximately thirty-eight thousand square feet (38,000') of office space and other commercial use, which is going through a separate review process. It is the City's preference to rezone these parcels to foster redevelopment as it occurs along the corridors in the Uptown area.

Mayor Trantalis recognized Andrew Schein, Esq., Lochrie and Chakas, P.A., on behalf of the applicant. In response to Mayor Trantalis' question, Mr. Schein confirmed the applicant is moving forward with its mixed-use project in the Development Review Process.

Each Commission Member disclosed verbal communications, written communications, site visits and expert opinions received.

There being no one else wishing to speak on this item, Commissioner Glassman made a motion to close the public hearing, which was seconded by Commissioner McKinzie. Roll call showed: AYES: Commissioner McKinzie, Commissioner Sorensen, Vice Mayor Moraitis, Commissioner Glassman, and Mayor Trantalis

Commissioner Sorensen remarked on compensation for City Clerk David Soloman as compared to department heads. City Manager Lagerbloom confirmed Human Resource Department Staff would work to provide a salary comparison with other Broward County City Clerks.
