RESOLUTIONS

R-1 [22-0309](#) Resolution Waiving the Minimum Requirement on Reimbursement of Eligible Project Costs and the Minimum Contribution Amount of the Business/Property Owner for the Development Incentive Program (DIP); and Motion Approving an Award of \$727,000 to Dale's Wheels & Tires Direct, Inc., and Authorizing the Executive Director to Negotiate and Execute the Development Agreements and Any and All Other Documents or Instruments Necessary or Incidental to Consummate the Transaction - (Commission District 2)

Chair Trantalis remarked on concerns regarding this Agenda item exceeding program parameters. He noted limited remaining CRA funds and expounded on his viewpoint regarding proposed use of this funding.

Clarence Woods, Community Redevelopment Agency (CRA) Manager, explained the applicant qualifies for the Facade Program and the Development Incentive Program (DIP) for two (2) parcels. In lieu of four (4) agreements for both programs on the two (2) parcels, this waiver allows one (1) agreement and represents consolidation of the project. Mr. Woods expounded on related details and cited examples of similar waivers.

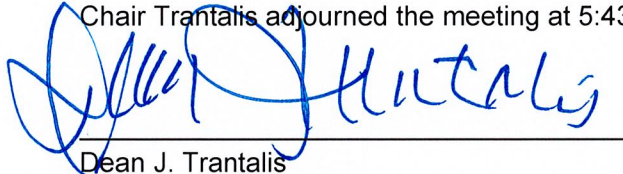
