SUNRISE KEY NEIGHBORHOOD IMPROVEMENT DISTRICT MILLAGE AND BUDGET

- 1. MAYOR: This is the first of two public hearings as required by law on the City of Fort Lauderdale's Sunrise Key Neighborhood Improvement District millage and budget for Fiscal Year 2025. The purpose of the hearing is to receive requests and comments regarding the Sunrise Key Neighborhood Improvement District's budget and to explain the budget and any amendments thereto. The public hearing is now open. The Acting City Manager will now present the proposed millage rate and tentative budget.
- 2. ACTING CITY MANAGER: The Sunrise Key Neighborhood Improvement District taxes the residents of this special district to provide security to their neighborhood. At their May 14, 2024, meeting, the district voted their millage rate at 1.0000 mill, which will generate an estimated tax collection of \$201,660 to support an operating budget of \$201,660. This millage rate is 5.30% more than the rolled-back rate of 0.9497 mills and is necessary to maintain services for the Sunrise Key Neighborhood Improvement District.

CITY OF FORT LAUDERDALE FY 2025 TENTATIVE MILLAGE

(This MUST be adopted BEFORE the Tentative Budget)

- 1. <u>MAYOR</u>: This is the first of two public hearings as required by law on the millage rates for **Fiscal Year 2025**. The purpose of the hearing is to receive requests and comments regarding the City's millage rate and to explain any amendments thereto. The public hearing is now open and the Acting City Manager will now present the tentative millage rate on which the **Fiscal Year 2025 budget** is based.
- 2. ACTING CITY MANAGER: The Fiscal Year 2025 City of Fort Lauderdale Tentative Budget includes maintaining the current millage rate of 4.1193 and decreasing the combined debt service millage from .2737 to .2545 mills. The recommended millage rate of 4.1193 exceeds the rolled-back rate of 3.8408 by 7.25%. The aggregate tentative millage rate, including the Sunrise Key Dependent District is 4.1229, which results in an increase of 7.25% above the aggregate rolled-back rate of 3.8443 and is premised upon the following:
 - Funding Increases in Wages and Insurances
 - Funding Key Commission Priorities & Community Investment Plan Projects
 - Maintaining a Healthy Fund Balance

Increases to the **Fiscal Year 2025** General Fund Budget that require maintaining the millage at the same rate as the prior **seventeen (17)** years include:

- \$12.6 Million for the increase in fringe benefits including health insurance and pension contributions
- \$10.5 Million for the increase in salaries & wages
- \$2.6 Million in increased insurance expenses

The purpose of the hearing is to receive requests and comments regarding the City's budget and to explain the budget and any amendments thereto. The public hearing is now open. - 2. <u>ACTING CITY MANAGER</u>: The Fiscal Year 2025 City of Fort Lauderdale Tentative Budget includes maintaining the same millage rate of 4.1193 and decreasing the annual Fire Assessment rate by \$10 to \$328 per residential unit. The tentative budget is premised on the following:
 - Funding Increases in Wages and Insurances
 - Funding Key Commission Priorities & Community Investment Plan Projects; and
 - Maintaining a Healthy Fund Balance

I would now like to present to you the adjustments to the **Fiscal Year 2025 Budget** that have been made since the submission of the **July 2**, **2024** Proposed Budget:

The following adjustments have been made to the General Fund Revenues:

- Increase in revenues totaling \$1,032,634 to account for updated Ad Valorem and State revenue estimates.
- Increase in revenues totaling \$145,455 to account for updated administrative charges as well as updated estimates for the speed zone safety camera program revenue.
- Increase in the appropriation of General Fund Balance totaling \$3,144,589.

Adjustments have been made to the General Fund Expenditures including:

- \$2,152,978 increase to fund the first payment of seven for a Cost of Living Adjustment for the General Employee Retirement System Retirees
- \$676,000 increase for Railroad Crossing Elimination Grant Program Local Match
- \$375,000 increase for Reconnecting Communities Grant Local Match
- \$315,424 increase in transfer to the Community Redevelopment Agency
