In response to Commissioner DuBose, Assistant City Attorney Bob Dunckel noted there was correspondence provided for the January 7, 2013 Commission meeting which placed the burden for electrical utility relocation, both existing and future. Reference to future has now been deleted. As to existing facilities, there is a 10-foot electrical utility easement running along the western boundary. The roadway the City will acquire is an extension of SW 2 Avenue, which is skewed to the east side therefore, he does not see any conflict between the use of the roadway and utility poles that might be placed in the western 10 feet of the parcel. An additional 10-foot easement is reserved on the north side but presently there appear to be no electrical facilities within it. It appears all of the poles are in the right-of-way of NE 4 Street, which would not affect the City. He understands there is a fiber optic cable but that would be the responsibility of AT&T and Comcast.

Dunckel confirmed for Commissioner DuBose that he is comfortable with respect to liability. He noted that if this item is not approved, it would break the deal between Florida Power & Light (FPL) and All Aboard Florida.

Mayor Seiler opened the floor for public comment.

Kevin Phillips, vice-president of City View Townhomes Association, said residents of the 130-unit City

View development have no information about this project. He believes they should be able to review the project plans. Mayor Seiler explained that, at this time, the plans are conceptual. He expects the Applicant will meet with the Association once they start developing plans. Phillips said they would like to see the plans before an easement is granted. The City Manager explained the Commission is not granting an easement at this meeting. This is merely to allow for All Aboard Florida or Flagler Development to purchase land from FPL and addressing current infrastructure on that property.

Jose Gonzales, senior vice-president of Florida East Coast Industries, advised that he made a presentation before the City View Townhomes Association early on. This step is about acquiring the FPL parcel relating to a substation site and FPL needs assurances that the existing facilities will not be relocated. It is not an easement from the City, but rather that the City will not force FPL to move its current location because it is not in the right-of-way. They are not yet at the stage where there are plans to share. Commissioner Trantalis clarified that the Association wants to participate in the process before the project is complete so they can provide input along the way on potential impacts to the neighborhood. Gonzales assured he will engage residents when the time is right. Commissioner DuBose requested that they also reach out to the City because there are other neighborhoods that have shared similar concerns.

Tom Recca, 212 City View Drive, stressed the residents have no information about the traffic flow or configuration. Florida Department of Transportation representatives were not aware the property had been purchased for a parking lot. Communication needs to improve.

There was no one else wishing to speak.

She is requesting these funds be reallocated to Care Resource because it has been serving the Minority Development and Empowerment's clients since they closed. Care Resource serves Spanish, Creole and American clients, and provides case management services through job search, readiness assistance, face-to-face encounters and budgeting assistance. They have served 111 new clients since October 1. There is only one other agency in the county that provides similar services.

There being no other individuals wishing to speak on this matter, a motion was made by Commissioner Trantalis and seconded by Commissioner DuBose to close the public hearing. Roll call showed: AYES: Commissioner Trantalis, Commissioner DuBose, Commissioner Rogers, Vice-Mayor Roberts and Mayor Seiler. NAYS: None.

Commissioner DuBose was glad to hear Earp's comments. Earp confirmed for Commissioner DuBose that Care Resource is not serving 100 percent of Minority Development's clients. Good afternoon, Mayor, Vice Mayor, Commissioners and City Manager,

The landmark designation for the Main Library will soon be on your agenda and I wanted to bring forth some information that is vital to the discussion.

When I spoke on behalf of the Broward Trust for Historic Preservation at the Historic Preservation Board meeting on November 4, 2013, I testified to the importance of certain interior portions of the Main Library and why they, too, should be designated along with the exterior of the building. Attached is the original application prepared by the Broward County Historical Commission. Please note on Page 5, under "Designation Rationale of the Building and Site" the references to the interior. Also on that page at the bottom, Criteria (f) addresses the interiors. Appendix A – photographs – are shown on Pages 9-10 and 12,14. Lastly, Appendix B – plans- demonstrate the interior areas that are worthy of designation.

The HPB unanimously designated only the exterior because that is what the County Commission/Administration presented in the final application; that was shortsighted. However, the HPB requested that Merrilyn Rathbun review the interiors and that the two County staffers present, Steve Hammond and Dave Baber return with an application for designating portions of the interior. (I don't believe that any of that happened.) Both Mr. Baber and Mr. Hammond testified to the importance of the interiors, and the attached letter of November 6, 2013 from the Broward County Historical Commission to the County Commission addresses this issue.

You, as the City Commission, have the authority to designate the interior portions as well as the exterior and it only makes sense to do so. Anyone who has ever been inside the Main Library understands the importance of the interior. I'm writing now because you need to have all of the facts and, hopefully, there is time for Ms. Rathbun to do the requested research and report back to you regarding the interiors. Designating the exterior without the portions of the interior makes no sense; please designate both. If staff is not yet ready to present to you the interior analysis, then please defer this item until such time as all of the information is available.

DESIGNATION RATIONALE OF THE BUILDING AND SITE

Through this application the following aspects of the Broward County Main Library, located at 100 South Andrews Avenue, Fort Lauderdale Florida are included in its designation as a Landmark and Landmark Site:

- The entire site
- The entire exterior of the building including the pedestrian bridge connecting to the adjacent parking garage.
- The following aspects of the interior as identified on the floor plans in Appendix B:
 - The interior pedestrian "street" including the water feature, garden area, escalators and glass elevator between the first and second floors and the area at the top of the escalators and glass elevator.
 - o The open atrium area on the first through seventh floors including the associated open staircases.

Criteria Related to this Designation

(d) Its identification as the work of a master builder, designer or architect whose individual work has influenced the development of the city, state, or nation:

Marcel Breuer had a dramatic and profound impact on the quality and nature or architecture nationally and throughout the world both through his body of work as well as his teaching at the Bauhaus and Harvard University. Robert T. Gatge, the design architect of the Main Library, was a protégé of Breuer and was profoundly influenced by him as a result of his long term professional relationship as an associate and partner in Breuer's firm.

(e) Its value as a building recognized for the quality of its architecture, and sufficient elements showing its architectural significance:

The Main Library is an exceptional example of modern architecture possessing many of the attributes that are the foundation of the concepts promoted at the Bauhaus, including its integrity of design and honesty of materials.

(f) Its distinguishing characteristics of an architectural style valuable for the study of a period, method of construction, or use of indigenous materials:

Some of the distinguishing features of this building are the open welcoming and flowing spaces vertically connecting the seven public floors through atrium open conveyances such as the escalators, glass elevator and atrium staircases, the exposed post and beam concrete structural system, the use of keystone, an indigenous material, and the interconnection of interior and exterior space through the use of terraced balconies and the glass wall on the north elevation.

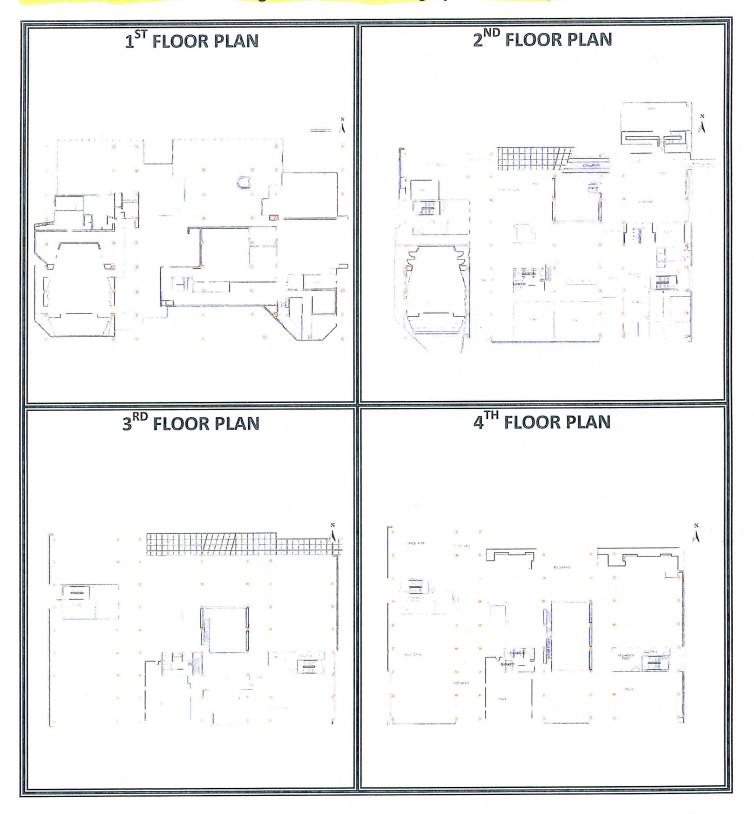

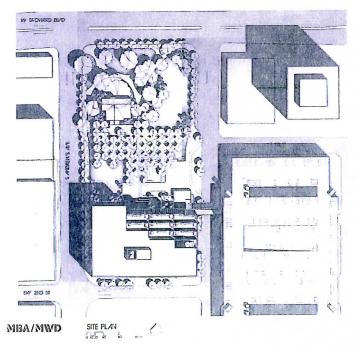

Dear Mayor and County Commissioners:

At the November 4, 2013, City of Fort Lauderdale Historic Preservation Board (HPB) meeting, a motion to recommend that the City Commission grant landmark designation to the County's Main Library site and building exterior was approved by a unanimous vote. Also at that meeting, the HPB requested that their consultant Merrilyn Rathbun research the criteria of designating the interior as well. In addition, the HPB requested that the two County staffers present, Steve Hammond and Dave Baber, report this information to the County Commission and return to the Board with an application for designating portions of the interior as well.

The Broward County Historical Commission at its November 5, 2013, meeting, unanimously passed a motion requesting that the Board of County Commissioners ask the City of Fort Lauderdale to designate portions of the interior as outlined in the original designation application. It was agreed that certain interior portions are integral to the design of the building and the flow between the exterior and interior. Specifically, the stairways, the first floor reflecting pool, the soaring atrium and the first floor open corridor linking the entrances must be protected, as these elements were critical to the Architect's vision.
