Charles King, 105 North Victoria Park Road, questioned how the lease was handled. He supported the eviction. The rent for this property should be higher.

In response to Commissioner Trantalis, the City Manager said there used to be an internal system by which rents were set and collected. He was dissatisfied with the system, which is why the City hired a real estate company to act as a property manager. As part of the process of bringing on the property manager, the delinquency was discovered. Staff spent a few months working with the owner trying to get the rent and back taxes back on track before coming to this point. Commissioner Trantalis asked if there are any other cases of this nature. The City Manager noted another lease for property at the airport that the Commission terminated at its last meeting which is not under control of the property management company. He intends to bring forward an amendment to the property management contract to include the airport properties. Most of the delinquencies involve taxes. Mayor Seiler noted that the City Manager has been asking for outside help with real estate issues for more than two years. The amount in this case is guaranteed. Commissioner Trantalis noted that the Oasis Café property is high-profile where more rent could have been collected. He did not want to send a message that a second-rate business could occupy that space. He did not want this type of operation to continue under a City lease and hoped for improvement overall going forward. The City Manager said that since the property has been advertised as available for lease, the City has had inquiries from some of the best food operators in the community.

Commissioner Roberts introduced the resolution, which was read by title only.

Raymond Cox, no address provided, questioned the scope of this project. He felt there are unfair actions being taken against the poor and discussed recent zoning changes.

In response to Commissioner Trantalis, the City Manager explained some details about this project being delayed. The biggest issue has to do with seagrass mitigation and the inability to use Deerfield Island.

Tyler Chappell, a member of the Florida Inland Navigation District Board (FIND), said FIND does not have seagrass mitigation requirements and therefore their project is not being delayed for that reason.

FIND's footprint for dredging is the main channel of the Intracoastal. There is more seagrass in the area the City is proposing to dredge. He confirmed for Commissioner Trantalis that the City needs to reapply but there is every indication that the funds will be approved again. It will go before the FIND board in June. Other municipalities can apply. Currently Broward County has \$3.3 million to allocate annually. Fort Lauderdale is requesting \$600,000. There should be enough to cover this allocation.

The City Manager said he is cautiously optimistic the City will be able to persuade other regulatory agencies to go outside the preferred mitigation area in order to have options other than Deerfield Island. The City does not have cooperation at the County level. If they are allowed to go outside the mitigation boundaries, there are other options. In further response to Commissioner Trantalis, the City Manager advised that staff will be picking up where it left off with the County. Work is continuing

Commissioner Trantalis introduced the resolution, which was read by title only.

Mayor Seiler announced that Vice-Mayor Rogers filed a request for the Commission to review the development permit application and conditional use for this project. He outlined the options available and procedure.

Vice-Mayor Rogers said neighborhood representatives met with County officials and seem satisfied with most of the plan. He will meet with the County at the end of the month. With the rezoning second reading scheduled for March 3, it may be a good time also for this review.

Mayor Seiler opened the floor for public comment.

Raymond Cox, no address provided, was opposed to a delay.

Robert Walsh, 401 East Las Olas Boulevard, criticized the way Vice-Mayor Rogers has handled this matter. He advocated for the facility.

L.F. Rosenthal, 1237 NW 4 Avenue, noted that he spoke in support of the proposal at the last meeting. He commented that district commissioners are charged with advocating for what their constituents want. Vice-Mayor Rogers is simply advocating for his constituents. He also said even more facilities are needed. There are no problems with a similar facility on his block. He took issue with those who have attacked Vice-Mayor Rogers and noted his recent no opposition election to office.

Charles King, 105 North Victoria Park Road, felt this matter has gone on too long. There are many addicts in Fort Lauderdale and many who do not have an opportunity to get help. The delay is killing people. The facility already exists in Fort Lauderdale. He believed the goal is to disperse such facilities and reduce the number in the downtown core. Along that line of thinking, Edgewood is on the edge of the city's boundary.

There was no one else wishing to speak.

Mayor Seiler opened the floor for public comment.

Burnadette Norris-Weeks, representing Right Perspective Development Group, said she purchased property on NW 7 Avenue more than a decade ago, when the area was vacant and blighted. Businesses organizations including Midtown Business Association, Broward Workshop and Chamber of Commerce do not agree with all aspects of the downzoning east of 9 Avenue. She believed that the 150-foot decline to 45 feet is a violation of the Bert Harris Act (Private Property Rights Protection Act). There are petitions of property owners, business operators and residents who own property, operate a business or reside east of NW 9 avenue (affected parties) in regard to NWRAC-MU_{NE} and NWRAC-MU_E) that were previously submitted for the record.

We believe that for the northwest section of Fort Lauderdale to be successful planning tools must be implemented by the City of Fort Lauderdale to repopulate the northwest section of Fort Lauderdale east of NW 9 Avenue which will support the existing businesses in the area. We support development that creates a vibrant community in which residents can live, work and play. We support development that eliminates slum and blight. We support development that creates a diverse community. We support development that connects and includes the northwest section of Fort Lauderdale east of NW 9 Avenue (Powerline Road) to the redevelopment of the downtown as opposed to excludes it from such redevelopment. Therefore we support the western boundary of NWRAC-MU_E as reflected on the rezoning map moved to NW 9 Avenue (Powerline Road).

Also we support the Table of Dimensional Requirements for the NWRAC-MU_{NE} and NWRAC-MU_E to reflect the following:

- 1) Under the text "Max. Height" the following 75 ft 110 ft (10 stories) max"
- 2) Under the text "Note B" the following: "Subject to Site Plan Level II permit, with City Commission approval, for heights greater than 110 feet" and
- 3) Under the text "Max. Shoulder Height" the following: "75 feet (six stories) max."

She asked that the Commission reconsider this measure. It restricts private property rights.

There was no one else wishing to speak.

Commissioner Trantalis introduced the ordinance, which was read by title only.

Mayor Seiler opened the floor for public comment.

Didier Ortiz, 2400 West Broward Boulevard, felt that the public has a problem with restricting sharing food with the homeless. There have not been objections to other related regulations. He felt that this law is immoral and unenforceable.

Irene Smith, 1231 NW 1 Avenue, wanted to have a candid discussion about the homeless issue and what is the real motive.

Elijah Manley, 3498 NW 4 Street, opposed what he referred to as homeless hate laws. People are taught in church to share.

L.F. Rosenthal, 1237 NW 4 Avenue, spoke in support of the item. He discussed the history of homelessness.

Reverend Gail Tapscott, representing Unitarian Universalist Church of Fort Lauderdale, invited the Commission to her church in Oakland Park to see a movie that addresses homelessness.

Reverend Craig Watts, representing Royal Palm Christian Church, said that if the concern is about public health, he questioned why there is so little attention to other situations but immense concern for the homeless. He questioned if the City is discriminating against a weak class of people. If there really is a health concern, the laws should be broad enough to address everyone's health. He did not think there is really a health issue.

Frank Pontillo, representing REMAR, felt tension is increasing and will continue. Eventually the business community will grow tired of it. He felt a year from now there will still be homeless people on the street because the laws are causing more chronic homelessness. There are not enough shelter beds or housing which is what should be addressed in a comprehensive way. There are not enough social services. He encouraged peaceful solutions.

Raymond Cox, no address provided, advocated for the homeless.

Charles King, 105 North Victoria Park Road, said he agrees with the ordinance but does not like the consolidation of services in one area. These services should be spread throughout the county. It is acceptable to adopt rules and have a standard of what is acceptable in the community. One standard is not relieving one's self in public. He drew attention to the County's lack of support on this topic.

There was no one else wishing to speak.

Commissioner Trantalis noted that when this ordinance was first presented, social service facilities appeared to be concentrated in a redevelopment area. The Commission was concerned but voted for the ordinance because there was a desire to move forward on the feeding aspect. He had requested that the feeding component be separated out but was denied. Now the highest concentration of social service zoning is in a redevelopment area. There has not been any dispersing throughout the community. It detracts from the goals the City is seeking to accomplish in the redevelopment area. The feeding aspect of the ordinance falls short of what the City is attempting to do. It has nothing to do with Arnold Abbott and feeding on the beach. There is not an available facility seven days a week. He asked that staff be asked to followup in providing answers the Commission originally requested. Vice-Mayor Rogers noted that most social service facilities are already in District IV in that is where downtown Fort Lauderdale began. He understood the concern but noted that the courthouse, and federal and county building are concentrated in Fort Lauderdale. This is the county seat. There will always be perceived inequities but staff has addressed this in the best manner possible. There must be zoning provided to address these facilities. Commissioner Roberts felt there is a large expansion from the previous map (Exhibit 1 to Commission Agenda Memorandum 15-0104). For example, industrial and B-2 (General Business) zoning areas were included this time. The homeless issue is a County function. The City has done more than its fair share. The County should step up and exercise their responsibility. The City should continue to work with the County and League of Cities. Commissioner Trantalis agreed; however, he emphasized there are hungry people. Mayor Seiler agreed with Commissioner Roberts that the County needs to step up to this responsibility.

Commissioner Trantalis pointed out that almost the entire area for social service facilities is proposed for the Regional Activity Center (RAC), but the RAC is intended to stimulate economic growth. Ninety percent of the city is unaffected. The staff was asked to change allocation of social service facilities and has not done so. Commissioner Roberts noted that a significant portion has been added in the area near the executive airport. Commissioner Trantalis questioned what is being done to enhance the business environment and attract investment. Commissioner Roberts pointed out what has been added to the executive airport area which has been targeted for economic development. Also, the City has pursued with the County and, or Sheriff use of the stockade as a potential resource, which is also in this area. Commissioner Trantalis reiterated his concern about impact on economic development. Mayor Seiler felt every district is being asked to share the burden and as such, there is no reason to oppose the ordinance. Commissioner Trantalis reiterated his position. He would like to postpone action on this ordinance. As to the issue of economic development, Vice-Mayor Rogers pointed out that they are areas where the City wants to encourage density which does not mean residential areas. Commissioner Trantalis was concerned about concentrating social service facilities in a blighted area. Vice Mayor Rogers did not feel there is any more concentration north of Broward Boulevard than it is south of Broward Boulevard. Mayor Seiler and Commissioner Roberts pointed out that the lack of other alternatives. Commissioner Trantalis agreed to review the map with staff. He reiterated his position also about the feeding component of this ordinance. Vice Mayor Rogers emphasized the importance of partnering with the business community and his belief that there will be opportunities ahead. Commissioner Trantalis felt overall the ordinance is lacking.
