They are running out of space and need to look into options on the seven- to 10-year horizon for acquiring land if they remain in the cemetery business. With regard to pricing, there is a resident and non-resident base system. If the Commission is concerned about that, he suggested that they could increase the non-resident pricing and hold firm on the resident pricing. Commissioner Rogers said he felt comfortable with that. He suggested approving the item tonight without a pricing increase for residential.

The City Manager advised that the Applicant has indicated he will not be in town for the July 7 meeting. The property owner has stated this is a time-sensitive matter and the August 18 meeting would be too late. The Commission will need to set a date to hear the matter.

Mayor Seiler felt that should be coordinated through the property owner. The Commission agreed.

Attorney Steve Tilbrook of Gray Robinson, representing the property owner, said his client suffers from a medical condition and there is a need to resolve the item quickly due to declining health of his client. There is a contract to sell the property, and this particular item has impaired that contract.

Attorney Stephanie Toothaker of Tripp Scott, representing the contract purchaser OTO Development, said that after six months of meeting with beach stakeholders, her client submitted an application to the Design Review Committee (DRC) on February 13. The application was reviewed on March 10 and there was no issue with any of the properties being considered historic. They believe the historic application was submitted to delay or prevent a proposed development. The project was approved by a majority vote of the Central Beach Alliance. Her client is under a tight time frame and a delay would cause serious harm. She was in agreement with Tilbrook's comments.

Charlie Esposito, 3009 Seville Street, read from a prepared statement, which is attached to these minutes.

Consultant Marla Dumas, representing the Applicant, said there was a lot on this location slated for the Vintro Hotel. There was discussion at the time that the Historic Preservation Board would submit applications to designate the property but that did not occur; private citizens came forward. No one was doing this because a development was pending. She advised that other meetings still must occur and can be scheduled on a dual track if the historic designation hearing is delayed. She believed that Mr. Ostryniec has rights but also believed that the Applicant should be allowed to be present at the hearing. The ordinance allows 90 days for the hearing to occur. Mayor Seiler pointed out that the owner has a health issue and believed they should defer to the owner's rights for scheduling. The Applicant can have someone stand in for him or submit a prepared statement. Dumas did not think a few weeks would make a difference. The closing meeting before the Commission meeting is a long one. She did not think it was a property rights issue.

Esposito confirmed for Mayor Seiler that he does not have expert knowledge of the property. David Baber is providing expertise, but Dumas said he would not be available on July 7.

Tilbrook stated that Architect Arthur Marcus testified before the HPB on behalf of the property owner. Toothaker advised that Tony Abbate was their expert, and he designated a spokesperson. Tilbrook said they were not aware of an expert representing the Applicant. Dumas said she was asked by Baber to speak on behalf of the property. She was not recognized by the HPB as an expert but was permitted to

speak during public comments.

Commissioner Trantalis clarified that the HPB passed a resolution supporting Esposito's application and would therefore now be the proponent of the application. Additional experts such as Dumas could provide testimony if the hearing is held July 7. He did not believe the developer was really under the gun because they are not ready to pull the trigger on any of the purchases. He felt that the driving force was the ability of a property owner to designate their property historic if they feel it is adverse to their interests. He felt weight should be given to the property owner because their rights are at issue. He suggested holding the hearing on July 7 and did not think the agenda would be any more or less inundated with agenda items. He wanted a full and fair hearing on the matter because he supports historic preservation.

Esposito suggested September 1, but the City Manager clarified that does not fall within the 90-day time frame. Commissioner Roberts agreed that the hearing should be held July 7. He reiterated that Esposito could provide testimony for the record.

Esposito clarified that he suggested Ostryniec could submit his testimony by video because counsel moved for his standing. Mayor Seiler suggested that Esposito's testimony could also be provided by video. Commissioner Trantalis noted that a three- or five-minute presentation would be allowed but nothing further in order to accommodate as many parties as possible.

Motion made by Commissioner Trantalis and seconded by Commissioner Roberts to approve the item as recommended.
