Charles King, 105 North Victoria Park Road, expressed his concerns and questions regarding the proposal occurring at the State legislative level to rename a portion of Broward Boulevard located from Broward Boulevard north to East Sunrise Boulevard after Lauren Book's (daughter of City lobbyist Ron Book) nonprofit, "Hope and Healing Highway". Mr. King also noted that Lauren Book is running for a Florida State Senate seat. Mr. King stated Florida Senate Bill 114 also contained renaming of a portion of I-95 as "Potters Field." Mr. King stated it is the wrong message for the City.

Commissioner Trantalis asked City Manager Feldman to reconfirm the City had been given no information this is moving forward. Mayor Seiler stated for the record to his knowledge, no one on the City Commission has ever requested the renaming of these areas. Mayor Seiler noted things are often done at the State capital without asking local governments, and a street designation is something the State has the authority to do. Additionally, City Manager Feldman stated this item was requested to be removed from S.B. 114 on February 18, 2016, and was removed on February 19, 2016.

Mayor Seiler confirmed it was the Commission's consensus to move this public hearing to a separate day. The Commission members confirmed this was the consensus. Mayor Seiler noted the Commission is awaiting a site plan and an appraisal of the property. Commissioner Rogers recommended having a workshop prior to the May 10, 2016 Special Public Hearing date. Commissioner Trantalis asked about the criteria for having the site plan go to back to the Planning and Zoning Board. Jenni Morejon, Department of Sustainable Development, stated the parameters for the site plan going back to the Planning and Zoning Board.

Commissioner Rogers clarified and stated for the record that upon receipt of a new revised site plan from the developer, a determination will be made if the site plan will need to go back to the Planning and Zoning Board and then deciding if and when a Workshop would occur. Once this has been determined, the public then will be made aware of the process and timeline in a clear, concise manner to allow for public participation and input.

City Attorney Everett clarified the motion to continue is a continuation of the initial, first public hearing, and a second public hearing is also necessary.

Additionally, City Attorney Everett noted, due to the nature of the public hearing being quasi-judicial, a Town Hall Meeting with the City Manager, City Staff and the public is recommended in lieu of a Commission Workshop.

Commissioner Rogers requested City Attorney Everett to send the Commission a memorandum outlining these items and steps along her recommendations. This memorandum will then be published to the community for a clear understanding of the process to allow for public participation noting that the dates are subject to change based on the date of receipt of the necessary new revised site plan and appraisal.
