### Piman Fest First Annual Picnic

City Manager Chris Lagerbloom confirmed that this is a new Snyder Park event, commenting on the Parks and Recreation Department's concerns regarding all-day closures and requesting input from the event promoter.

Mayor Trantalis recognized Phil Thornburg, Director of Parks and Recreation. Mr. Thornburg said that Snyder Park is a busy park, commenting on numerous activities and concerns related to the impact of large events on other park users. Comment and discussion ensued on details of this event and challenges related to large events. Commissioner Sorensen commented on his concerns.

Mayor Trantalis recognized Wilguins Edmund, event promoter on behalf of the applicant, Piman Restaurant. Mr. Edmund confirmed that the event has been downsized with the goal of creating a safe environment when celebrating Haitian Flag Day in Broward County. He acknowledged concerns raised, confirming that next year they would work to relocate this event to another City Park. The duration of the event was revised and will now be from 4:00 p.m. to 8:00 p.m. Clean up would be from 8:00 p.m. to 9:00 p.m. In response to Commissioner Sorensen's question, discussions ensued on the volume of the amplified sound. Security will include private security and Police Officers.

City Manager Lagerbloom commented on a comfort level with the reduction in expected attendance from 1,500 to 600. Further comment ensued. Mr. Edmund discussed attendance monitoring and limiting attendance to 600. There will be an admission charge.

In response to Commissioner Sorensen, Mr. Thornburg confirmed his agreement to approve this event agreement, recommending the Police Department address attendance and noise levels. Further comment and discussion ensued. Vice Mayor McKinzie discussed prior, similar events, noting that City Parks are for the entire community and commenting on the need to ensure access to all residents.

Mayor Trantalis recognized Barbara McGrath, East Point Towers Condominium. Ms. McGrath spoke in support of this item, commenting on a related issue and the need to address the speed of recreational vehicles in this area of the waterway. Mayor Trantalis noted his concern regarding *dockage creep* into recreational areas of the waterway. Commissioner Glassman commented on his perspective, noting the need to address that concern. Further comment and discussion ensued.

Mayor Trantalis recognized Gunther Galloway, 1601 North Federal Highway. Mr. Gunther spoke in opposition to this item, expounding on related concerns.

Commissioner Glassman commented on the March 7, 2019 Marine Advisory Board's Meeting Minutes (MAB Minutes) related to this topic. He inquired if the review of this topic was conducted as referenced in the MAB Minutes.

Mayor Trantalis recognized Andrew Cuba, Marine Facilities Manager. Mr. Cuba confirmed he had met with Department of Sustainable Development Staff on this topic, expounding on details related to the allowable threshold. Commissioner Glassman recommended addressing this topic when the threshold is met.

Mayor Trantalis recognized Stephen Parker, the applicant. Mr. Parker explained details related to this topic. The Riva Condominium has a land lease 40 feet out from the dock. He commented on details related to the vessel size that could be accommodated and background details regarding the waiver request.

There being no one else wishing to speak on this item, Commissioner Sorensen made a motion to close the public hearing which was seconded by Commissioner Glassman. Roll call showed: AYES: Commissioner Moraitis, Commissioner Glassman, Vice Mayor McKinzie, Commissioner Sorensen and Mayor Trantalis. NAYS: None.

Vice Mayor McKinzie introduced this Resolution which was read by title only.

Mayor Trantalis opened the Public Hearing.

Mayor Trantalis recognized Gary Olson, 2619 Sugar Loaf Lane. Mr.

Olson commented on this item's impact on Holiday Park, the need to allow adequate time for review of the lease and his involvement. He expounded on details related to his concerns, requesting additional time for discussion. Discussion ensued on communications to the Commission. Commissioner Glassman reviewed the communications regarding recommendations and modifications to updated language in the lease and attachments. Mayor Trantalis reviewed the updated language.

Commissioner Glassman explained details regarding the legal description listed in the lease documents. City Attorney Alain Boileau confirmed, expounding on details.

Mayor Trantalis commented on concerns regarding approval language in Section 4.3 of the Leasehold Agreement. He requested the language be updated to reflect approval by the Director of the Department of Sustainable Development *and* the City Commission. City Attorney Boileau said Code would control review and approval, expounding on details. Further comment and discussion ensued.

Mayor Trantalis recognized John Milledge, Esq., on behalf of the Florida Panthers. Mr. Milledge commented on the Commission role as landlord and regulatory body, confirming there is no objection to this modification and his agreement to amend the language. He confirmed that there would be meetings with neighbors for project input. Mr. Milledge also acknowledged there would be Commission approval for programming and related public benefits, expounding on details.

Vice Mayor McKinzie commented on the importance of community input from all areas of the community. Mr. Milledge concurred, expounding on additional updated language to address neighbor concerns and work to ensure neighbor input. Commissioner Glassman suggested meeting with the Council of Fort Lauderdale Civic Associations. Vice Mayor McKinzie requested Mr. Milledge meet with him to assist in receiving District III neighbor input. Further comment and discussion ensued. Mr. Milledge confirmed that concerns raised by Mr. Olson would be addressed.

Commissioner Glassman requested that mature trees remain. Mr. Milledge confirmed this would be addressed. Commissioner Moraitis requested Mr. Milledge participate in an upcoming District I Pre-Agenda Meeting for neighbor input. She also noted the importance of preserving walking trails, commenting on the possible opportunity for an indoor walking trail. Mr. Milledge commented on efforts in this area, confirming that this should be possible.



In response to Commissioner Moraitis, Mr. Milledge reviewed the anticipated, informal timeline for the project, expounding on details including a possible phased approach. A majority of work would be completed in the first phase. Mayor Trantalis commented on the need for a maximum timeline for major improvements inside War Memorial Auditorium. City Attorney Boileau confirmed related language could be included in leasehold language.

Mayor Trantalis explained details regarding the City's contribution of \$800,000. Mr. Milledge confirmed that this amount would fund specific electrical needs previously allocated by the City prior to entering into an agreement with the Florida Panthers. This funding would be in the form of a reimbursement request following completion of the hard costs of electrical upgrades.

In response to Commissioner Glassman's question, City Attorney Boileau explained the process moving forward and modifications in the lease agreement language, expounding on details. This Resolution approves the lease agreement and the grant agreement. Further comment and discussion ensued. City Manager Chris Lagerbloom commented and confirmed the need to change the approval language throughout the document. City Attorney Boileau confirmed.

Commissioner Glassman requested Mr. Milledge meet and coordinate with pickleball and roller rink representatives to address their concerns. Mr. Milledge confirmed. Commissioner Glassman commented on this aspect of the process, noting the upcoming process to approve the Site Plan includes the opportunity for neighbor input. Mayor Trantalis discussed the financial relief provided to the City from this project, expounding on details. Further comment and discussion ensued.

Mayor Trantalis recognized Matthew Caldwell, President and Chief Executive Officer of the Florida Panthers and Sunrise Sports Entertainment (Sunrise Sports). In response to Commissioner Sorensen's question, Mr. Caldwell explained efforts to employ veterans and West Point graduates with the Florida Panthers and Sunrise Sports organizations.

Mayor Trantalis recognized Sean McCaffrey, Chief Operating Officer, Florida Panthers. Mr. McCaffrey expounded on plans for the War Memorial Auditorium, efforts to honor veterans and make the venue a hub for the community.

Mayor Trantalis recognized L. Thomas Chancey, 15 SW 19th Avenue.

Mr. Chancey discussed his experience with tree preservation efforts, commenting on the importance of planning in advance. He expounded on the value of existing trees and the ability to address large tree conservation.

Mayor Trantalis recognized Mike Miller, 810 Cypress Creek Road. Mr. Miller commented on his support of this project and his history and experience at War Memorial Auditorium

Mayor Trantalis recognized William Butler, 309 Sunset Drive. Mr. Butler concurred with Mr. Miller's comments in support of this project, expounding on the importance of focusing on community based needs and neighbor input.

Mayor Trantalis recognized Peter Potter, President of U.S.A. Sports of Florida, Inc. (U.S.A. Sports). Mr. Potter commented on previous use and future use of this venue by U.S.A. Sports. Mayor Trantalis recommended Mr. Potter confer with Mr. Milledge on this topic.

There being no one else wishing to speak on this item, Commissioner Sorensen made a motion to close the public hearing which was seconded by Vice Mayor McKinzie. Roll call showed: AYES: Commissioner Moraitis, Commissioner Glassman, Vice Mayor McKinzie, Commissioner Sorensen and Mayor Trantalis. NAYS: None.

Commissioner Glassman introduced this Resolution as amended which was read by title only.
