Commissioner Glassman commented on formatting aspects of increase and decreased budget amounts in the backup to this item. Laura Reece, Budget Director, explained related accounting details noting corrections. She confirmed revisions would be made.

Commissioner Glassman requested City Manager Lagerbloom repeat the budget line item information related to the Broward County Metropolitan Planning Organization (MPO). City Manager Lagerbloom explained information related to ongoing negotiations with the MPO regarding an Interlocal Agreement (Agreement) and how it would impact this budget line item. The Agreement with the MPO is anticipated to be finalized by the second Commission Regular Meeting on October 15, 2019. Adjustments to the budget would be made prior to the Second Budget Hearing, explaining details.

In response to Commissioner Glassman's question, City Manager Lagerbloom confirmed the amount associated with the MPO Interlocal Agreement is an increase of \$455,954. City Manager Lagerbloom said modifications would be made between the First Budget Hearing and the Second Budget Hearing, explaining related information. Commissioner Glassman noted his perspective and the need for additional information, expounding on details.

City Manager Lagerbloom discussed his recommendation to revert this budget line item to the status quo and present a budget amendment request along with the Interlocal Agreement with the MPO in the 2020 Fiscal Year. Commissioner Glassman confirmed his desire to have a full understanding of all information related to all items before the Commission.

Mayor Trantalis recognized Robert Walsh, 401 East Las Olas Boulevard. Mr. Walsh commented on his perspective regarding the readiness to address the budget, recommending the Commission wait until the October 1, 2019 deadline. He expounded on details regarding additional budget-related concerns, citing examples.

I would now like to present to you the adjustments to the **FY 2020 Budget** that have been made since the submission of the **July 9, 2019** Proposed Budget:

The following adjustments have been made to the General Fund Revenues:

 Adjustments in revenues totaling \$1,219,484 to account for updated State revenue estimates, Ad Valorem tax estimates, and other revenue adjustments outlined in Exhibit 2 of CAM 19-0917.

Adjustments have been made to the General Fund Expenditures including:

- Decrease the City's transfer to the to the Community Redevelopment Agency associated with the July 1st Taxable Values (\$13,747)
- Increase in funding to offer Florida Retirement System (FRS) as a pension option for employees \$500,000
- Decrease in Public Safety (Police \$550,000 and Fire-Rescue \$600,000)
 Overtime (\$1,150,000)

- Decrease in Attrition rate due to a reduction in police officer vacancies \$550,000
- Increase in funding to the United Way for a contribution to Homelessness in Fort Lauderdale \$750,000
- Increase to provide funding to the Historic Stranahan House Museum \$100,000
- Increase in funding to the Winterfest, Inc. for a contribution to the Boat Parade
 \$60,000
- Increase in funding for an updated Metropolitan Planning Organization (MPO)
 Interlocal Agreement \$455,954
- Other expenditure adjustments based upon updated information as outlined in Exhibit 2 of CAM 19-0917

These revenue and expenditure adjustments bring us to a FY 2020 Tentative General Fund Budget of \$373,792,257.

Changes to other funds since the submission of the **FY 2020 Proposed Budget include**:

- The Debt Fund Budget was increased by **\$13,525**; the new Tentative Budget is \$38,879,987.
- The Self-Insured Health Benefits Fund Budget was decreased by (\$43,872), the new Tentative Budget is \$34,397,322
- The Community Redevelopment Agency Fund Budget was decreased by (\$215,173); the new Tentative Budget is \$33,628,413.
- The Parking Fund Budget was increased by **\$825,273**; the new Tentative Budget is \$25,906,657.
- The Cemetery Perpetual Care Fund Budget was decreased by (\$55,843); the new Tentative Budget is \$1,281,357.
- The Beach Business Improvement District Fund Budget was increased by \$402;
 the new Tentative Budget is \$1,066,809.
