Proclamation declaring January 20, 2016 as Guardian Ad Litem Day in the City of Fort Lauderdale

Commissioner Trantalis presented a Proclamation to Laura Davis declaring January 20, 2016 as Guardian Ad Litem Day in the City of Fort Lauderdale in support of the Guardian Ad Litem Program of the 17th Judicial Circuit here in Broward County. It is also to remind our neighbors and City employees that there are thousands abused and neglected children who do not have the blessings that most children have and are just hoping to find people who can love and care for them. As it is the beginning of the New Year, the Guardian Ad Litem ("GAL") Program and the City of Fort Lauderdale encourages our neighbors and employees to make a New Year's resolution to volunteer a few hours a month to help an abused child. Commissioner Trantalis read the proclamation in its entirety.

Ms. Davis spoke thanking the Commission for this opportunity and requesting community volunteers to check on these abused and neglected children explaining these volunteers are the eyes and ears of the judges that can advise how these children are doing and make recommendations to the court. Ms. Davis noted GAL volunteering is a very important job and everyone from all walks of life is needed to help a child who has had a very hard start in life. It only takes a few hours a month along with a commitment and a little bit of flexibility in terms scheduling to attend and update the court every 90 days as to how a child is doing. Some of the benefits children receive from having a GAL include doing better in school, the likelihood they are will get out of the foster care system sooner and into a permanent situation, and, they usually have fewer behavior problems. Ms. Davis advised the public as to how to contact her to volunteer for the GAL Program. Mayor Seiler also noted that the public can contact GuardianAdLitem.org for information about volunteering for this important and worthy project.

PRES- 16-0029 2 Proclamation declaring February 2, 2016 as Mangrove Awareness Day in the City of Fort Lauderdale

Commissioner Rogers presented the proclamation to Christian Hoss, Executive Director, and Lee Gottlieb, Director of Community Outreach Programs, for the Youth and Environmental Alliance declaring February 2, 2016 as Mangrove Awareness Day in the City of Fort Lauderdale. The State of Florida supports one of the largest mangrove forests in North America playing a vital role in preserving our environment with over 500,000 acres of mangrove forests protecting Florida's natural environment. Christian Hoss and Lee Gottlieb along with student and adult volunteers will plant 50 red mangroves at Bill Keith Preserve in the City of Fort Lauderdale helping to restore a vital wetland habitat. Commissioner Rogers read the proclamation in its entirety.

Mr. Hoss and Mr. Gottlieb thanked the Commission noting all of the environmental benefits of mangrove trees and detailing the work that Youth and Environmental Alliance is doing to preserve the environment.

Acceptance of Grant Funds - \$291,281 - Broward Boating Improvement Program for Cox's Landing (15th Street Boat Ramp)

Mr. Dan Jaffe, Chairman of the Broward County Marine Advisory Committee and Mr. John Fiore, Staff Liaison of the Broward County Marine Advisory Committee, spoke on behalf of the Broward County Commission noting the boating lifestyle of the City is just one of its many attractions. On the County level, grant money exists from the Broward Boating Improvement Program and are funded from boat registration fees. These funds are used to pay for boating access anywhere in Broward County. Over the last 20 years, Fort Lauderdale has received approximately \$3,500,000 in grant funds from the Broward Boating Improvement Program representing some 28 projects and 20 percent of the County's budget.

Mr. Jaffee and Mr. Fiore presented a check for \$291,281 representing the County's portion of the grant to fund the 15th Street Boat Ramp in Cox Park stating the City has done extensive renovations and improvements that make the lives of boat owners in Broward County and those visiting the City better.

Commissioner Trantalis asked what these funds represent. Mr. Fiore noted the particular items done at the 15th Street Boat Ramp at Cox Park. Mr. Fiore thanked City Staff for their work in getting the project at Cox Park completed. Mr. Fiore also discussed holding a first time Municipal Marine Summit attended by all cities located on the water, the City's Marine Advisory Board, the Police Department, the Coast Guard, the Fish and Wildlife Conservation Commission, the Florida Navigation District, and the Broward Sheriff's Office. The summit allowed a forum where cities coulde share successful policies and procedures that work and the challenges they face. It also enables all waterfront communities to work together as one to communicate to Broward County what works to make the county a better and safer place to boat. Mayor Seiler thanked them for all their support.

Police Officer of the Month for January, 2016

Chief of Police Frank Adderley, presented Police Officers of the Month for January 2016 Detective Rafael Bouyett. Detective Bouyett has been a member of the Department for 14 years currently assigned to the Career Criminal Unit and recognized for his outstanding work on fifteen separate occasions. On September 6, 2015, Detective Bouyett was working the Igloo Caribbean Festival at Lockhart Stadium. As thousands of spectators exited the stadium at the conclusion of the event. Detective Bouyett observed several individuals engaged in a physical altercation. Within seconds, gunshots were fired, and Detective Bouyett saw an armed suspect running away from the crowd and chased the suspect on foot. As the suspect entered a parked vehicle, Detective Bouyett realized the need to take immediate action and noted that his back-up officers were minutes away. While in a safe tactical position, Detective Bouyett arrested the armed suspect and recovered a firearm used during the shooting. The suspect was identified as the individual who shot two victims and was charged with two counts of attempted murder. Tonight we recognize Detective Bouyett for his immediate response that lead to the apprehension of an armed and dangerous suspect. The entire audience commended Detective Bouyett for a job well done. Detective Bouyett's wife and son were in attendance and photos taken to commemorate Detective Bouyett's Award for Police Officer of the Month - January 2016. Mayor Seiler thanked Mrs. Bouyett and their son for what they do for our community noting the sacrifices all family members of the City's Police Department make day in and day out.

Commissioner Rogers said the neighborhood of Harbordale located near this site has been engaged with the contractor and Marathon Oil who has tried to address all issues involved. He further stated, there had been a meeting with the contractor, Marathon Petroleum ("Marathon"), and the president of the Harbordale neighborhood association to allow input from the Harbordale community, all concerns had been addressed, and things are ready to move forward with the project.

Tyler Haan, Project Manager for Marathon Petroleum spoke stating this would be an additional tank to be located on the site on the Northwest corner of the facility.

Commission Trantalis noted that there had been objection from people in the area because the tank is 125 feet from the housing development Village East.

Mr. Haan said the port's fire department has reviewed the proposed setbacks agreeing that those are acceptable setbacks. Mr. Haan stated neighborhood concerns included site security, upkeep around the fence lines noting the site borders the outside of the port, and some of the fence lines had a lot of overgrown trees and debris. He said Marathon had taken action to clear out those fence lines and opened them up to provide proper security around the facility. It was noted the debris was located in an easement between Marathon's property and the property next to it. An additional comment included there are gates in the chain link fence around the facility and questions as to whether those locks were sufficient. Marathon has upgraded those locks.

Commissioner Trantalis asked for confirmation that the facility's perimeter is secure and it was confirmed by Mr. Haan. It was also confirmed that Marathon has someone on site 24 hours a day, 365 days a year that do continuous walk rounds throughout the day and night. Monday through Friday it is Marathon Oil security personnel, and on Saturday it is split between Marathon Oil security personnel during the daytime and outside security at night. On Sunday it is outside security.

Mayor Seiler was told that an addition speaker had signed up for this item.

Yvonne Aznarez, a resident of Village East, spoke in opposition to this item. Ms. Aznarez cited the proximately of the 7,000-gallon tank of explosive gasoline in such proximity to the Village East townhome residences. Her primary concern is security stating anyone can jump the fence and the lack of walls. Ms. Arnarez stated Marathon avoided the residents' questions and concerns suggesting in today's world, there is a need to be proactive and install a wall that cannot be easily breached.

A copy of Ms. Aznarez' pictures are attached to these minutes.

Mr. Haan stated Marathon met with Marilyn Mammano several times and offered several meetings with community members the last meeting being December 21, 2015. Commissioner Rogers stated one of the concerns he had after speaking with Ms. Mammano was that she did not hear back from Marathon for an extended period.

Commissioner Rogers questioned City Manager Feldman regarding the permitting of this project. Commissioner Roberts recommended deferring this item until we can better answer some of the concerns that have been raised.

Mayor Seiler recommended Marathon meet with the residents of Village East to share what precautions are in place from a safety standpoint as it is important to put nearby residents at ease with respect to safety issues ensuring that a potential flame does not spread to nearby property.

Jenni Morejon, Sustainable Development, put on the record that while there has not been a formal meeting with the adjacent townhome association, City Staff has been in contact with the President of the Village East Townhome Association and provided her with the updated narrative from the applicant. This was done within the last month.

Commissioner Rogers recommended City Staff and Marathon meet with the adjacent property owners to go over the plans. Additionally, he feels it is only smart to meet with City Staff again to determine the next steps when the building permit is issued to address other items associated with this project and safety measures are important to all involved.

Commissioner Trantalis informed Mr. Haan Marathon should have a meeting and notice everyone within a 300-foot radius of the site by U.S. Mail. Commissioner Trantalis also mentioned that not just this tank but all tanks at this site need to have proper precautions, taken to prevent a tragedy.

There were no additional comments regarding this item.

Commissioner Roberts moved to reconsider the vote which was seconded by Commissioner Rogers.

Hence, if it is moved over, it will be measured on a 90 degree perpendicular and the numbers change. Currently, they do not have the numbers and surveys to show what the new numbers will be. Further discussions ensued.

Commissioner Trantalis moved to close the public hearing which was seconded by Commissioner Roberts and approved.

Mayor Seiler closed the public hearing.

Commissioner Trantalis made a motion to defer this item for one meeting, so the applicant can come back with proper measurements when moving the cluster piles 8 feet to the east. This will allow the proper measurements to be included in the resolution.

Commissioner Rogers moved to defer this item to the February 2, 2016 Regular Commission Meeting and was seconded by Commissioner Roberts.

The Tarpon River Civic Association brings to your attention a Waiver of Limitations Request for triple cluster mooring pilings at 811 SW 6 Street. This is on the Commission agenda for Wednesday night, January 20, 2016, as Public Hearing #1. The application requests 2 triple piling clusters: one at the eastern end 40 ft from the property line and one at the western end 47.1 ft from the property line. This request exceeds the permitted distance of 25 ft. While we support the need of our neighbors to be able to secure their future yacht properly and welcome them from New York to our caring and historic neighborhood, many questions about the request have developed over the last few months.

Many Tarpon River residents have approached the Tarpon River Neighborhood Board of Directors and have concerns with this application waiver request for reasons described below:

#### Safety and Navigation Concerns:

• While the distance of waiver requests for both the east and west pilings out into the New River are of concern, the west piling in particular is of safety concern due to the fact that the placement of the piling is just off the entrance from Tarpon River into the New River. There are dozens of small and low profile boats as well as kayaks and canoes that moor and dock at private residences south of this applicant's residence along the Tarpon River. According to neighbors who have expressed concern, more than 80% of their voyages take them east from Tarpon River into the New River creating a "right turn" navigation for many vessels. This right turn will be obstructed by a triple cluster piling that extends 47.1 feet from the property line into New River. As all of New River is considered a navigable area without a designated channel, this navigational area for the dozens of boats that moor up and down Tarpon River will create a hazard to both safety and navigation both with a yacht in the mooring and especially when the yacht is not at this mooring and the triple clusters are exposed at night.

The Marine Advisory Board has already weighed in on this matter. While the neighborhood does not agree completely with their recommendation, we would be more willing to accept it if you would see to the following reasonable requests of the applicant in order to receive Commission approve for this waiver:

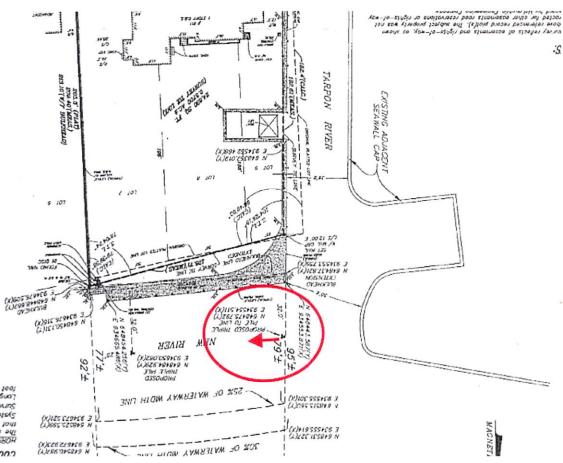
- 1 Have them define more fully how they will implement the MAB's request for reflective material on the pilings (bottom of page 4 of MAB minutes). This is was function of the MAB's approval. The neighborhood would prefer lights on the piling cluster.
- 2 Request the applicant to move the west triple cluster piling 15 feet east so that when their yacht is not in its mooring it will produce less of a hazard to Tarpon River boaters coming out into New River to take their easterly turn into New River (as shown in red circle from applicant's drawing below). The applicant's representative said he would be willing to do as much as noted in the MAB minutes (top of page 5 of MAB minutes) but we need this to be formalized as part of your approval.

Thank you for your consideration of our neighborhood's request.

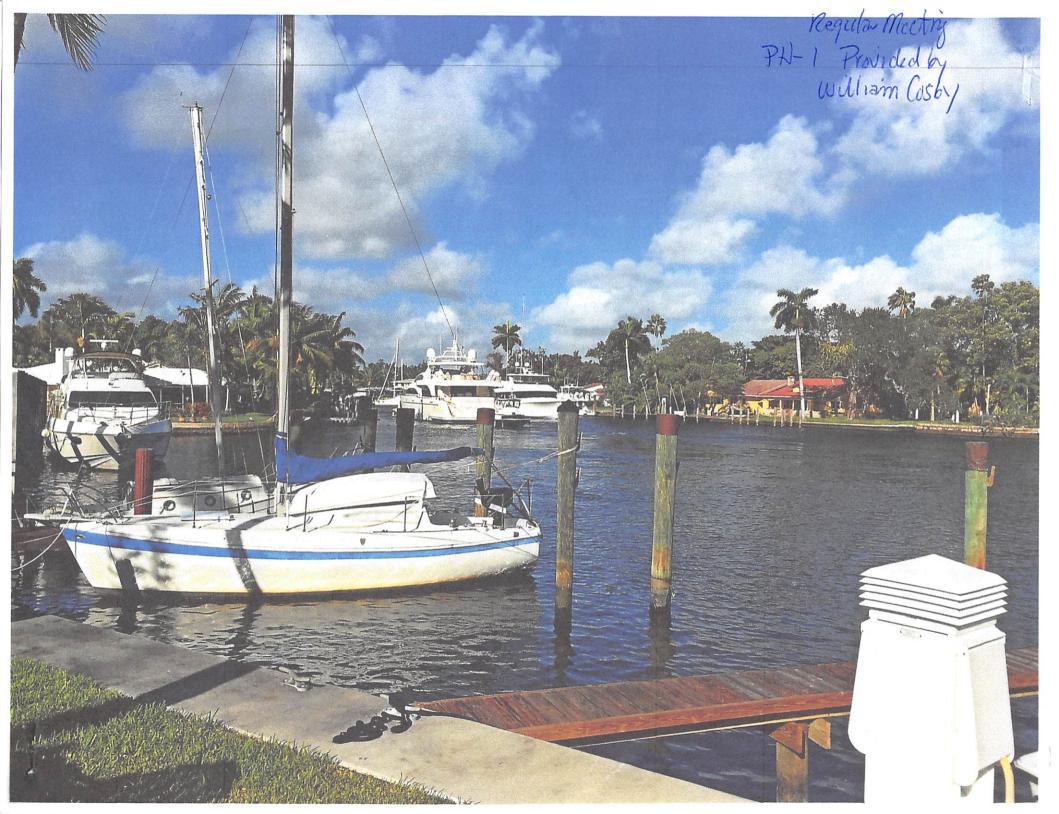

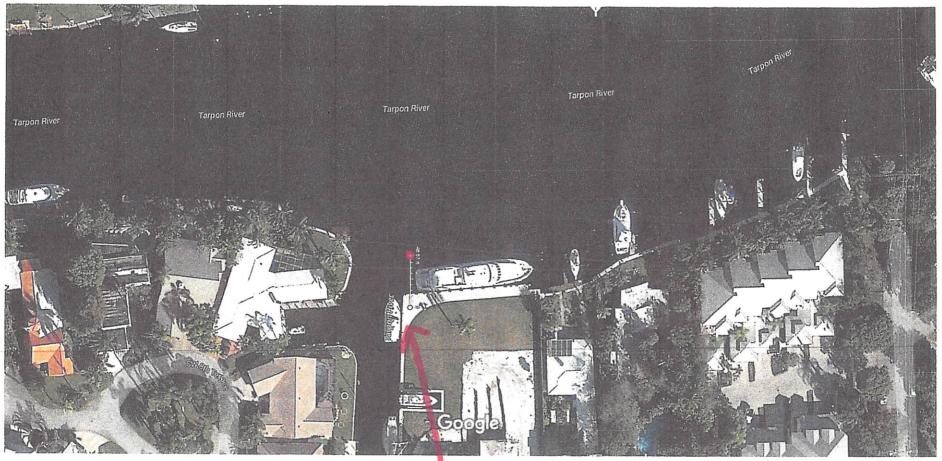

#### Recommendation

It is recommended that the City Commission adopt a resolution granting a Waiver of Limitations for the installation of two triple-pile mooring clusters for Edward J. & Betty G. Kirwin located at 811 SW 6<sup>th</sup> Street. Fort Lauderdale. FL.

#### Background

The applicant is seeking a resolution granting a Waiver of Limitations (a waiver to allow a dock, mooring structure, or boat lift to extend beyond the maximum distance as defined by City Code) of Section 47-19.3(D) of the Unified Land Development Regulations (ULDR) for the installation of two triple-pile clusters extending a maximum of 47.1' into the New River from the property line. Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$300.00 is required. The applicant's narrative specifies that the additional distance for these piles is necessary to allow for safer mooring of their vessel, simpler ingress and egress, and protection from damage during extreme weather.

The Marine Advisory Board recommended approval of the application 13 to 0 (see Exhibit 3).

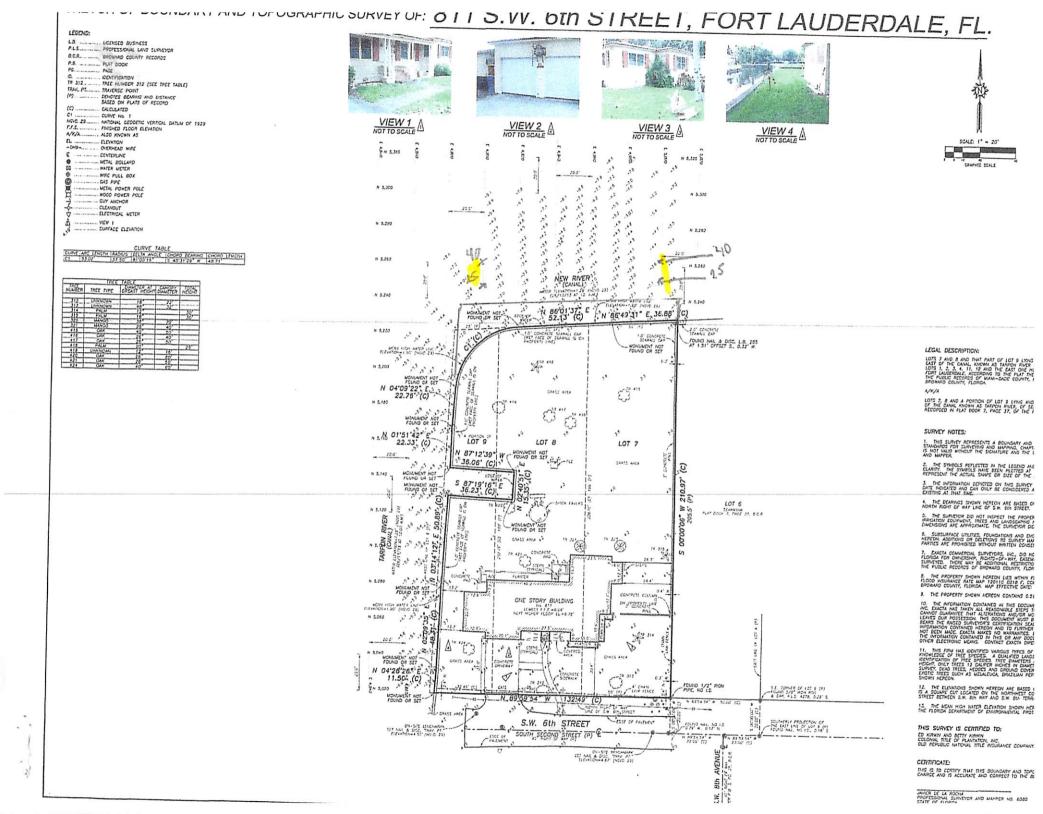

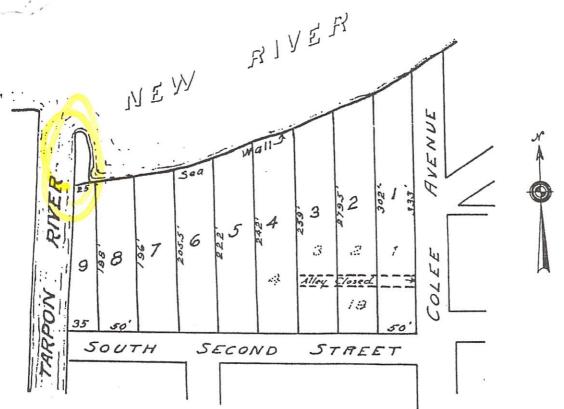

## Comments Regarding Marathon Petroleum Company's Proposal to Construct a New Petroleum Tank to Increase the Spangler Terminal Storage Capacity

This letter is being written to members of the City Commission regarding Marathon Petroleum Company's (Marathon's) proposal to construct a new petroleum tank to increase the Spangler Terminal storage capacity. As a resident of Harbordale I have grave concerns about this project and the impact it will have on our community.

Although the need for additional gasoline storage capacity within the Port may be real, the wisdom of abandoning millions of barrels of capacity elsewhere within the Port in favor of a new larger tank for Marathon in closer proximity to existing residential dwellings must be questioned.

This project would increase the risk to adjacent residential homes. Risk considers both the likelihood of an incident such as a fire or an explosion and the consequences of such an event. An additional larger tank placed in closer proximity to residential dwellings would increase both factors but especially the consequences of such an incident. One cannot help but wonder what the impact would be of an explosion of a tank of this size on nearby residents.

Having reviewed Marathon's application, it is clear that it is presented with a "business as usual" approach; one more tank in an existing tank farm. In this day and age of terrorist threats we can no longer consider an additional 8 million gallons of flammable liquid in closer proximity to residential dwellings to be "business as usual".

Section 47-15.20 C 3 of the City of Fort Lauderdale's Unified Land Development Regulations (ULDR) requires "that the proposal be designed in such a manner as to preserve, perpetuate and improve the character of the proposed site and surrounding area". Marathon's proposal makes no consideration of the surrounding area and therefore falls short of ULDR requirements.

I respectfully request that City Commission members, if they have not already done so, look at Google Earth's satellite imagery or other mapping to gain a better appreciation of the proximity of the project to existing residential buildings. Marathon's proposal does not provide distances to nearby residential buildings nor does it evaluate the impact of an explosion on residents.

I am also unaware if any alternatives analyses were performed to reach the conclusion that the current proposal is the best solution. Could the proposed tank be located elsewhere on Marathon's property to minimize impact? Could existing tanks, especially those that would soon need replacement, be substituted with larger tanks? Does property exist elsewhere in the port that could accommodate fuel storage, especially considering that the removal of a significant number of existing tanks within the port is, at least in part, driving the need for this project?

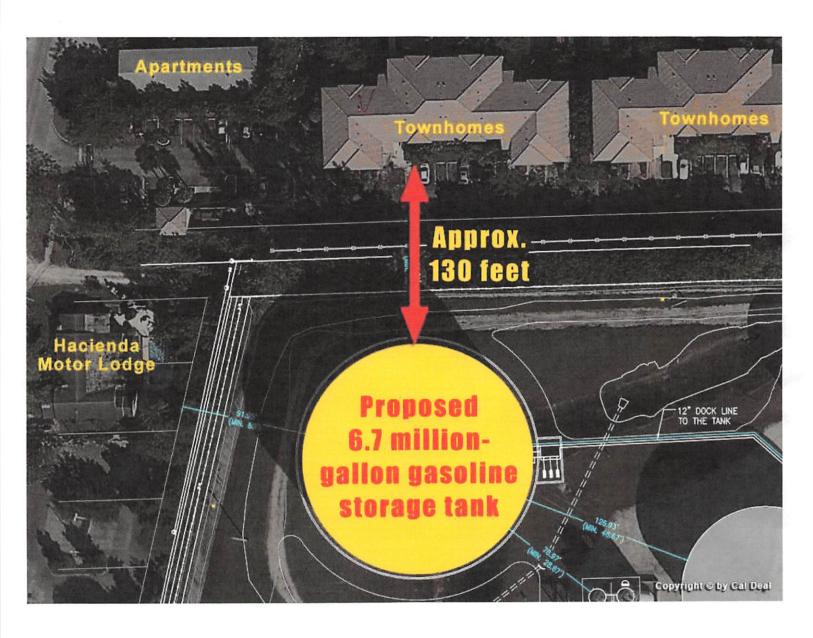
It is my understanding that this tank would be significantly taller and larger than existing adjacent tanks. Could the capacity of the tank be slightly decreased to keep its height more in line with adjacent tanks? The tank is described in the narrative as a 56-foot high tank but it is actually taller due to its domed roof. Could the tank be moved slightly back on the project site to increase the distance to residential buildings and decrease the potential for loss of life in the event of an explosion? What are the sight lines from the proposed tank to neighboring buildings?

Although representatives from Marathon met with the Harbordale Civic Association, the meeting came only at the request of impacted neighbors. At the meeting these and similar questions were posed to Marathon and to-date Marathon has not responded to the Association despite their assurances to do so.

It is my sincere hope that the City Commission will consider these matters in its evaluation of the project and, at the very least, take more time to better understand the risk to and safety of nearby residents and the impact of the project on the neighboring community.

## Comments Regarding Marathon Petroleum Company's Proposal to Construct a New Petroleum Tank to Increase the Spangler Terminal Storage Capacity

This letter is being written to members of the City Commission regarding Marathon Petroleum Company's (Marathon's) proposal to construct a new petroleum tank to increase the Spangler Terminal storage capacity. As a resident of Harbordale I have grave concerns about this project and the impact it will have on our community.

Although the need for additional gasoline storage capacity within the Port may be real, the wisdom of abandoning millions of barrels of capacity elsewhere within the Port in favor of a new larger tank for Marathon in closer proximity to existing residential dwellings must be questioned.

This project would increase the risk to adjacent residential homes. Risk considers both the likelihood of an incident such as a fire or an explosion and the consequences of such an event. An additional larger tank placed in closer proximity to residential dwellings would increase both factors but especially the consequences of such an incident. One cannot help but wonder what the impact would be of an explosion of a tank of this size on nearby residents.

Having reviewed Marathon's application, it is clear that it is presented with a "business as usual" approach; one more tank in an existing tank farm. In this day and age of terrorist threats we can no longer consider an additional 8 million gallons of flammable liquid in closer proximity to residential dwellings to be "business as usual".

Section 47-15.20 C 3 of the City of Fort Lauderdale's Unified Land Development Regulations (ULDR) requires "that the proposal be designed in such a manner as to preserve, perpetuate and improve the character of the proposed site and surrounding area". Marathon's proposal makes no consideration of the surrounding area and therefore falls short of ULDR requirements.

I respectfully request that City Commission members, if they have not already done so, look at Google Earth's satellite imagery or other mapping to gain a better appreciation of the proximity of the project to existing residential buildings. Marathon's proposal does not provide distances to nearby residential buildings nor does it evaluate the impact of an explosion on residents.

I am also unaware if any alternatives analyses were performed to reach the conclusion that the current proposal is the best solution. Could the proposed tank be located elsewhere on Marathon's property to minimize impact? Could existing tanks, especially those that would soon need replacement, be substituted with larger tanks? Does property exist elsewhere in the port that could accommodate fuel storage, especially considering that the removal of a significant number of existing tanks within the port is, at least in part, driving the need for this project?

It is my understanding that this tank would be significantly taller and larger than existing adjacent tanks. Could the capacity of the tank be slightly decreased to keep its height more in line with adjacent tanks? The tank is described in the narrative as a 56-foot high tank but it is actually taller due to its domed roof. Could the tank be moved slightly back on the project site to increase the distance to residential buildings and decrease the potential for loss of life in the event of an explosion? What are the sight lines from the proposed tank to neighboring buildings?
