> Mayor Trantalis recognized John Rodstrom III, Esq., on behalf of Bill Scherer. Mr. Rodstrom commented on the position of his client. He confirmed ongoing efforts with residents of this area of Cordova Road to

come up with a reasonable solution for all stakeholders, requesting a continued deferment.

In response to Vice Mayor McKinzie's question, Commissioner Sorensen explained the recommendation from Mr. Rodstrom and Mr. Scherer to change the Ordinance allowing a perpetual easement. Mr. Rodstrom confirmed. City Attorney Alain Boileau explained dock permits have always been revocable licenses. He gave a brief review of the meeting with Commissioner Sorensen, Mr. Rodstrom and Mr. Scherer. City Attorney Boileau said that Mr. Rodstrom and Mr. Scherer's proposal for an easement in perpetuity would give upland owners a property interest, noting it is a public right-of-way and expounding on details. He reconfirmed his legal opinion and recommendation that dock access continue through a dock permit that is a revocable license.

Commissioner Sorensen confirmed his understanding of City Attorney Boileau's position that a perpetual easement with conditions attached was not viable. City Attorney Boileau expounded on legal details regarding a perpetual easement. He said Property Appraiser representations for upland properties along this area of Cordova Road are unrelated to the City.

In response to Commissioner Sorensen's question, Mr. Rodstrom said the proposal for a perpetual easement was intended to be a conversation starter in an effort to reach a mutually agreed-upon position, confirming Mr. Scherer's desire to reach a middle ground as an alternative to what is currently proposed in the Second Reading of this Ordinance.

Mayor Trantalis discussed the position of the City, noting his perspective regarding this item and Staff's lengthy research.

Mr. Rodstrom confirmed the right-of-way dedicated to the City was approximately twenty-five (25) feet. Cordova Road and the adjacent swale are larger than twenty-five (25) feet. He commented on the position of his client questioning whether part of the swale and the dock area is City property. City Attorney Boileau confirmed review of this issue, noting the right-of-way abuts the public waterway and is City property.

Mayor Trantalis recognized Charles King, 105 N. Victoria Park Road. Mr. King commented on his perspective of this item and the position of Mr. Scherer.

In response to Commissioner Sorensen's question, City Attorney Boileau confirmed the Ordinance as written is in the best interests of the City.

> Vice Mayor McKinzie commented on his agreement with Mr. Rodstrom's request, explaining related details. Commissioner Sorensen concurred, noting the fairness in waiving the dock permit fee for current dock permit holders in this area of Cordova Road. Further comment and discussion

City Manager Lagerbloom commented that the Fiscal Year 2020 budget would not balance should these fees be waived, noting Staff would pursue waiving permit fees for this set of dock and permit holders should the Commission so desire.

In response to City Attorney Boileau's request for clarity, Commissioner Sorensen confirmed the waiving of dock permit fees would apply to current existing dock permit holders along Cordova Road for docks that have been removed or will be removed due to being part of the seawall improvements. The remainder of this Resolution remains the same for new applicants wishing to apply for dock permits along Cordova Road and new applicants for dock permits in other areas of the City having seawalls that do not need to be removed and raised.

In response to City Manager Lagerbloom's question, it was confirmed that the City is removing existing docks along this area of Cordova Road for the raising of the seawalls. Applicants are not being requested to remove those docks. The criteria for this finite group of upland property owners along Cordova Road (Property Owners) was noted. If these Property Owners have an existing dock and they apply for a dock permit to reinstall a dock on the new raised seawall, the dock permit fee would be waived. It is a one-time waiving of the dock permit fee for the Property Owners.

Mayor Trantalis recognized Charles King, 105 N. Victoria Park Road. In response to Mr. King's question regarding the history of dock permit fees, City Attorney Boileau confirmed it is being raised from \$300 to \$1,500. Mr. King commented on his perspective.

Vice Mayor McKinzie introduced this Resolution as amended which was read by title only.
