#### CALL TO ORDER

Chair Trantalis called the meeting to order at 4:26 p.m.

#### RESOLUTIONS

**R-1** <u>19-0408</u> Resolution Authorizing the Disposition of Property at 713, 717 and 723 NW 3 Street to Avenue D'Arts FLL, LLC and Approving an Award of \$3,000,000 from the CRA Development Incentive Program to Avenue D'Arts FLL, LLC - (Commission District 3)

Chair Trantalis recognized Clarence Woods, Area Manager Northwest-Progresso-Flagler-Heights (NWPFH) Community Redevelopment Agency (CRA). Mr. Woods explained details noted in Memo 19-0408. These lots were needed for additional parking. When put out to bid, Avenue D'Arts FLL, LLC was the only respondent and will be paying for the land.

The \$3,000,000 incentive from the CRA Development Incentive Program would be distributed in four allocations disbursed over three separate years. Approximately 27 jobs are anticipated to be created with twenty percent (20%) going to residents within the NWPFH CRA.

In response to Commissioner Sorensen's question, it was confirmed the estimated total cost of the project is approximately \$17,000,000 - \$18,000,000. Further comment ensued on aspects of design. Mr. Woods commented on the ability to move forward, capitalizing on areas along Avenue of the Arts. Vice Chair McKinzie commented on the effort involved with this project, the lengthy process, community input, the development agreement with Comfort Suites and the move forward.

Chair Trantalis recognized Ray Cox, 101 SW 18th Avenue. Mr. Cox commented on his perspective regarding this item.

Vice Chair McKinzie introduced this Resolution which was read by title only.

M-1 <u>19-0477</u> Motion Approving Funding for Task Order No. 4 for Materials Testing and Inspection Services for the Fort Lauderdale Aquatic Center Renovation Project - Wood Environment & Infrastructure Solutions, Inc. - \$268,140 - (Commission District 2)

> Chair Trantalis recognized Thomas Green, Senior Community Redevelopment Agency (CRA) Project Manager. Mr. Green explained details regarding this item. It funds materials testing and inspection services from Wood Environment & Infrastructure Solutions, Inc., for the Fort Lauderdale Aquatic Center Renovation Project (Project). The goal is to ensure construction is in compliance with the construction documents.

In response to Chair Trantalis's questions regarding the construction timeline, Mr. Green explained fencing has been installed. However, the demolition has not started. Demolition is expected to begin in June 2019 in addition to a test pilot program for materials testing. Production pile construction is anticipated in July - August 2019.

Chair Trantalis recognized Ray Cox, 101 SW 18th Avenue. Mr. Cox commented on his perspective regarding this item.

Commissioner Sorensen made a motion to approve this item and was seconded by Commissioner Glassman.
