- TITLE: Motion Approving Agreement for Fiveash Water Treatment Plant Valve Replacement – Lanzo Companies, Inc.- in the Lump Sum Amount of \$864,992 - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends that the City Commission approve an agreement, in substantially the form attached with Lanzo Companies, Inc., for Fiveash Water Treatment Plant Valve Replacement Project in the lump sum amount of \$864,992.

Background

This project's scope includes removal and replacement of an existing 30-inch water main valve, which is currently leaking, located on one of the water transmission main lines at the Fiveash Water Treatment Plant on Powerline Road.

In addition to replacing the leaking valve, work consists of installing two (2) 30-inch, one (1) 36-inch, and one (1) 42-inch side-mounted butterfly valves on the water transmission main lines. In order to complete the work, the water main system will have to be isolated and monitored to ensure that the water pressure flow stays at normal operating conditions throughout the construction. As such, the work will be completed in phases and Plant staff will be monitoring the water flow throughout the construction.

The work is to be performed in the following three phases:

- Phase 1 install a line stop on NW 42nd Street and install a new 30-inch sidemounted butterfly valve.
- Phase 2 install a line stop on the 42-inch water main and install a new 42-inch and 30-inch butterfly valve.
- Phase 3 install a line stop on Powerline Road and install a new 36-inch sidemounted butterfly valve and replace the leaking 30-inch valve.

On November 8, 2021, the Procurement Services Division issued Invitation to Bid No. 12609-423. The City received two (2) bids in response to the solicitation which were opened 01/05/2022 Page 1 of 3 CAM #21-1187

on December 10, 2021. The bids submitted by Lanzo Companies, Inc., and David Mancini & Sons, Inc. have been deemed responsive and responsible bids. Both bidders did not identify as a Disadvantaged Business Enterprise. The bid submitted by Lanzo Companies, Inc. has met all the specifications of the solicitation, and has been deemed the lowest cost, responsive, and responsible bidder.
