If awarded, these grant funds will be used to support construction costs associated with the installation of an additional concrete 130' x 10' floating dock at Esplanade Park/ Maritime Museum Floating Dock. It will be constructed as a floating viewing dock with temporary railings until such time when four (4) Broward County Marine Facilities Operating Licenses (MFOL) can be obtained by the City. Once obtained, the dock will be open for vessel day docking.
