Phase I Design and Permitting has been completed. If awarded, these grant funds will be used to support construction costs associated with the installation of an additional concrete 130' x 10' floating dock at Esplanade Park/ Maritime Museum Floating Dock. It will be constructed as a floating viewing dock with temporary railings until such time when four (4) Broward County Marine Facilities Operating Licenses (MFOL) can be obtained by the City. Once obtained, the dock will be open for vessel day docking.

Grants Administration Comments:

- The Department is requesting the use of \$280K in General Fund Grant Match
 - \$230K in required grant match for the construction of the project
 - \$60K in project managements fees that are not eligible for reimbursement on the grant
- The FIND Phase I grant will not provide reimbursement for the \$37K expended on design until the project is permitted. (P12369.129)
- The project must be completed in three (3) years - 2 year grant with optional 1 year extension
- There are currently no Broward County Marine Facilities Operating Licenses available so the dock will initially be constructed as a floating viewing dock and will later transition for vessel day docking
