Participation Agreement with Northwest Federated Womans Club of Broward County, Inc., - \$78,309 - (Commission Districts 1, 2, 3 and 4)

#### Recommendation

Staff recommends the City Commission adopt a resolution approving a City of Fort Lauderdale FY 2022 Not for Profit Grant Participation Agreement with Northwest Federated Womans Club, Inc., a not-for-profit corporation, in the amount of \$78,309, and authorizing execution of the agreement.

### **Background**

With the adoption of the FY 2022 Budget, the City Commission approved contributions to not-for-profit organizations that support the needs of the community while making a positive impact. The benefiting not-for-profit organization is required to execute a participation agreement that provides for amount, terms of contribution, scope of services, and standards of performance.

The mission of Northwest Federated Womans Club of Broward County, Inc., is to significantly improve the mental health and well-being of all members of the community through education, recreation, support, and advocacy. The funding will be used to provide medication therapy management for seniors by a pharmacist and supporting staff to create a bridge between patients, physicians, and pharmacist to limit and prevent adverse prescription drug reactions. Seniors and caregivers will also be provided with support services and resources such as disease management seminars to improve adherence to medication regimens, preventative care, and CPR certification.

# Resource Impact

There is a fiscal impact to the General Fund in the amount of \$78,309 in FY 2022. Funding is budgeted and available in the account listed on the following page.
