**TITLE**: Motion Approving an Event Agreement, Related Road Closures and

Requests for Music Exemptions for Nobe Sunday Block Party on January 23, 2022 and January 30, 2022 and Retroactive Approvals for the January 9, 2022 and January 16, 2022 Event Dates – (**Commission District 1**)

### **Recommendation**

Staff recommends the City Commission approve an event agreement, related road closures and requests for extended hours for music with Fishtales Bar & Grill, Inc., in substantially the form attached, on January 23, 2022 and January 30, 2022 Retroactive Approvals for the January 9, 2022 and January 16, 2022 Event Dates, and authorize execution of the agreement by the City Manager.

### **Background**

At the January 5, 2022 Commission meeting, the City Commission approved an event agreement with Fishtales Bar & Grill, Inc. for events between February 2022 through April 2022. Due to an oversight, January dates were mistakenly left off the approval. Approval of the event agreement will allow the event promoter to continue her event through the end of January and retroactively approve the January 9, 2022 and January 16, 2022 dates.

City staff has been working closely with the event organizer regarding event topics, such as logistics, maintenance, and security as detailed below. The Police Department recommends approval of the closing of the City streets where appropriate, and event parking has been satisfactorily arranged. When applicable, amplified music was discussed, and the event organizer was advised of the noise ordinance and possible concerns.

The organizer will pay for all event costs and submit the required certificates of insurance. The event organizer will also secure all other necessary permits and licenses that are required from other agencies. Civic and merchant associations have been notified, as appropriate, regarding events in their areas. Specific event details are included in each event application as attached.

Where applicable, the City Commission authorizes amplified music for the events listed below.

Authorization for the execution of the event agreements is contingent upon the City Attorney's Office receiving and approving a validly executed agreement.
