TITLE:	Public Hearing - Resolution Granting a Waiver of Limitations at 721 Cordova Road for the Installation of an L-shaped Fixed Dock, Floating dock, and Boat Lift - (Commission District 4)

Recommendation

Staff recommends the City Commission adopt a Resolution granting a Waiver of Limitations for the installation of an L-shaped fixed dock, floating dock, and boat lift at 721 Cordova Road.

Background

The applicant is seeking a resolution granting a Waiver of Limitations (a waiver to allow mooring structures to extend beyond the maximum distance as defined by City Code) of Section 47-19.3 (C) of the Unified Land Development Regulations (ULDR) for the installation of an L-shaped fixed dock, floating dock, and boat lift extending a maximum distance of +/- 30 feet from the property line into the adjacent Lake Juanita.

The applicant's Project Description specifies that the proposed structures are necessary for safely mooring resident's vessels, especially during extreme weather. In addition, the extra 5' of water depth will allow for vessel storage protecting both the motors and aquatic resources. The issuance of this Dock Waiver is contingent upon approval of a separate Dock Permit for Private Usage of Public Property via City Code 8-144.

Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$1500.00 is required.

The Marine Advisory Board recommended unanimous approval of the application 10 to 0 (see Exhibit 3) at the December 2, 2021 meeting.

Resource Impact

There is a positive fiscal impact in the amount of \$1,500. Revenue related to the application fee is included in the FY2022 Operating Budget in the account listed below.
