A RESOLUTION OF THE CITY COMMISSION OF THE CITY FORT LAUDERDALE, FLORIDA, DENYING APPLICATION BY EDWARD J. BOHNE, III AND ELIZABETH ELLEN BOHNE, FOR A DOCK PERMIT FOR THE INSTALLATION OF 1) A SET OF STAIRS TO PROVIDE ACCESS OVER SEAWALL CAP, (2) AN L-SHAPED FIXED WOOD DOCK OF +/- 276 SQUARE FEET, (3) A 4' X 16' ALUMINUM GANGWAY, (4) A 20' X 5' FLOATING DOCK AND (5) A 30,000 POUND CRADLE BOAT LIFT EXTENDING A MAXIMUM OF +/-30' FROM THE WET FACE OF THE SEAWALL ON PUBLIC PROPERTY ABUTTING THE WATERWAY ADJACENT TO 721 CORDOVA ROAD, PURSUANT TO SECTIONS 47-19(e) OF THE CITY OF FORT LAUDERDALE UNIFIED LAND **DEVELOPMENT** REGULATIONS ("ULDR"), FOR PROPERTY LOCATED AT 721 CORDOVA ROAD, FORT LAUDERDALE, FLORIDA 33316.

WHEREAS, Section 8-144 of the Code of Ordinances of the City of Fort Lauderdale, Florida provides that the City Commission may grant a dock permit; and

WHEREAS, EDWARD J. BOHNE, III AND ELIZABETH ELLEN BOHNE, husband and wife, (hereinafter "Applicant") owns the Property located at 721 Cordova Road, Fort Lauderdale, Florida, 33316, Property ID# 5042 1118 3660 (hereinafter "Property"); and

WHEREAS, Applicant applied for a permit to install, use, maintain, and repair (1) a set of stairs to provide access over seawall cap, (2) an L-shaped fixed wood dock of +/- 276 square feet, (3) a 4' x 16' aluminum gangway, (4) a 20' X 5' floating dock, and (5) a 30,000-pound cradle boat lift extending a maximum of +/- 30' from the wet face of the seawall on public property abutting the waterway adjacent to 721 Cordova Road (hereinafter "Application"); and

WHEREAS, at the January 18, 2022, Regular Meeting of the City Commission of the City of Fort Lauderdale, by a unanimous vote of the City Commission, the Commission denied the Application.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:
