**TITLE:** Resolution Authorizing the City Manager to Submit a Grant Application for \$5,232 to the Florida Inland Navigation District – Small Scale Derelict Vessel Removal Program to Remove a Derelict Vessel from the New River – **(Commission District 2)**

**Recommendation**

Staff Recommends the City Commission adopt a Resolution authorizing the City Manager to submit an application for grant funding of \$5,232 to the Florida Inland Navigation District – Small Scale Derelict Vessel Removal program. This Grant requires a City match of \$1,743.

**Background**

The Florida Inland Navigation District (FIND) administers the Waterway Assistance Program (WAP) program. FIND provides funding assistance to local governments within the District to provide public access to area waterways through boat ramps, floating docks and derelict vessel removal.

A 30' vessel sank in Intracoastal Waterway and the City of Fort Lauderdale Police Marine Unit deemed the vessel abandon and authorized the City to remove the vessel on January 14, 2022. On January 18, 2022 Grady Marine Services removed the derelict vessel for the City at a cost of \$6,975.

The Florida Inland Navigation District Small Scale Derelict Vessel Removal Program will fund up to 75%, or in this case \$5,232 of the costs needed to salvage and properly dispose of this derelict vessel. The remaining costs of \$1,743 to remove the vessel will be funded by a Broward County Boating Improvement Derelict Vessel Removal Grant which was awarded to the City in 2019.

**Resource Impact**

There is no fiscal impact associated with the grant application. The Grant will be brought back to the City Commission for execution and appropriation if awarded.
