TITLE:	Motion Approving Purchase of an Asphalt Patcher – Environmental Products Group, Inc \$193,131 - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve the purchase of an asphalt patcher from Environmental Products Group, Inc. (EPG), in the amount of \$193,131.

Background

Public Works requested the purchase of a second asphalt pothole patching truck which will provide redundancy for times when one truck requires maintenance and improve the current operational level of service. The sale of other roadway equipment assets in the summer of 2021 made additional funds available for this purchase.

On December 27, 2021, the Procurement Services Division issued Invitation to Bid No. 12629-822 – Asphalt Patcher. On January 12, 2022, the solicitation ended with a total of four (4) bids submitted from two (2) different firms, Jet-Vac Equipment Company, Inc. (JVEC), and EPG. Neither firm indicated its status as a Disadvantaged Business Enterprise (DBE).

The solicitation specified the request for a 6-yard truck. Neither of the two firms that bid currently make a 6-yard truck. Both bidders offered a 4-yard truck as an alternate bid that they correctly assumed would be in the City's best interest. JVEC submitted the lowest bid, however, they were deemed non-responsible as the chassis they specified in their bid did not meet minimum specification requirements. EPG submitted the second lowest bid, met requirements, and is deemed the lowest price, responsive, and responsible bidder. Staff recommends Commission award the purchase to EPG.

Resource Impact

There will be a fiscal impact to the City in the amount of \$193,131 for this purchase. Funds for this purchase, in the amount of \$193,131 are available in the FY 2022 Operating Budget in the account listed below.
