- TITLE: Motion Approving Agreement for Fiveash Water Treatment Plant Filters Rehabilitation Project - Phase 2 - RF Environmental Services, Inc. -\$3,354,380 - (Commission Districts 1, 2, 3 and 4)

### **Recommendation**

Staff recommends the City Commission approve an agreement, in substantially the form attached, with RF Environmental Services, Inc. for Fiveash Water Treatment Plant Filters Rehabilitation Project - Phase 2, in the amount of \$3,354,380.

#### **Background**

Phase 2 of this project is for the removal of existing media and installation of new media in 14 filters at the Fiveash Water Treatment Plant. Phase 1 of this project rehabilitated eight (8) media filters. The filters remove contaminants and other impurities from the raw water providing clean and healthy potable water to the community.

On October 20, 2021, the Procurement Services Division issued Invitation to Bid No. 12589-423. The City received four (4) bids in response to the solicitation, which were opened on November 22, 2021. Of the bidders, SCR Mechanical, LLC identified as a Disadvantaged Business Enterprise (DBE). All bids were reviewed for compliance with the solicitation specifications. The bid submitted by RF Environmental Services, Inc. has met all the specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bid.

### Resource Impact

There will be a fiscal impact to the City in the amount of \$3,354,380 for the contract award, including the allowances, and \$170,000 for construction engineering inspection service fees and estimated in-house project management fees for a total of \$3,524,380. Pre-encumbrance is included on requisition RQ2200564 in the amount of \$2,900,000. The remaining balance of \$681,722 is available in the FY2022 Community Investment Plan in the account listed below.
