WHEREAS, City and Lessee entered into that certain Lease Agreement dated May 18, 2021, (CAM Number 21-6479, as supplemented, amended or modified from time to time, collectively, the "Lease"), pertaining to the Leased Premises, as such premises are further described in the Lease, and

WHEREAS, City and Lessee desire to enter into this 20d Amendment for the purpose of amending the Lease, subject to the terms and conditions set forth herein.

Agreement

NOW, THEREFORE, in consideration for the covenants and conditions of this Amendment and for other good and valuable consideration, the receipt and sufficiency of which are hereby conclusively acknowledged, City and Lessee agree as follows:

- 1. Recitals. The above recitals are true and correct and are incorporated herein as a material part hereof.
- 2. <u>Defined Terms</u>. All undefined capitalized terms used herein shall have the same meanings as defined in the Lease.
- 3. Rental Payments. The Lease is hereby amended to defer the monthly rental payments for 90 days for the period beginning February 2021 through April 2021 (the "Deferral Period"), without extending the Term of the Lease Agreement. Upon the expiration of the Deferral Period, LESSEE shall resume making monthly rent payments as required in the Lease and the deferred rental payments being paid as an additional charge to the monthly base rental payment. The base rental and deferred rental payments shall be made by the Lessee over a six (6) month period beginning May 2021 through October 2021.
- 4. Ratification of Lease; Counterparts. All other provisions of the Lease shall remain unchanged and in full force and effect. City and Lessee do hereby ratify and confirm the Lease, as modified herein. This Amendment may be signed in counterparts, each of which shall be deemed an original, all of which together shall constitute one complete agreement.
- 5. Conflict. If any of the provisions of this 2nd Amendment conflict with the Lease, then this 2nd Amendment shall control.
- 6. Effectiveness. This 2nd Amendment shall not be effective until it is executed by, and delivered to, both City and Lessee.

7. Authority. City and Lessee each warrant to the other that the person or persons executing this Amendment on its behalf has or have authority to do so and that such execution has fully obligated and bound such party to all terms and provisions of this Amendment.
