TITLE:	Resolution Approving Retroactive Revisions to the Foreign Trade Zone No. 241 Zone Schedule, Fees and Other Changes – (Commission District 1)

Recommendation

Staff recommends the City Commission adopt a resolution authorizing retroactive revisions to the Foreign Trade Zone No. 241 (FTZ-241) Zone Schedule fees and other changes, as of March 28, 2014, and authorize the City Manager to approve and execute future revisions of the FTZ-241 Zone Schedules.

Background

The City of Fort Lauderdale established FTZ-241 on April 19, 2000, under a Grant of Authority from the Foreign-Trade Zones Board (US Secretary of Commerce and US Secretary of Treasury). Since inception, the goal of the program is to promote development of the Executive Airport Industrial Airpark, serve businesses engaged in international commerce in the greater Fort Lauderdale area, and maximize the City's business retention and attraction efforts. The Zone Schedule sets forth the operational structure of FTZ-241 and the regulations and fees associated with active zone operations.

On March 28, 2014, Lee R. Feldman, former City Manager, submitted to the City Commission an informational memorandum 14-053 indicating revised fees to the FTZ-241 Zone Schedule (Exhibit 1). This memorandum was informational only and should have gone to the City Commission for approval, but never did. The FTZ-241 program has been operating with the revised fees stated in the informational memorandum since 2014.

On April 15, 2014, a resolution authorizing the City Manager to approve and execute FTZ-241 Operator Agreements as the Grantee of FTZ-241 was approved by the City Commission (Exhibit 2). The described authorization did not include a provision for the City Manager to approve and execute the FTZ-241 Zone Schedule, which comprises the fees.

Upon review of the FTZ-241 program, staff recommends the following revisions to the FTZ-241 Zone Schedule (Exhibit 3):

• Authorize the fees according to Exhibit 1.

- Section I. Foreign Trade Zone No. 241 Administration Directory.
- Omit the Site Descriptions.
- Update Section numbers and various changes throughout the document, as recommended by the FTZ Board.

Staff recommends approving the revised FTZ-241 zone schedule retroactively as of March 28, 2014; authorize the City Manager to approve and execute future FTZ-241 Zone Schedules, and revisions.

Resource Impact

There is no fiscal impact associated with this action.
